

Staff reviewed the 2010 Track and Simulcast applications for American Racing-Vernon Downs, Inc (Vernon Downs). Staff has found the track and simulcast applications substantially complete.

The application for racing in 2010 requests approval to conduct no fewer than ninety (90) separate racing programs. The minimum number of race days to be requested for Vernon Downs is 144, in accordance with Section 318 of the New York State Racing, Pari-Mutuel Wagering and Breeding Law. The management of Vernon Downs stated it would be economically infeasible to race the 144 days.

The horsemen's contract calls for no fewer than ninety (90) racing days to commence no later than May 1st and close no sooner than November 21st with a minimum three (3) day per week schedule." The horsemen are in concurrence with the ninety (90) days citing a possible reduction in horses available to race.

Section 307.5-a of the Racing, Pari-Mutuel Wagering and Breeding Law provides that the Board shall not issue a license for Vernon Downs if it does not conduct at least 120 racing programs. The statute further provides that the Board may grant the license to conduct fewer programs and races for good cause shown due to factors beyond the control of the racing corporation, and upon consent of the representative horsemen's association.

Staff recommends that the Board make such finding for purposes of Section 307.5-a and also find for purpose of establishing the Section 318 pari-mutuel tax rate that the assignment of the 90 racing programs was due to factors beyond the control of the racing corporation or that it would have been uneconomical or impractical for the corporation to be assigned the prescribed number.

The Harness Horse Association of Central New York also provided American Racing-Vernon Downs, Inc. with permission to distribute purse checks no later than ten (10) days, after races have been run.

No material issues were found with the CAFO documentation submitted with this application.

The required SAS 70 Type II audit report for American Racing-Vernon Downs has been filed with the Board; however, the report as received does not meet this year's requirements. Staff will issue a separate memo for Board information when additional information is received and pursue this matter separately.

Pursuant to Section 5100.23(d), the Board must annually approve the Vernon Downs Totalisator Security Plan. Staff has reviewed the plan and found it to be substantially in compliance with the rule.

Staff notes no substantial changes in the simulcast plan of operation presented as compared with the 2009 application and plan. The application is sufficient for purposes of issuing a 2010 simulcast license application.

It is recommended that the Board:

- Grant the 2010 track and simulcast licenses subject to standard conditions
- Grant the requested waiver from the purse distribution requirements
- Approve the totalisator security plan

Authorize certification to the Commissioner of Taxation and Finance pursuant to Section 318.5 consistent with finding that assignment of the 90 racing programs was due to factors beyond the control of the racing corporation or that it would have been uneconomical or impractical for the corporation to be assigned the prescribed number.

By request letter dated January 11th, 2010, Michael D. Kane, the Vice President of Operations and Live Racing for the Western Off-Track Betting Corporation has submitted a request to amend the plan of operation for the opening of the Western Regional Off-Track Betting EZ Bet named The Dr.'s Inn located at 1743 East Avenue. This branch is located in the City of Rochester which is in the County of Monroe.

The Dr's Inn, Inc. was incorporated on February 23, 2000. In 2008, David Hartman bought out the other shareholder and now owns the two outstanding shares as the sole owner of this corporation.

Staff reviewed the Personal History Disclosure, a Financial Disclosure Form (FD-1), tax returns, credit history, business records and various background checks including fingerprint-based criminal history reports.. A background check with the New York State Division of Lottery did not disclose any past or current violations.

Staff also examined the tax returns for David Hartman and for The Dr's Inn, Inc. for the years 2006, 2007 and 2008. Staff also reviewed payroll records against the Board's licensing database.

The Dr's Inn is a current New York State Liquor Authority licensee. A check with the State Liquor Authority disclosed violations in 2006 and 2009. (Subdivision one section 117-a of the Alcoholic Beverage

Control Law with the sale of an unlimited amount of drinks during a set period of time for a fixed price and the 2009 violation of Section

109(2) of the Alcoholic Beverage Control Law with the failure of the licensee to send notification of the renewal thirty days before the application was filed. Both resulted in fines.

Western Regional Off-Track Betting will provide the data network and telephone lines needed to operate the betting and simulcast system. Training and support will be provided by Western Regional OTB as well. The Dr.'s Inn, Inc. will provide sufficient personnel to operate Western's Regional OTB's betting and simulcasting system during the hours of 12:00 p.m. to 11:00 p.m.

The Dr.'s Inn, Inc. agrees to maintain an on-site minimum daily balance of fifteen hundred (\$1,500.00) dollars to satisfy vouchers which may be presented for payment by customers who utilize the Western Regional OTB betting system.

Approval is recommended.

Section 318 (1) Except as otherwise provided by law, every association or corporation authorized under this article to conduct pari-mutuel betting at a harness horse race meeting on races run thereat shall distribute all sums deposited in any pari-mutuel pool to the holders of winning tickets therein, provided such tickets be presented for payment prior to April first of the year following the year of their purchase, less an amount which shall be established and retained by such racing association or corporation of between fourteen and twenty per centum of the total deposits in pools resulting from regular bets, less sixteen to twenty-two per centum of the total deposits in pools resulting from multiple bets, less twenty to thirty per centum of the total deposits in pools resulting from exotic bets, and less twenty to thirty-six per centum of the total betting deposits in pools resulting from super exotic bets, plus the breaks. The retention rate to be established is subject to the prior approval of the racing and wagering board. Such rate may not be changed more than once per calendar quarter to be effective on the first day of the calendar quarter.

On October 23, 2008, the Board approved and indorsed the proposed Certificate of Incorporation of Concord Empire Raceway Corp., thus permitting its filing with the New York State Department of State as a harness racing corporation.

By letter dated January 22, 2010, Concord Empire Raceway Corp. requests approval to amend its certificate of incorporation to change the entity's name to Concord Raceway Corp. This amendment is stated to result from the fact that the Concord project is no longer a joint venture with Empire Resorts, Inc. As reflected in the attached organizational chart (submitted January 25, 2010), the ownership of the racing corporation has changed since the October 2008 Board Action. The current application includes the originals of the executed certificate of amendment, written consents to the proposed amendment, the relevant assignment and assumption agreement relating to stock held by Charles A. Degliomini, Cliff Ehrlich, and David P. Hanlon, and a certificate of amendment relating to a name change of Concord Empire LLC to Concord Kiamesha Raceway LLC.

A corporation that desires to conduct race meets at which pari-mutuel harness racing is to be conducted pursuant to Racing Law Sections 305 and 307 must be formed under Section 302 of the Racing Law. Neither the original certificate of incorporation nor an amendment can be filed with the Secretary of State without the Board's endorsement.

This amendment is a name change only. Staff has not reviewed the ownership changes associated with the reported organizational chart. However, an approval of the amendment does not confer a license to conduct pari-mutuel harness horse racing. The original (October 23, 2008) approval conferred the Racing Law Section 304 right to hold harness race meetings subject to compliance with all of the Racing Law Article III provisions and the opportunity to apply for a Racing Law Section 307 track pari-mutuel harness racing license.

It is recommended that the certificate of amendment Concord Empire Raceway Corp. for the name change be approved. It is further recommended that approval be accompanied by a statement that this approval and endorsement does not reflect approval of the suitability of ownership interests, financing or other materials required in relation to licensing and operation of a pari-mutuel racetrack.



Staff recommends that the Board approve a 30-day extension for filing each of the 2010 four quarterly reports which will make them due 45 days after the end of each quarter.

The Board has previously approved virtually the same MMOA system for use at Catskill OTB, New York City OTB and Capital OTB. Customers will be able to utilize one website provided by MMOA to fund accounts at all four OTBs. However, all transactions are separate and a customer must have a separate account at each OTB in order to fund an account.

In general, MMOA will provide "Check EFT" service by which a Suffolk OTB customer requests that MMOA electronically debit the customer's checking account for funds to be provided by MMOA to Suffolk OTB for credit to the customer's Suffolk OTB telephone betting account. Before using the service the customer must establish a CheckEFT account. MMOA charges a fee for this service and Suffolk OTB receives a commission on the transactions. Deposits are limited to \$500 per day.

Staff performed a cursory background check of MMOA consisting of a public records search and found no information that would preclude Board approval.

Staff recommends the Board approve the change in Suffolk OTB's plan of operation to reflect the inclusion of the contract.



By letter dated December 1, 2009 Suffolk Regional Off-Track Betting Corporation (Suffolk OTB) requested New York State Racing and Wagering Board (Board) approval to amend its plan of operation to implement internet account wagering. By letter dated February 1, 2010 Suffolk OTB also requested approval of the internet wagering contract with Scientific Games.

Pursuant to 9(E) NYCRR §5300.3 authorized pari-mutuel entities may conduct account wagering pursuant to a written plan of operation approved by the Board. The plan must include, at a minimum: the system of processing wagers, internal controls, system security, rules and recording device apart from the tote.

System of Processing Wagers

Suffolk OTB has contracted with Scientific Games Racing LLC to provide its internet wagering platform known as TrackPlay. (TrackPlay has been previously approved by the Board for use at Nassau OTB) The TrackPlay system is a web-based internet system that allows customers to place wagers using their Suffolk OTB Accounts. Customers can bet on any event offered at Suffolk OTB as long as the host track has granted permission for internet wagers. Suffolk OTB included several screen shots of the customer interface. Staff notes that Suffolk OTB does not intend to offer video streaming at this time and it is not included in this request.

Internal Controls

Staff has reviewed Suffolk OTB's internal controls and found them to be substantially compliant with Part 5300 (Account Wagering) of the Rules. This includes compliance with §5300.8 Segregation of Funds, §5300.9 Conduct of Wagering, §5300.11 Withdrawals, §5300.12

Credits and §5300.21 Yearly Audit. Suffolk will offer surcharge free wagering on those accounts that have at least \$300 balance at the start of the session. Staff notes that Suffolk OTB has an anti-money laundering and suspicious activity policy.

System Security

The application servers are located in a secure 24/7 monitored facility. All physical access is logged. Access to the network is available only through a VPN via keystroke gateway. Network access is logged, controlled an audited. Player data is encrypted and backed up.

Rules

Staff has reviewed Suffolk OTB's account wagering and internet rules and found them to be substantially compliant with Part 5300 of the Rules. According to the Suffolk OTB's rules customers must be a resident of and located in New York State.

Recording Device

Scientific Games Racing utilizes a Transaction Processing Agent Service (TPAS) to record and log all internet account wagering transactions. Staff has previously reviewed this system and found it compliant with the Rules.

Other

Scientific Games is currently testing the Suffolk OTB wagering system. Staff recommends the Board approve Suffolk OTB's request for internet wagering conditioned on receipt of satisfactory test results from Suffolk OTB and/or Scientific Games.

For those authorized organizations who wish to continue mailing the form through the mail, the forms will still be available on our website for download.

Filing electronically will allow the Board to enhance automatic data collection and improve accuracy for form submittals. Additionally, this system will save time, resources and postage, and will also utilize less paper.

Authorized organizations that choose to submit the required GC-7Q forms electronically, will be able to register on our website, create an online ID and password, and enter all the information already required on the paper forms, electronically. Additionally, the organizations will be required to register an e-mail address so that they may be contacted electronically if a mistake or omission is made on the form, or if they are remiss in submitting the 5% license fee, thus saving the Board paper and postage.

Upon submission, electronic filers will receive an e-mail acknowledgement of their submission, as well as instructions on how to print and sign the affirmation page and submit the 5% fee to the Board.

6. 2009 SAS 70 TYPE II AUDIT REPORTS OF TOTALISATOR SYSTEM BACKGROUND

Part 5100.6(c) of the totalisator standards that were adopted by the Board in 2008 and became effective January 1, 2009 states "The totalisator company shall submit yearly a Type II, SAS 70 report, or other report approved by the board, that demonstrates the totalisator company's compliance with the tote standards." As a condition of licensing the Board required each New York track and OTB to submit such report no later than October 31, 2009.

With several new requirements put in place for 2009 Board staff sent a letter to each totalisator company on July 31, 2009 notifying them of the SAS 70 audit requirements that are now needed. A detailed list of required control objectives to be tested as well as required control description and procedures was provided at this time.

An audit report for the United Tote systems at NYRA, Finger Lakes Racetrack, Capital OTB, Tioga Downs and Vernon Downs was timely filed. The report for the United Tote systems at Western OTB/Batavia was filed 32 days late.

An audit report for the Scientific Games systems at Nassau OTB, Suffolk OTB, Catskill OTB, Yonkers Raceway, Saratoga Equine Sports Center and Monticello Raceway was timely filed however staff determined that it did not meet this years requirements. Subsequent discussions led to Scientific Games submitting a supplement report dated February 5, 2010 from their independent auditors that staff determined substantially met the Board's requirements.

AmTote provides totalisator services for NYCOTB and Buffalo Raceway. A report that did not meet this years requirements was received December 9, 2009 that was 39 days late. Subsequent discussions led to AmTote submitting a supplement report dated February 5, 2010 from their independent auditors that staff determined substantially met the Board's requirements.

Staff has concluded that these reports meet the minimum requirements established by the Board for each of the OTB's and tracks.

A summary and analysis of each report that was received can be provided for review upon requested.
