 - a. Retransmission of your simulcast signal by authorized recipients to secondary recipients is not allowable without disclosure within the contract of the names and locations of all secondary recipients.
 - b. The Board has the authority to audit the out-of-state receiving site's books and records (including all secondary sites that receive your simulcast) and must be noted in any simulcast agreement entered into for your simulcast signal. Included within the agreement must be reference that the guest shall permit inspection of the totalisator facilities at the site where guest's wagers are subject to commingling and all related totalisator books and records by a representative of the host or of the host's Board. Names and contact telephone numbers and/or addresses of managers at all pari-mutuel "hubs" used in the course of your simulcast transactions, if not included within individual contracts, must be supplied to the Board.
 - c. Any agreement which you are party to is subject to the requirements of the host and guest states with any provision mandated by either jurisdiction with such provisions specifically incorporated into contract by reference. Both parties, including any Secondary Recipients, shall comply with the provisions of all-applicable Federal, State and local laws and regulations.
 - d. An SAS-70 Type II audit is to be performed for the current licensing period on the totalizator operations utilized and located at your facility. The report is to be filed with the Board no later than October 31, 2009.
 - e. Rule 5100.2(b)(1), which requires that the track's totalisator system be in compliance with Rule 5100.24(l)-Independent Monitoring System.

4. NYS TAXATION & FINANCE - CERTIFICATION OF YEAR 2008 RACING DATES/RACES FOR TAX RATE PURPOSES

The New York State Racing and Wagering Board certified pursuant to Section 236 (3)(b)(ii) and Section 318 (5)(b)(ii) of the Racing, Pari-Mutuel Wagering and Breeding Law that Finger Lakes Racetrack, Monticello Raceway, Saratoga Gaming and Raceway,

and Yonkers Raceway did conduct during the year 2008 at least 90% of programs/races in 1985 or 1986 (whichever is less).

For 2008, the Board found that for Batavia Downs, Buffalo Raceway, and Vernon Downs, it would have been uneconomical or impractical for these corporations to be assigned the prescribed number of racing dates, pursuant to Section 318(5)(b)(ii). Therefore, such finding entitles these harness racetracks to be classified as if each complied with such requirements.

Accordingly, the Board certified that Finger Lakes, Batavia Downs, Buffalo Raceway, Monticello Raceway, Saratoga Harness, Vernon Downs, and Yonkers Raceway have complied with either Section 236(3)(b)(ii) or Section 318(5)(b)(ii) of the Racing, Pari-Mutuel Wagering and Breeding Law for the purpose of establishing the 2008 pari-mutuel tax rate.

5. NYRA – REQUEST TO MODIFY INTERNET & ACCOUNT WAGERING – NYRA REWARDS PLAYERS CLUB

1. dismissed the sixty (60) day license suspension and \$1,000 fine in relation

The Board has the authority to audit the out-of-state receiving site's books and records (including all secondary sites that receive your simulcast) and must be noted in any simulcast agreement entered into for your simulcast signal. Included within the agreement must be reference that the guest shall permit inspection of the totalisator facilities at the site where guest's wagers are subject to commingling and all related totalisator books and records by a representative of the host or of the host's Board. Names and contact telephone numbers and/or addresses of managers at all pari-mutuel "hubs" used in the course of your simulcast transactions, if not included within individual contracts, must be supplied to the Board.
 - e. Any agreement which you are party to is subject to the requirements of the host and guest states with any provision mandated by either jurisdiction with such provisions specifically incorporated into contract by reference. Both parties, including any Secondary Recipients, shall comply with the provisions of all-applicable Federal, State and local laws and regulations.
 - f. An SAS-70 Type II audit is to be performed for the current licensing period on the totalizator operations utilized and located at your facility. The report is to be filed with the Board no later than October 31, 2009.
 - e. Rule 5100.2(b)(1), which requires that the track's totalisator system be in compliance with Rule 5100.24(l)-Independent Monitoring System.

4. NYS TAXATION & FINANCE - CERTIFICATION OF YEAR 2008 RACING DATES/RACES FOR TAX RATE PURPOSES

The New York State Racing and Wagering Board certified pursuant to Section 236 (3)(b)(ii) and Section 318 (5)(b)(ii) of the Racing, Pari-Mutuel Wagering and Breeding Law that Finger Lakes Racetrack, Monticello Raceway, Saratoga Gaming and Raceway,

and Yonkers Raceway did conduct during the year 2008 at least 90% of programs/races in 1985 or 1986 (whichever is less).

For 2008, the Board found that for Batavia Downs, Buffalo Raceway, and Vernon Downs, it would have been uneconomical or impractical for these corporations to be assigned the prescribed number of racing dates, pursuant to Section 318(5)(b)(ii). Therefore, such finding entitles these harness racetracks to be classified as if each complied with such requirements.

Accordingly, the Board certified that Finger Lakes, Batavia Downs, Buffalo Raceway, Monticello Raceway, Saratoga Harness, Vernon Downs, and Yonkers Raceway have complied with either Section 236(3)(b)(ii) or Section 318(5)(b)(ii) of the Racing, Pari-Mutuel Wagering and Breeding Law for the purpose of establishing the 2008 pari-mutuel tax rate.

Spagnola for sixty (60) days and imposed a \$1,000 fine based upon the finding that the TCO2 level of the horse DIRT CHEAP N, which competed at Saratoga Raceway on March 30, 2008 and was trained by Mr. Spagnola, exceeded the acceptable level, and thus constituted violation of Board Rules 4120.13 and 4120.4.

18. IN THE MATTER OF ROBERT W. SUMNER

The New York State Racing and Wagering Board upheld with modification the recommendation of designated Hearing Officer Russell H. Baller, Jr. in relation to three reported excessive TCO2 levels in horses trained by Robert W. Sumner, in violation of Board Rules 4120.13 and 4120.4 as follows:

1. upheld a sixty (60) day license suspension and \$1,000 fine in relation to a reported excessive TCO2 level finding of the horse SPORTY NATE, which competed at Yonkers Raceway on February 4, 2008,

2. upheld a seventy-five (75) day license suspension and \$2,500 fine in relation to a reported excessive TCO2 level finding of the horse ARTS MATTJESTY, which competed at Yonkers Raceway on February 23, 2008, and

3. revoked the license of Robert W. Sumner and declared him ineligible to reapply for five (5) years imposed a five-year license suspension including no direct or indirect participation in New York pari-mutuel horse racing, and imposed a \$5,000 fine in relation to a reported excessive TCO2 level finding of the horse ARTS MATTJESTY, which competed at Yonkers Raceway on April 5, 2008.

19. IN THE MATTER OF GERALD H. DECKER

The New York State Racing and Wagering Board upheld the recommendation of designated Hearing Officer Russell H. Baller, Jr. and sustained the sixty (60) day license suspension of the harness owner-trainer license of Gerald H. Decker and imposed a \$1,000 fine based upon the finding that the TCO2 level of the horse CAPITOL JET, which competed at Monticello Raceway on May 20, 2008 and was trained by Mr. Decker, exceeded the acceptable level, and thus constituted violation of Board Rules 4120.13 and 4120.4.

20. IN THE MATTER OF RICK C. ZUFELT

The New York State Racing and Wagering Board upheld the recommendation of designated Hearing Officer Russell H. Baller, Jr. and revoked the thoroughbred groom-exercise rider licenses of Rick C. Zufelt based upon his failure to comply with terms of his reinstatement to racing by failing to comply with the direction to provide a urine specimen on November 1, 2008 at Finger Lakes Racetrack, and prior substance abuse violations.

21. IN THE MATTER OF NOEL ITARA

The New York State Racing and Wagering Board upheld the recommendation of designated Hearing Officer Russell H. Baller, Jr. and revoked the thoroughbred groom-general services licenses of Noel Itara based upon his failure to comply with terms of his Consent to Conditions for Reinstatement dated April 18, 2008, and the prior related human substance abuse violation.

22. IN THE MATTER OF DENNIS J. LATERZA

The New York State Racing and Wagering Board upheld the recommendation of designated Hearing Officer Russell H. Baller, Jr. that the harness racing trainer license of Dennis J. Laterza be suspended for five (5) years, including no direct or indirect participation in New York pari-mutuel horse racing, and a \$2,500 fine be imposed based upon a finding of Recombinant Human Erythropoietin (rhEPO) in the post-race blood of the horse LEMON PEPPER, which competed in the 9th race at Yonkers Raceway on April 27, 2007 and was trained by Mr. Laterza. The disciplinary action was based on violations of Board Rules 4120.2(h) and 4120.4.
