

#### MINUTES NEW YORK STATE RACING AND WAGERING BOARD MEETING OF JULY 21, 2009

## **B.** ITEMS PREVIOUSLY APPROVED OR DEFERRED BY THE CHAIR

#### 1. BUFFALO RACEWAY – REQUEST TO CONDUCT TRIPLE CROWN CONTEST

- 69. For entry into the minutes, on May 22, 2009, the New York State Racing and Wagering Board approved an amendment to the Yonkers Raceway simulcast plan of operation authorizing the simulcast for wagering purposes of races from Louisiana Downs (Thoroughbred Meet), Louisiana through October 4, 2009.
- 70. For entry into the minutes, on May 27, 2009, the New York State Racing and Wagering Board approved an amendment to the Yonkers Raceway simulcast plan of operation authorizing the simulcast for wagering purposes of races from Rockingham Park, New Hampshire from June 6, 2009 through August 30, 2009.

# C. ITEMS PREVIOUSLY APPROVED, DENIED OR DEFERRED BY THE BOARD

1. **IN THE MATTER OF MICHAEL L. DAVILA, JR. (SUMMARY SUSPENSION)** For entry into the minutes, on May 5, 2009, the New York State Racing and Wagering Board summarily suspended the jockey license of Michael L. Davila based upon a positive human drug test in violation of the conditions of his license and a finding that the public safety and welfare imperatively required this emergency action.

# 2. NEW YORK CITY OTB – APPOINTMENT OF NEW MEMBERS TO BOARD OF DIRECTORS – NEWMAN & BERGAMO

For entry into the minutes, on May 21, 2009, the New York State Racing and Wagering Board approved an amendment to the New York City Off-Track Betting Corporation's plan of operation to reflect the appointment of Steven Newman and Anthony Bergamo as members of the New York City Off-Track Betting Corporation's Board of Directors.

## 3. **REINSTATEMENT OF NORBERTO ARROYO, JR.**

For entry into the minutes, on May 27, 2009, the New York State Racing and Wagering Board approved the reinstatement of Norberto Arroyo, Jr. to participate in pari-mutuel thoroughbred racing.

## 4. REINSTATEMENT OF THOMAS G. MILICI

For entry into the minutes, on May 27, 2009, the New York State Racing and Wagering Board denied the reinstatement of Thomas G. Milici as a pari-mutuel harness racing licensee.

# 5. NASSAU REGIONAL OTB – REQUEST TO AMEND ACCOUNT WAGERING PROGRAM

For entry into the minutes, on June 1, 2009, the New York State Racing and Wagering Board approved the Nassau Regional Off-Track Betting Corporation's March 30, 2009 request to amend its plan of operation to authorize the use of permanent wagering accounts by individual account holders for purposes of handicapping contests.

#### 6. YONKERS RACEWAY – REQUEST FOR APPROVAL OF PEACE OFFICER

For entry into the minutes, on June 16, 2009, pursuant to Section 312 of the Racing, Pari-Mutuel Wagering and Breeding Law, the New York State Racing and Wagering Board granted Yonkers Racing Corporation's request to approve the appointment of Benjamin Heard as a special policeman within and around the grounds of Yonkers Raceway.

# 7. NEW YORK CITY OTB – REQUEST TO APPOINT NEW CHAIRMAN OF THE BOARD – MEYER S. FRUCHER

For entry into the minutes, on June 17, 2009, the New York State Racing and Wagering Board approved amendments to the New York City Off-Track Betting Corporation's plan of operation to reflect the following changes:

- The resignation of David Cornstein as Chairman of the Board of Directors of the Corporation
- The resignation of Timothy Gilchrist as a Member of the Board of Directors
- The appointment of Meyer S. Frucher as a Member of the Board of Directors, as well as the designation by the Governor for Mr. Frucher to serve as Chairman of the Board of Directors.

## 8. IN THE MATTER OF ALVIN COLON – SUMMARY SUSPENSION

For entry into the minutes, on June 25, 2009, the New York State Racing and Wagering Board summarily suspended the exercise rider/apprentice jockey licenses of Alvin Colon based upon a positive human drug test in violation of the conditions of his licenses and a finding that the public safety and welfare imperatively required this emergency action.

## 9. IN THE MATTER OF BETH AARON SYNAGOGUE SISTERHOOD – SUMMARY SUSPENSION

For entry into the minutes, on July 1, 2009, the New York State Racing and Wagering Board summarily suspended the identification number and charitable gaming license of the Beth Aaron Synagogue Sisterhood based upon the guilty pleas of Rabbis Sroya and Mordecai Abraham Sorcher to embezzling money and a finding that the public safety and welfare imperatively required this emergency action.

## 10. NYRA – REQUEST TO VIDEO STREAM LIVE "TALKING HORSES" SHOW

For entry into the minutes, on July 1, 2009, the New York State Racing and Wagering Board approved the April 2, 2009 request of the New York Racing Association to video stream live the "Talking Horses" show to be produced on-track by NYRA and the Daily Racing Form, Inc. during the Saratoga race meeting.

#### D. ITEMS TO BE APPROVED, DENIED OR DEFERRED BY THE BOARD

#### 1. YONKERS RACEWAY – 2009 TRACK & SIMULCAST LICENSE APPLICATIONS

The New York State Racing and Wagering Board assigned to Yonkers Raceway the race dates requested for the months of August and September, 2009 only.

#### 2. MONTICELLO RACEWAY – 2009 TRACK & SIMULCAST LICENSE APPLICATIONS

The New York State Racing and Wagering Board assigned to Monticello Raceway the race dates requested for the months of August and September, 2009 only.

# 3. BATAVIA DOWNS/WESTERN REGIONAL OTB – 2009 TRACK & SIMULCAST LICENSE APPLICATIONS

The New York State Racing and Wagering Board assigned to Western Regional OTB/ Batavia Downs the race dates requested for the months of July and August, 2009 only.

The Board deferred action on the Batavia Downs track and simulcast license applications pending receipt of an amended request for race dates to reflect a total of 72 dates specified in the new agreement with its horsemen.

## 4. CATSKILL REGIONAL OTB – REQUEST TO RELOCATE SUFFERN BRANCH TO RAMAPO, NY

The New York State Racing and Wagering Board deferred action on the Catskill OTB request to relocate its 140 Orange Avenue, Suffern, N.Y. branch to 84 Route 59 in the Town of Ramapo, New York.

#### 5. CAPITAL DISTRICT REGIONAL OTB – MODIFY CASH REWARDS PROGRAM – INCREASE REWARDS PERCENTAGE ACCUMULATION The New York State Racing and Wagering Board approved the May 11, 2009 request by Capital District Regional Off-Track Betting Corporation to amend their Plan of

Operation to modify its Monthly Rewards Schedule. The following table reflects the increased reward percentages that were approved:

#### 6. NOTICE OF PROPOSED RULEMAKING – EXEMPTING CERTAIN RAFFLES FROM REGISTRATION & LICENSING - RULE 5620.22

The New York State Racing and Wagering Board approved the submission to the Department of State of a Consensus Rulemaking to conform Rule 5620.22 to the licensing and registration provisions of Section 190-a of the General Municipal Law. This rule will implement the provisions of Chapter 678 of the laws of 2004, which eliminated the requirement that authorized organizations obtain Board identification numbers and licenses when conducting raffles in which the proceeds will not meet or exceed over \$5,000 for a single raffle, or \$20,000 for a series of raffles conducted during a calendar year.

## 7. IN THE MATTERS OF FRANK C. CALECA & ROBERT H. MERTON

The New York State Racing and Wagering Board upheld the recommendation of designated Hearing Officer Russell H. Baller, Jr. and suspended the license of harness racing/trainer Frank C. Caleca for sixty (60) days and fined him \$1,000 based upon excessive TCO2 level in the horse ARMBRO CHIVALRY, trained by him, which competed at Yonkers Raceway on December 8, 2008, in violation of Board Rules 4120.13 and 4120.4.

The New York State Racing and Wagering Board upheld the recommendation of designated Hearing Officer Russell H. Baller, Jr. and suspended the license of harness racing trainer Robert Merton for seventy-five (75) days and fined him \$2,500 based upon excessive TCO2 level finding in the horse ART OF WAR, trained by him, which competed at Yonkers Raceway on April 14, 2008, in violation of Board Rules 4120.13 and 4120.4.

#### 8. IN THE MATTER OF GENERAL B. WASHINGTON, JR.

The New York State Racing and Wagering Board upheld the recommendation of designated Hearing Officer Russell H. Baller, Jr. and suspended the license of harness driver General B. Washington, Jr. for eight (8) days because while driving the horse MICHELPANGELO he interfered with the horse ANALYST N causing him to break stride in the 5th race on April 2, 2009 at Monticello Raceway, in violation of Board Rule 4117.4(a), (b) and (k).

#### 9. IN THE MATTER OF DIANA BARTELLS - DISQUALIFICATION OF MICHELPANGELO AT MONTICELLO

The New York State Racing and Wagering Board upheld the recommendation of designated Hearing Officer Russell H. Baller, Jr., granted the summary judgment motion and dismissed the appeal of owner Diana Bartells who appealed the placement decision of the judges that disqualified MICHELPANGELO and placed that horse 8<sup>th</sup> during the 5<sup>th</sup> race on April 2, 2009 at Monticello Raceway based upon violation of Board Rules 4117.4(a), (b), and (k).

#### 10. IN THE MATTER OF OMAR GONZALEZ

The New York State Racing and Wagering Board upheld the recommendation of designated Hearing Officer Russell H. Baller, Jr. and revoked the thoroughbred groom's license of Omar Gonzalez based upon his admission of marijuana use, his voluntary surrender of his license, and failure to comply with the terms of the voluntary surrender.

# 11. IN THE MATTER OF MARY L. JONES AND PAUL M. JONES

The New York State Racing and Wagering Board upheld the recommendation of designated Hearing Officer Russell H. Baller, Jr. and revoked the harness racing owner/ trainer/provisional driver's licenses of Mary L. Jones and Paul M. Jones based upon a finding of financial irresponsibility (Board Rule 4102.5). The Board determined that each will be allowed to reapply upon proof that the outstanding unsatisfied judgment has been satisfied.

## 12. IN THE MATTER OF MARK CAPONE AND VALERIE KUTIL

The New York State Racing and Wagering Board upheld the recommendation of designated Hearing Officer Russell H. Baller, Jr. and revoked the harness racing trainer/driver's license of Mark Capone and the harness owner's license of Valerie Kutil based upon a finding of financial irresponsibility (Board Rule 4102.5). The Board determined that each will be allowed to reapply if each signs the Consent to Conditions described in the record of the proceeding.

# 13. IN THE MATTER OF PERRY GOODMAN

The New York State Racing and Wagering Board upheld the recommendation of designated Hearing Officer Russell H. Baller, Jr. and revoked the harness racing groom's license of Perry Goodman based upon charges that he failed to comply with a directive to appear for a urine test and had failed to comply with the terms for the reinstatement of his license.

# 14. IN THE MATTER OF ANTHONY T. GIOVANNELLI

The New York State Racing and Wagering Board upheld the recommendation of designated Hearing Officer Russell H. Baller, Jr. in reference to harness racing trainer/driver/groom Anthony Giovannelli, Jr. and imposed the following disciplinarian action:

- Upheld the twenty-day license suspension and \$500 fine for the violation associated with the post-race flunixin positive
- Found that Mr. Giovannelli engaged in wrongful and fraudulent conduct in that he "surreptitiously pilfered the bottom portions of the Blood and Urine tags" related to the post-race positive
- Found that Mr. Giovannelli violated the terms of his Consent to Conditions for Racing Privileges, dated February 28, 2008.
- Revoked Mr. Giovannelli's valid receipt/and or license until such time as he can demonstrate requisite fitness to participate in racing
- Imposed a fine of \$2,500.

This matter is based upon the reported post-race flunixin positive for the horse BLAZING SHADOWS T, trained by him, which competed at Monticello Raceway on November 4, 2008 (Board Rules 4120. 2[(d] and 4120.4) and the charge (by Order to Show Cause dated April 27, 2009) with violation of Board Rules 4102.2, 4119.7(a)(3) and (5), and 4119.9 in relation to misconduct concerning the "disappearance" of the original sample tags associated with the November 4, 2008 equine drug positive.

## 15. IN THE MATTER OF WILLIAM J. GALLION

The New York State Racing and Wagering Board upheld the recommendation of designated Hearing Officer Russell H. Baller, Jr., granted the motion for summary judgment and revoked the thoroughbred owner's license of William J. Gallion based upon grounds associated with his conviction on nine criminal counts of federal wire fraud.

## 16. RULE MAKING PROPOSAL - COUPLED ENTRIES

The New York State Racing and Wagering Board approved the proposal of amendments to the existing thoroughbred rule that governs coupling of horses in races other than races where the gross purse is greater than one million dollars. The proposal approved would amend Rule 4025.10(d) to permit trainers to enter a maximum of two horses per race as uncoupled entries provided the entries do not have common ownership. It would also amend Rule 4035.2(e) to authorize the stewards to disqualify both of the horses entered by the same trainer and run on an uncoupled basis in the event one is disqualified and in the judgment of the stewards that violation prevented any other horse from finishing ahead of the other horse trained by the same trainer.
