

MINUTES NEW YORK STATE RACING AND WAGERING BOARD MEETING OF FEBRUARY 14, 2008

A meeting of the New York State Racing and Wagering Board was held on Thursday, February 14, 2008 at 10:00 a.m. at the Racing & Wagering Board's Schenectady Office located at 1 Broadway Center, Suite 600, Schenectady, New York.

A report listing any and all findings of this analysis should be submitted to the Board no later than 20 days from the date the promotion was held.

In the event that two or more customers select the correct score, the winner will be drawn from among the correct entries and a fifty (\$50.00) dollar OTB wagering voucher will be awarded to all the runners-up. If no one picks the correct score, a random drawing will be held from among all entries for a one hundred (\$100.00) dollar OTB wagering voucher.

Approval is conditioned on compliance with the terms of the January 9, 2008 application. Employees of Western Regional Off-Track Betting Corporation and all of its EZ-Bet locations are ineligible to participate.

59. YONKERS RACEWAY – REQUEST TO OFFER ACCOUNT WAGERING SIGN-UP PROMOTIONS

For entry into the minutes, on January 11, 2008, the NYS Racing and Wagering Board approved the Yonkers Raceway request to conduct the following promotions during 2008 in relation to the Yonkers Raceway account wagering operation:

- 5. Any new customer will receive a free services promotion in which any new account activated during the promotional month will receive free race replays, a waiver of the monthly service fee and a waiver of the transaction fee.
- 6. If an existing customer refers a friend that activates a Yonkers wagering account of fifty (\$50.00) dollars or more, he or she will receive fifty (\$50.00) dollars into his or her account after the referred person deposits fifty (\$50.00) dollars inter their account and maintains that account in good standing for a period of thirty days.
- 7. If a customer wagers an aggregate of two hundred (\$200.00) dollars or more during a promotional period, he or she will receive a credit into his or her Yonkers wagering account of an amount equal to at least a 10% discount on any handicapping products that the customer purchased during the promotion period.

This approval is effective immediately and is conditioned upon compliance with the terms of the promotions as set forth in the application to the Board. These promotions are subject to audit.

The approval was conditioned upon ratification of the appointment by the Board of Stewards of the Jockey Club and filing of same with the Board.
