

# Fiscal Year 2006–2007 Year-End Report

Now in its 40<sup>th</sup> year in operation, the New York Lottery has evolved into one of the world's leading Lottery organizations with annual incoming revenue of \$7.1 billion and aid to education for the last fiscal year alone totaling \$2.3 billion. This brings the Lottery's total aid to education contribution since 1967 to more than \$31 billion.

The New York Lottery's primary mission is to earn revenue for education. The Lottery's ongoing commitment to education includes programs like the Governor Hugh L. Carey Empire State Games, Educator of the Week, EdVideo Online, Regents Review Live, and, of course, the Leaders of Tomorrow (LOT) Scholarship



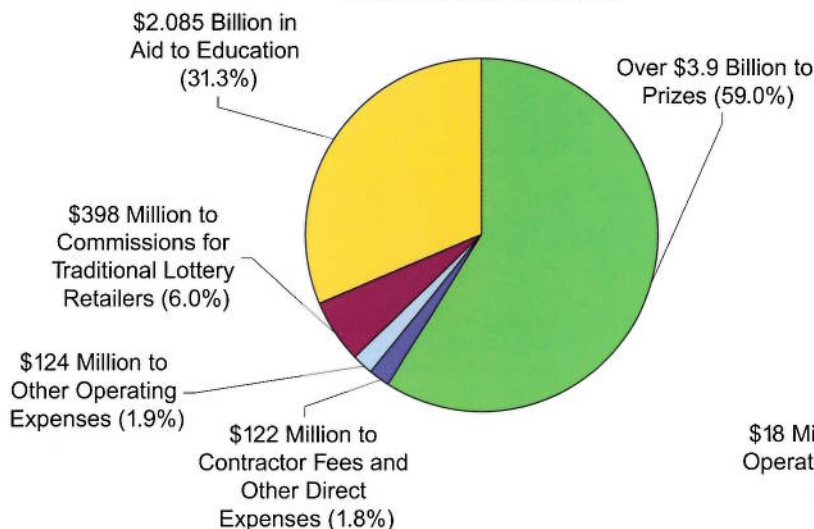

With the support of New York's Governor and Legislature, the four-year 2007 LOT Scholarship for students entering college in the 2007–08 academic year has been increased from \$4,000 to \$5,000. And as further evidence of the Lottery's commitment to education at all levels, the Division recently formalized its alliance with the New York State Office of Alcohol and Substance Abuse Services to fund initiatives to help curb the rising incidence of underage gambling being reported nationwide.

## Where Do Lottery Dollars Go?

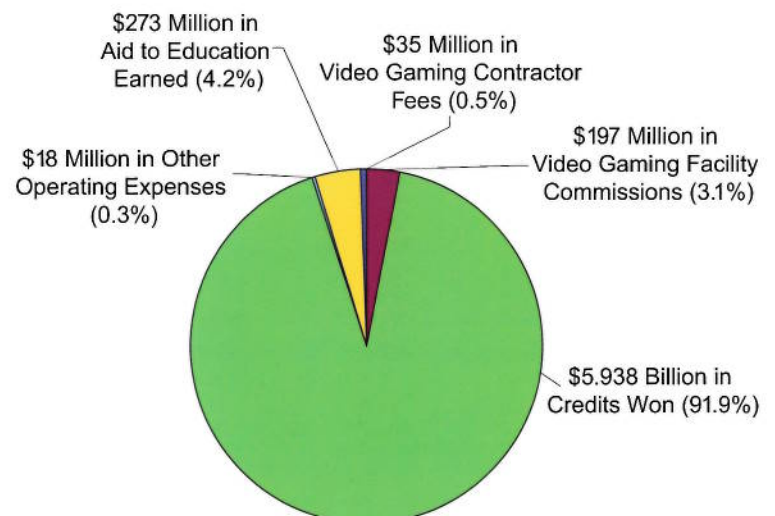
### TRADITIONAL LOTTERY SALES DOLLARS

## Leaders of Tomorrow SCHOLARSHIPS

The Leaders of Tomorrow Scholarship program provides one \$5,000 scholarship to one eligible senior in every participating high school in New York State to offset the cost of attendance at a New York State college, university, community college or trade school of the student's choice. The scholarship is paid in four annual payments of \$1,250.

The Lottery sponsors the Games to help showcase the valuable lessons that can be learned through sport, including hard work and fair play.

## EdVideo Online

EdVideo Online provides access to streaming video and downloadable video that meets current state and national educational standards. The service is available to 262,000 educators representing more than 3.3 million students statewide.
