OPEN COMMENT PERIOD: Began 2:00 p.m. Bill Croll, Oneida County Legislator discussed what Vernon Downs has accomplished over the past year regarding bringing outstanding taxes up to date, etc. Myron Thurston, Town of Vernon Supervisor stated how Vernon Downs is an intregal part of the community. ## 1. VERNON DOWNS TRACK LICENSE APPLICATION FOR 2004

The Board refused, pursuant to Racing, Pari-Mutuel Wagering and Breeding Law Sections 307 and 320, to grant the application of Mid-State Raceway, Inc. for a license to conduct pari-mutuel harness racing at Vernon Downs during the calendar year 2004 because the issuance of such license would not serve the public interest, convenience or necessity and the best interests of racing generally based upon the financial condition of Mid-State Raceway, Inc., the non-licensed status of Shawn Scott, breach of the Stipulation of Settlement dated April 10, 2003, fire safety matters, and the provision of false and/or misleading information to the Board concerning fire safety matters.

## 2. VERNON DOWNS SIMULCAST LICENSE APPLICATION FOR 2004

The Board refused, pursuant to Racing, Pari-Mutuel Wagering and Breeding Law Section 1003, to grant the application of Mid-State Raceway, Inc. for a license to display the simulcast of horse races on which pari-mutuel wagering shall be permitted because the applicant is not authorized to conduct parimutuel wagering.
