3. NEW YORK RACING ASSOCIATION REQUEST TO ACCEPT WAGERS ON PICK-SIX PARIMUTUEL POOL AT SANTA ANITA
For entry into the minutes, on February 24, 1999, approval was granted for

If no one, anywhere, participating in the pick-six pool has all six winners on

Saturday; NYRA patrons may also participate in the carry-over

pool on Sunday, March 7, 1999.

4. NEW YORK CITY OFF-TRACK BETTING REQUEST TO AMEND PLAN OF OPERATION For entry into the minutes, on February 24, 1999, approval was granted for the

request by the New York City Off-Track Betting Corporation to amend their plan

of operation and appoint Mr. Richard Labriola to Executive Vice President of Operations and Mr. Dennis McManus to Senior Vice President of New Business, Telephone Betting Operations and Community Affairs.

5. NASSAU OFF-TRACK BETTING CORPORATION TO SIMULCAST FROM HIALEAH PARK AND SPORTSMAN'S PARK

For entry into the minutes, on February 24, 1999, approval was granted for the request by Nassau Off-Track Betting Corporation to import the simulcast signals from Hialeah Park in Florida and Sportsman's Park in Illinois, as provided for in the Racing Law, and for their entire 1999 race meetings.

This approval also extends to the Suffolk Regional Off-Track Betting Corporation.

6. NEW YORK RACING ASSOCIATION REQUEST TO SIMULCAST RACES OF SPECIAL INTEREST FROM HIALEAH

For entry into the minutes, on February 25, 1999, approval was granted for the request by the New York Racing Association to designate the following thoroughbred races as special events:

7. NEW YORK RACING ASSOCIATION REQUEST TO CONDUCT PROMOTIONAL EVENTS For entry into the minutes, on March 2, 1999, approval was granted for the request by the New York Racing Association to conduct the following promotional events:

March 27th - Free grandstand admission at Aqueduct Racetrack to anyone who attends the Market Pro Computer Show and Sales to be held on March 20th and 21st at Aqueduct.

April 10th - Direct mailing of Mystery Mutuel Vouchers to approximately 50,000 patrons on Aqueduct's mailing list. Vouchers will be valued at \$2, \$5, \$100 and \$10,000. Approximately 20% of the vouchers mailed will be valued at \$5 or more and one voucher will be valued at \$10,000.

April 17th and 18th - Handicapping Tournament - There is an entry fee of \$300 per person to enter this tournament for the two days. The entry fee entitles each patron to clubhouse and Equestris admission, luncheon buffet, cocktail reception, complimentary track program and Daily Racing Form and a free NYRA gift (article of clothing) for both days. The tournament will be held in the area of the Equestris Dining Room.

May 1st - Free Clubhouse and Equestris Dining Room admission and a free \$2 bet voucher on Kentucky Derby Day, Saturday, May 1st , as part of Aqueduct's Kentucky Derby party. The party will be priced between \$30 and \$35 per person, with a final decision due on March 1st. The bet voucher is valid only on Derby Day.

Free Clubhouse admission coupon in conjunction with print advertising in City Guide, a magazine distributed in NYC and on Long Island, a Long Island publication. The coupon is valid during weekdays only (excluding holidays), during the Aqueduct or Belmont Park spring and summer meetings.

NYRA, in conjunction with the NYS Thoroughbred Breeding and Development Fund will offer two daily Saratoga Clubhouse passes to all winners of a "Vote for your New York Bred choice of the Year" contest. Voting will be conducted on the NYS Thoroughbred and Development web site and on track at Aqueduct through March 21st.

Denied The Board denied NYRA's request to participate in the National Thoroughbred Racing Association's Fantasy Challenge. This request was denied because it violates the provisions of Section 908 regarding handicapping tournaments which requires that all fees collected be distributed as prizes, as well as the requirement that 50% of the races of the tournament be held in New York.

8. WESTERN OTB REQUEST TO AMEND ITS PLAN OF OPERATION For entry into the minutes, on March 2, 1999, approval was granted for the request by Western Off-Track Betting Corporation to amend its plan of operation

and appoint Mr. Phillip Tooze as the concessionaire of the simulcast branch located at 8315 Park Road, Batavia, New York.

The approval is conditioned upon a satisfactory return of Mr. Tooze's fingerprint card. (See F items.)

9. MONTICELLO RACEWAY REQUEST FOR UPCOMING 1999 CALENDAR YEAR For entry into the minutes, on March 3, 1999, approval was granted for the request by Monticello Raceway to import simulcasts, effective March 2 through November 27, 1999, from Saratoga Harness.

The Board also approved the simulcast export of Monticello signal to Northville Downs in Michigan throughout 1999.

10. VERNON DOWNS REQUEST TO SIMULCAST HIALEAH PARK
For entry into the minutes, on March 3, 1999, approval was granted for the
request by Vernon Downs to import the simulcast signal from Hialeah Park
(Florida) whenever permitted under the Racing Law.

Approval extends throughout the 1999 Hialeah Park meeting that concludes on May 22nd.

11. NASSAU OFF-TRACK BETTING REQUEST TO IMPORT SIMULCAST FROM LONE STAR PARK

For entry into the minutes, on March 3, 1999, approval was granted for the request by Nassau Off-Track Betting Corporation to simulcast the 1999 thoroughbred meeting from Lone Star Park in Texas. The Lone Star simulcasts begin on April 15th and conclude on July 25, 1999.

Approval also extends to Suffolk Regional Off-Track Betting Corporation.

12. NEW YORK CITY OFF-TRACK BETTING REQUEST TO SIMULCAST SPECIAL EVENTS For entry into the minutes, on March 3, 1999, approval was granted for the request by New York City Off-Track Betting Corporation to designate the following thoroughbred races from Santa Anita Park as special events:

13. BUFFALO RACEWAY SIMULCAST AGREEMENTS
For entry into the minutes, on March 9, 1999, approval was granted for the request by Buffalo Raceway to import simulcasts from Ladbroke at the Meadows in Pennsylvania, effective immediately.

The request for the importation of simulcasts for the 1999 season from Pocono Downs in Pennsylvania was deferred pending Board receipt of the federally required letters of consent. Letters from both the Pennsylvania Harness Commission and the representative harness horsemens' association at Pocono Downs are needed.

14. FINGER LAKES REQUEST TO EXPORT SIMULCAST TO MONTICELLO RACEWAY AND TO NASSAU OTB

For entry into the minutes, on March 9, 1999, approval was granted for the request by Finger Lakes to export simulcasts in-state to the Monticello Raceway

and Nassau Regional OTB during the 1999 approved racing season.

15. FINGER LAKES REQUEST TO SIMULCAST \$1,000 HANDICAPPING CHALLENGE For entry into the minutes, on March 9, 1999, approval was granted for the request by Finger Lakes to conduct a \$1,000 simulcast handicapping challenge on

March 20 and 21, 1999, as outlined in the official rules and regulations.

- 16. FINGER LAKES REQUEST TO REDUCE ADMISSION PRICE For entry into the minutes, on March 9, 1999, approval was granted for the request by Finger Lakes to reduce its admission price from \$3.50 to \$2.00 for entrance to either the grandstand or clubhouse.
- 17. MONTICELLO RACEWAY REQUEST FOR UPCOMING 1999 CALENDAR YEAR For entry into the minutes, on March 9, 1999, approval was granted for the request by Monticello Raceway to accept simulcasts from Tampa Bay Downs in Florida, effective immediately.
- 18. SARATOGA HARNESS REQUEST TO SIMULCAST LIST OF RACE TRACKS/OTB For entry into the minutes, on March 9, 1999, approval was granted for the request by Saratoga Harness to import simulcasts from Hiahleah Park from March

17th through May 22nd.

Also approved was the contract with Capital OTB extending through December 31, 1999, including in-home simulcast provisions.

Also approved, on March 15, 1999, was the export of simulcasts from Saratoga Harness to The Downs (Pocono Downs in Pennsylvania and its satellites), located in a contiguous state. The approval is valid throughout the 1999 racing season at Saratoga Harness.

Also approved were the Saratoga Harness exported simulcasts to the Lakes Region Greyhound Park in New Hampshire and to the Lebanon Raceway in Ohio.

19. CAPITAL DISTRICT OTB REQUEST TO AMEND PLAN OF OPERATION For entry into the minutes, on March 9, 1999, approval was granted for the request by Capital OTB to amend its plan of operation and appoint Mr. F. James Mumpton as the new Oneida County Director.

Approval is conditioned upon a satisfactory return of Mr. Mumpton's fingerprint card. See F-item on Agenda.

20. NEW YORK CITY OFF-TRACK BETTING REQUEST SIMULCAST RACES OF SPECIAL INTEREST

For entry into the minutes, on March 9, 1999, approval was granted for the request by New York City OTB to designate the Tampa Bay Derby to be held on Sunday, March 21, 1999, as a race of special interest, pursuant to Section 905-a of the Racing, Pari-Mutuel Wagering and Breeding Law.

This approval also applies to all New York Regional Off-Track Betting Corporations.

21. WESTERN OTB REQUEST TO AMEND PLAN OF OPERATION For entry into the minutes, on March 9, 1999, approval was granted for the request by Western OTB to amend its plan of operation and appoint Mr. Roger  ${\tt E.}$ 

Ruckman as the new Chautaugua County Director.

Approval is conditioned upon a satisfactory return of Mr. Ruckman's fingerprint

card. See F-item on Agenda.

22. WESTERN OTB REQUEST TO RECEIVE VERNON DOWNS SIMULCAST For entry into the minutes, on March 9, 1999, approval was granted for the request by Western OTB to receive the 1999 harness meeting from Vernon Downs.

The contract may be terminated by either party upon thirty days notice.

- 23. WESTERN OTB REQUEST FOR PROMOTIONAL EVENT For entry into the minutes, on March 9, 1999, approval was granted for the request by Western OTB to conduct a free drawing on St. Patrick's Day, Wednesday, March 17, 1999.
- 24. NEW YORK CITY OTB AMENDMENT TO PLAN OF OPERATION
  For entry into the minutes, on March 9, 1999, approval was granted for the request by New York City OTB to simulcast and accept wagers on the races

conducted by the Los Angeles Turf Club (Santa Anita) for the remainder of their 1999 Winter-Spring meeting.

- 25. CAPITAL OTB REQUEST TO SIMULCAST HOLYFIELD vs. LEWIS FIGHT For entry into the minutes, on March 11, 1999, approval was granted for the request by Capital District Regional OTB to simulcast the Holyfield vs. Lewis fight on Saturday, March 13, 1999 at its 711 Central Avenue Teletheater.
- 26. FINGER LAKES REQUEST TO EXPORT SIMULCAST TO CAPITAL OTB For entry into the minutes, on March 15, 1999, approval was granted for the request by Finger Lakes to export their simulcast in-state to the Capital District

OTB during the 1999 Finger Lakes racing season, now consisting of  $171\ \mathrm{racing}$  programs.

- 27. YONKERS RACEWAY SIMULCAST AGREEMENT WITH VERNON DOWNS AND SARATOGA For entry into the minutes, on March 15, 1999, approval was granted for the request by Yonkers Raceway to import in-state simulcasts from Vernon Downs and Saratoga Harness.
- 28. YONKERS RACEWAY SIMULCAST AGREEMENT WITH PLAINRIDGE RACECOURSE For entry into the minutes, on March 15, 1999, approval was granted for the request by Yonkers Raceway to export simulcast signal from Yonkers Raceway to Plainridge Racecourse in the contiguous State of Massachusetts during the entire

Yonkers Raceway racing season.

29. NEW YORK CITY OTB REQUEST TO AMEND PLAN OF OPERATION For entry into the minutes, on March 15, 1999, approval was granted for the request by New York City OTB to import simulcasts from Bay Meadows in California whenever applicable under the Racing Law. Approval extends through November 14, 1999.

- D. ITEMS TO BE APPROVED, DENIED OR DEFERRED BY THE BOARD
- 1. MATTER OF SUSAN M. DUBEE
  The Board approved Hearing Officer Hoblock's recommendation that Ms. Dubee receive an opportunity for a probationary license conditioned upon her compliance with Board licensing standards and rules.
- 2. MATTER OF MICHAEL ERB
  The Board approved Hearing Officer Martin's recommendation that Mr. Erb be found guilty of violating rules 4043.2(f), 4043.4 and 4042.1(d). The Board found insufficient evidence to find Mr. Erb in violation of Rule 4042.1(f) September 1, 1998. Further, the Board adopted the Hearing Officer's recommendation that Mr. Erb's thoroughbred trainer license be suspended for two years from the date the Board acts upon this recommendation.
- 3. MATTER OF CARMINE IORIO
  The Board approved Hearing Officer Hoblock's recommendation that, under the

circumstances, the \$100.00 penalty, as imposed by the State Steward for failing to conduct business in a proper manner at Finger Lakes Race Track is insufficient and increased the fine to \$500.

- 4. MATTER OF PATCHOGUE MOOSE LODGE #518
  The Board approved Hearing Officer Martin's recommendation that the charitable gaming registration of the Lodge be suspended until such time as the delinquent information is provided, that the appropriate municipal governing body be notified that the Lodge is delinquent and that no charitable gaming license may be issued to the Lodge so long as the delinquency exists.
- 5. AUTOTOTE SYSTEMS, INC. REQUEST TO AMEND HUB SITE
  The Board approved the request by Autotote Systems, Inc., dated February 8,
  1999, to

run Saratoga Harness remotely from its Catskill OTB hub site. Saratoga Harness would

be an association of Catskill OTB, similar to the arrangement between Nassau and

Suffolk OTB.

Approval is conditioned upon amendment of the contract. See F-item on Agenda.

6. FINGER LAKES REQUEST TO WITHDRAW FROM CAPITAL IMPROVEMENT FUND

The Board approved the request by Finger Lakes, letter dated February 12, 1999, to withdraw \$28,672.17 from their Capital Improvement Fund for reimbursement for various capital expenditures incurred by the track.

9. YONKERS RACEWAY REQUEST TO WITHDRAW FROM CAPITAL IMPROVEMENT FUND The Board approved the request by Yonkers Raceway, letter dated December 2, 1998, to withdraw \$279,811.47 from their Capital Improvement Fund for partial reimbursement of their 1996 expenses for grandstand demolition and relocation of betting operations to the Clubhouse.
