

To the Honorable Hugh L. Carey, Governor:

The New York State Racing and Wagering Board is pleased to submit to you its fourth annual report in accordance with Chapter 346 of the Laws of 1973.

In 1973, the Board was created to merge the functions of the State Racing Commission, Harness Racing Commission, Quarter Horse Racing Commission, Off-Track Pari-Mutuel Betting Commission and State Lottery Commission. In 1975, the State Bingo Control Commission was added; in 1976, the Lottery was transferred and the regulation of the new Games of Chance Law was added. Also during 1976, the Board was reorganized into three divisions, Racing and Off-Track Betting, Audit and Investigation and Wagering Systems.

1976 has been a year of mixed results for the Board. We received added jurisdiction with the newly enacted Games of Chance. Total racing revenues to the state fell but New York State still leads the nation. The state received from on-track and off-track betting a total of \$177,792,203. In a year with 1,804 racing days, the total handle for on and off-track racing exceeded all previous years, totaling \$2,698,616,464.

In September 1976, I was appointed Chairman of the Board and with Members Joseph H. Boyd Jr. and Bertram D. Sarafan, have worked to maintain the integrity and enhance the quality of racing in this state. In July, Member Boyd prepared an interim report on drug medication and his recommendations have substantially been adopted. New York State continues to prohibit the administration of any drug to race horses and insures this through the most thorough drug testing program in the country.

In the following pages, the various activities of the Board are set forth.

IN GENERAL

During 1976 with 1,804 racing days, New York State had over 14 million people in attendance at the races who wagered \$1,645,713,481. When combined with the Off-Track Betting handle, the total exceeds all previous years at \$2,698,616,464. Although revenues to the state fell this year, the total was still an impressive \$177,792,203. Of the total state revenue, \$152,880,271 came from on-track revenue, while \$24,911,932 came from Off-Track Betting.

Quarter Horse racing became a reality in New York State with the opening of Tioga Park in Nichols, New York. During their 86-day meet, the state received \$434,408 and almost \$700,000 was paid to horsemen in purses. In May of 1977, it is anticipated that a second track, Parr Meadows in Yaphank, Long Island will open.

The Board's medication study, led by Member Joseph H. Boyd Jr., continued in 1976. In August, an Interim Report was released and it examined the therapeutic efficacy of such drugs as Phenylbutazone (butazolidin) and Furosemide (lasix). In addition, the report explored the validity of the arguments for and against adopting a controlled medication program and compiled data, research and statistics pertaining to controlled medication.

The recommendations of the report have been substantially adopted. With the closing of the Jamaica Laboratory anticipated and the program for Equine Drug Testing and Research at Cornell State Veterinary College at Cornell University, New York State will have the most sophisticated and advanced drug testing program in the country. In addition the drug testing rules governing the different types of horse racing are being brought into conformity. Currently, there is post-race drug testing after each race run in the state and the Board is examining the possibility of expanding its pre-race drug testing program.

As a result of the amendment to the New York State Constitution and enabling legislation (Chapter 960 of the Laws of 1976) the conducting of Games of Chance by charitable and other non-profit organizations was legalized. The Board was given jurisdiction to proscribe the rules and regulations governing the games on a statewide basis. The localities, only with the approval of the electorate through a referendum, can authorize the conduct of these games. The localities are also responsible for the enforcement of the law and the Board's rules as well as the licensing of all legal games.

Bingo is still very popular with revenues to the state of over \$1.2 million from nearly 130,000 occasions statewide.

THOROUGHBRED RACING

Over 6.7 million people attended thoroughbred racing during the year in which Bold Forbes won the Belmont Stakes and Forego won the Marlboro Cup.

An additional 48 days were raced this year which produced a total handle of \$486,690,590 which was \$72 million more than last year. While revenue to the state decreased, it still totalled a respectable \$76,838,277. Most of the thoroughbred racing in New York State is conducted at the New York Racing Association tracks (Belmont, Saratoga and Aqueduct). With 300 racing days and a yearly attendance of 6.2 million fans, the state received most of its revenue from these tracks, \$73,342,594.

Finger Lakes, the only thoroughbred track in Central New York, had 181 racing days in 1976 with a total attendance of 635,719 and a handle of \$54,290,646, provided the state with \$3,383,460 in revenue for 1976.

Though New York State leads the nations in thoroughbred racing revenues, economic conditions and severe weather did little to aid

the industry and further problems will surely arise next year as thoroughbred racing comes to Meadowlands.

HARNESS RACING

During the 1,237 day harness season, over 7.3 million people attended the harness tracks to bet almost \$792 million. This year, however, harness revenues were lower than thoroughbred for the first time in 8 years.

The total revenue to the state from the harness tracks fell over 11% from \$85,287,250 in 1975 to \$75,607,586 in 1976, primarily due to the intense competition from Meadowlands which opened for 102 racing days on September 1, 1976. As a result, Yonkers, Roosevelt and Monticello Raceways all suffered a decline in handle and attendance in 1976.

There were some bright spots at the upstate tracks. The one week meets at the Syracuse Fairgrounds and the Historic Track in Goshen showed a marked increase in handle of 46% and 12% respectively. The Syracuse Mile also had an increase of almost 12% in attendance.

Still, New York State Harness racing reigns supreme. New York State receives almost twice the revenue of its nearest competitor, Illinois.

QUARTER HORSE

On July 1, 1976, New York State's first Quarter Horse track, Tioga Park, opened in Nichols. Over 160,000 fans attended the 86-day meet and bet \$7,040,656.

In May 1977, it is anticipated that a second track, Parr Meadows, will open in Yaphank, Long Island.

OFF-TRACK BETTING

For the first time since it began in 1971, the OTB handle passed the \$1 billion mark and the state received over \$4 million more this year than last. The total money, including for the first time, revenue from Connecticut OTB, for the state was \$24,911,932. The horse racing industry received almost \$43 million from OTB.

Off-Track Betting continued to expand in 1976 with the opening of the Catskill Regional OTB on April 22. The regional offices in Nassau and Suffolk counties became fully operational as well.

The future for OTB seems bright as branch offices continue to expand to capacity. The localities profit from the operation of OTB and received almost \$97 million in 1976.

BINGO

Bingo again this year shows that people still love to play. There were 3,180 organizations conducting games this year which is 350 more than in 1975. The state got \$1,231,600 from these games compared to \$1,182,133 in 1975. The interest is statewide as nearly 130,000 bingo occasions were held throughout the 650 municipalities which have enacted local laws authorizing bingo on a local option basis.

(1) Retroactive to Jan. 1, 1976, commission to the State from the New York Racing Association handle was reduced to 5% on regular wagering and 7½% on exotic wagering (down from 10% and 15%, respectively, in 1975). The NYRA is receiving 12% on regular wagering and 17½% on exotic (up from 7% and 10%, respectively). At the same time, franchise fees were changed from \$1,000 per program raced to 90% of NYRA's net taxable income or a minimum of \$50,000 per program raced, or all income in excess of \$1,750,000 whichever is the greatest.
