For MRP/DCP MAA and type II variations, if applicable, texts for product information /mock ups should be submitted in national language at end of the procedure. For type IA/IB variations concerning product information national translation should be submitted with the application.

If it is outside Belgium the MAH can choose his linguistic role. However one MAH can only correspond to one linguistic role.
2. Product information /mock ups should be submitted in French and/or German at end of procedure.
3. For national procedure the documents should be submitted in national language.
