Greenman moved that the name of Ecklund be shown as chief author on H. F. No. 4468. The motion prevailed.

S. F. No. 4476, A bill for an act relating to redistricting; adjusting the district boundaries of Senate Districts 15 and 16; adjusting the house of representatives district boundaries within Senate Districts 15, 16, and 58; proposing coding for new law in Minnesota Statutes, chapter 2.

Page 3, line 1, after "EFFECTIVE DATE" insert "; ESTABLISHMENT OF NEW PRECINCTS"

Page 3, line 4, after the period, insert "Notwithstanding any law to the contrary, if a boundary adjustment contained in this act requires a county, city, or town to reestablish a precinct boundary to conform to the adjustment, the affected county, city, or town must reestablish the necessary precincts as soon as practicable, but in no case later than June 17, 2022."

Renumber the sections in sequence

Amend the title as follows:

Page 1, line 4, after the semicolon, insert "adjusting the district boundaries of Congressional Districts 7 and 8; repealing obsolete district boundary adjustments;"

Correct the title numbers accordingly

With the recommendation that when so amended the bill be placed on the General Register.

Page 2, line 4, after the period, insert "At least two weeks prior to the sale, lease, or conveyance of county-owned property under this paragraph, the county must mail by certified mail the information in the notice to all property owners of record whose property is proximate to the property described in the notice. For the purposes of this paragraph "proximate" means the property owner's property is located two miles or less from the property described in the notice when the county-owned property is outside of the boundaries of a home rule charter or statutory city, or one mile or less from the property described in the notice when the county-owned property is located within the boundaries of a home rule charter or statutory city."

Page 2, line 5, before "bids" insert "and mailed notice to proximate property owners."
