RE: NOTICE OF BREACH OF REGISTRAR ACCREDITATION AGREEMENT

Dear Mr. Taame:

Please be advised that as of 12 July 2012, Name for Name, Inc. ("Name for Name") is in breach of its Registrar Accreditation Agreement ("RAA") with the Internet Corporation for Assigned Names and Numbers ("ICANN") dated 23 March 2011 ("RAA"). These breaches result from:

1. Failure to provide Registrar Services pursuant to Section 3.1 of the RAA resulting from the termination of Name for Name's Registry-Registrar Agreement (RRA) with Verisign Inc. (Verisign) effective 16 July 2012.
2. Failure to provide written notice within 30 days of any change to Name for Name's contact information pursuant to Section 5.11;
3. Failure to provide accurate contact details on Name for Name's website pursuant to Section 3.16 of the RAA; and
4. Failure to provide Whois service pursuant to 3.3.1 of the RAA.

Capitalized terms that are not defined in this notice have the meanings given to them in the RAA.

Please refer to the attachment below for details regarding these breaches. ICANN requests that Name for Name cure the breaches by 2 August 2012, 15 working days from the date of this letter, by taking the following actions:

1. Make arrangement to maintain Name for Names' RRA with Verisign and provide Registrar Services pursuant to Section 3.1 of the RAA.
2. Provide written notice to ICANN of changes to Name for Name's contact information as required by Section 5.11 of the RAA;
3. Provide accurate contact details on Name for Name's web site, including a valid email and mailing address, pursuant to Section 3.16 of the RAA; and
4. Provide Whois service as required by Section 3.3.1 of the RAA;

If Name for Name fails to timely cure these breaches, ICANN may commence the termination process.

ATTACHMENT

Failure to Provide Registrar Services

Section 3.1 of the RAA obligates registrars to provide Registrar Services. This provision states, "During the Term of this Agreement, Registrar agrees that it will operate as a registrar for each TLD for which it is accredited by ICANN in accordance with this Agreement."

On 26 June 2012, ICANN learned of Verisign's intent to terminate Name for Name's RRA. On 28 June 2012, ICANN sent an urgent notice via facsimile, courier and email to Name for Name urging Name for Name to contact Verisign immediately and make arrangements to maintain its RRA. As of the date of this letter, no one from Name for Name has responded to any of ICANN's communications.

Based on ICANN's inability to make contact with anyone at Name for Name, ICANN can only conclude that Name for Name failed to provide changes to its contact information as required by Section 5.11 of the RAA. Name for Name's failure to provide accurate contact details on its web site is a separate breach of the RAA.

On 9 July 2012, Name for Name was sent a notice of termination of RRA by Verisign. The effective date of the notice of termination is 16 July 2012. Without a valid RRA, Name for Name cannot provide Registrar Services. Accordingly, Name for Name's failure to provide Registrar Services is a breach of Section 3.1 of the RAA.
