Dear Murat Yaniklar,

Please be advised that as of 17 January 2018, Reg2C.com Inc. ("Reg2C.com") is in breach of its 2013 Registrar Accreditation Agreement with the Internet Corporation for Assigned Names and Numbers ("ICANN") dated 13 September 2014 ("RAA"). This breach results from:

1. Reg2C.com's failure to timely pay past due accreditation fees, as required by Section 3.9 of the RAA.

Please refer to the attachment for details regarding this breach.

In addition, Reg2C.com has been deemed noncompliant in the following areas:

1. Reg2C.com's failure to publish on Reg2C.com's website(s) and/or provide a link on its website to the Registrants' Benefits and Responsibilities Specification, as required by Section 3.7.10 of the RAA;
2. Reg2C.com's failure to publish an email address to receive abuse reports on the home page of Reg2C.com's website, as required by Section 3.18.1 of the RAA; and
3. Reg2C.com's failure to publish on its website a description of Reg2C.com's procedures for the receipt, handling and tracking of abuse reports, as required by Section 3.18.3 of the RAA.

Additional Concerns

Section 3.7.5.5 of the RAA requires registrars that operate a website for domain name registration or renewal to clearly display details of the registrar's deletion and auto-renewal policies on the registrar's website. The information on Reg2C.com's website regarding its deletion and auto-renewal policies is unclear.


ICANN requests that Reg2C.com cure these breaches by 7 February 2018, 21 days from the date of this letter, by taking the following actions:

1. Publish on Reg2C.com's website(s) and/or provide a link on its website to the Registrants' Benefits and Responsibilities Specification;
2. Publish an email address to receive abuse reports on the home page of Reg2C.com's website;
3. Publish a description of Reg2C.com's procedures for the receipt, handling and tracking of abuse reports on Reg2C.com's website;
4. Clarify Reg2C.com's deletion and auto-renewal policies, and provide the location of the details of these policies on Reg2C.com's website;
5. Provide ICANN with corrective and preventative action(s), including implementation date(s), to ensure that:
 - a. Reg2C.com will timely respond to ICANN compliance matters; and
 - b. Reg2C.com will timely make payment of its ICANN fees; and
6. Pay all past and currently due accreditation fees.

If Reg2C.com fails to timely cure the breaches and provide the information requested by 7 February 2018, ICANN may commence the RAA termination process.

ATTACHMENT

Failure to pay accreditation fees

Section 3.9 of the RAA requires registrars to timely pay accreditation fees to ICANN, consisting of yearly and variable fees. Reg2C.com owes ICANN past due accreditation fees, in breach of Section 3.9 of the RAA.

Failure to publish on Reg2C.com's website(s) and/or provide a link to the Registrants' Benefits and Responsibilities Specification

Section 3.7.10 of the RAA requires registrars to publish on its website(s) and/or provide a link on its website to the Registrants' Benefits and Responsibilities Specification attached to the RAA. Reg2C.com's failure to publish on its website or provide a link on its website to the Registrants' Benefits and Responsibilities Specification is a breach of Section 3.7.10 of the RAA.

Failure to publish an email address to receive reports of abuse

Section 3.18.1 of the RAA requires registrars to publish on the home page of their website an email address to receive abuse reports. Reg2C.com's failure to publish an email address on the home page of its website to receive abuse reports is a breach of Section 3.18.1 of the RAA.

Failure to publish a description of procedures for receipt, handling and tracking of abuse reports

Section 3.18.3 of the RAA requires registrars to publish on their website a description of their procedures for the receipt, handling and tracking of abuse reports. Reg2C.com's failure to publish a description of its procedures for the receipt, handling and tracking of abuse reports on its website is a breach of Section 3.18.3 of the RAA.
