SUBJECT: Public Notice of Feb. 21, 2014 Deadline for Objections to the IL-TRM Version 3.0 dated Feb. 14, 2014

The Staff of the Illinois Commerce Commission (“ICC Staff”) has received the Illinois Statewide Technical Reference Manual for Energy Efficiency Version 3.0 dated February 14, 2014 (“IL-TRM Version 3.0”) from the TRM Administrator Vermont Energy Investment Corporation (“VEIC”). ICC Staff understands that the IL-TRM Version 3.0 is a result of the IL-TRM Update Process that involved weekly meetings over the October 2013 through February 2014 timeframe with the Technical Advisory Committee (“TAC”), a subcommittee of the Illinois Energy Efficiency Stakeholder Advisory Group (“SAG”). Further, ICC Staff understands that this IL-TRM Update is a result of two SAG review and commenting cycles.¹ ICC Staff understands the [IL-TRM Version 3.0](#) to be a consensus document.

Stakeholders are urged to review the IL-TRM Version 3.0 to make certain that this document represents a consensus document, and to address any questions, concerns, or objections to Jennifer Hinman at jhinman@icc.illinois.gov and Thomas Kennedy at tkennedy@icc.illinois.gov, copying the SAG e-mail distribution list (Celia Johnson at Celia.Johnson@FutEE.biz) and the TRM Administrator (Erin Carroll at ecarroll@veic.org and Nikki Clace at nclace@veic.org). The IL-TRM Version 3.0 dated February 14, 2014 is publicly available and posted on the Commission’s website for review: <http://www.icc.illinois.gov/Electricity/TRM.aspx>. In the event that ICC Staff does not receive any indication to the contrary by Friday, February 21, 2014, it will assume that the IL-TRM Version 3.0 dated February 14, 2014 reflects the consensus of the SAG, and will seek Commission approval of this consensus updated IL-TRM Version 3.0 at the Commission’s March 5, 2014 Regular Open Meeting. If an objection is received by February 21, 2014, then ICC Staff will request the Commission initiate a separate non-consensus IL-TRM Update proceeding at the Commission’s March 5, 2014 Regular Open Meeting to resolve the non-consensus IL-TRM Update issues per the process outlined in the Commission-adopted [IL-TRM Policy Document](#) and [ICC Order on Rehearing Docket No. 13-0077](#).
