INCREASED FINES EFFECTIVE JULY 1, 2022

The Illinois Commerce Commission Transportation Division administers and enforces the requirements of the following statutes and regulations.

- Illinois Commercial Transportation Law, 625 ILCS 5/18c-1101 *et seq.*, and administrative rules promulgated under that Law.
- Illinois Commercial Relocation of Trespassing Vehicles Law, 625 ILCS 5/18a-100 *et seq.*, and administrative rules promulgated under that Law, 92 III. Adm. Code 1710.10 *et seq.*
- Illinois Commercial Safety Towing Law, 625 ILCS 5/18d-101 *et seq.*, and administrative rules promulgated under that Law, 92 III. Adm. Code 1715.5 *et seq.*
- Personal Property Storage Act, 240 ILCS 10/.01 *et seq.*, and administrative rules promulgated under that Act, 92 III. Adm. Code 1458.10 *et seq.*
- Collateral Recovery Act, 225 ILCS 422/1 *et seq.*, and administrative rules promulgated under that Act, 92 III. Adm. Code 1480.10 *et seq*.

Pursuant to the Illinois Commercial Transportation Law, "[t]he Commission may assess, against any person found by it to have violated this Chapter, a civil penalty not greater than \$1,000 nor less than \$100 per violation. The penalty assessed by the Commission shall reflect the number and severity of violations found to have been committed." 625 ILCS 5/18c-1704(2). These provisions also govern the enforcement of the Illinois Commercial Relocation of Trespassing Vehicles Law, the Illinois Commercial Safety Towing Law, and the Personal Property Storage Act. 625 ILCS 5/18a-307; 92 Ill. Adm. Code 1715.600; 240 ILCS 10/20.2. Pursuant to the Collateral Recovery Act, the Commission may "fine, or take any disciplinary action that the Commission may deem proper, including fines not to exceed \$2,500 for each violation . . . of this Act or its rules . . . [or] [a]iding or abetting another in violating any provision of this Act or its rules." 225 ILCS 422/80(a).

In accordance with the foregoing statutes and rules, fines have been adjusted to levels calculated to promote prompt and sustained compliance to ensure that regulated entities operate safely. Fines for violations of the foregoing statutes and rules assessed through an administrative citation, subject to notice and hearing, are increased as follows beginning July 1, 2022.
