

## ICC Approves Highway-Rail Crossing Improvement Project Near Ellery

Springfield, IL – The Illinois Commerce Commission approved a Stipulated Agreement requiring the installation of new automatic flashing light signals, gates, and approach grade improvements at the County Road 700 North/TR 495 grade crossing near Ellery in Wayne County (AAR/DOT #724702W, railroad milepost 128.08-W).

The total estimated costs for the new automatic warning devices at the crossing are \$407,232. Staff recommended that the Grade Crossing Protection Fund (GCPF) be used to pay 95 percent of the signal installation costs, not to exceed \$386,871. Norfolk Southern will pay all remaining signal design and installation costs, and all future operating and maintenance costs related to the new automatic warning devices and temporary STOP signs.

The estimated cost to improve the roadway approach grades is \$200,000, of which GCPF funds will be used to pay 100 percent of the costs.

"Projects like the ones in Ellery are necessary to keep pedestrians and motorists safe on or near railroad tracks and trains. The GCPF makes it possible for local communities to make these much-needed upgrades," said ICC Commissioner Michael T. Carrigan.

All work is expected to be completed within 18 months of the Order date.

## ABOUT THE STATE OF ILLINOIS GRADE CROSSING PROTECTION FUND (GCPF)

In 1955, the State of Illinois passed legislation creating the GCPF. Since then, Illinois has strengthened its commitment to public highway-rail safety by increasing funding toward projects such as the closure and consolidation of existing public crossings, installation of new warning systems, highway approach improvements, upgrades to existing warning devices and interconnection to nearby traffic signals, construction/reconstruction of grade separation structures and the construction of pedestrian grade separations. The Commission administers the GCPF, which is funded by motor fuel tax money designated for rail safety improvements. The General Assembly appropriates \$42 million annually for the GCPF.
