RESOLUTION

By the Illinois Commerce Commission:

WHEREAS, Winnebago County is subject to the Illinois Commercial Relocation of Trespassing Vehicles Law (“Relocation Law”), 625 ILCS 5/18a; and

WHEREAS, Section 18a-700 of the Relocation Law provides that Cities, villages and incorporated towns in counties to which the provisions of this Chapter apply may, by resolution adopted by a majority of the members of the corporate authorities and filed with the County Clerk of such county and with the Illinois Commerce Commission, choose to be excluded from the provisions of this Chapter. 625 ILCS 5/18a-700(d); and

WHEREAS, on May 2, 2022, the City of Rockford City Council adopted a resolution, effective July 1, 2022, (Exhibit A) electing to be excluded from the application of the Relocation Law; and

WHEREAS, Section 18d-180 of the Illinois Commercial Safety Towing Law provides the Safety Towing Law applies in counties in which the Relocation Law is effective, 625 ILCS 5/18d-180; and

WHEREAS, the Safety Towing Law continues to apply in the entirety of Winnebago County; and

THEREFORE IT IS RESOLVED by the Illinois Commerce Commission, that the provisions of the Illinois Commercial Relocation of Trespassing Vehicles Law shall not be applicable in City of Rockford, effective immediately.







BE IT RESOLVED by the City Council of the City of Rockford:


