FEDERAL FUNDS - QUARTERLY REPORT

April 1, 2024 - June 30, 2024

This report is compiled from data obtained from state agencies through the Commission on Government Forecasting and Accountability's (CGFA) Federal Aid Tracking System, which was established under the authority of P.A. 80-1029 and P.A. 93-632. Information regarding all applications for (and all awards of) federal funds to Illinois state agencies are recorded in a computer database. CGFA assigns a State Application Identifier (SAI) number to each application submitted by agencies. Status of each application is tracked by CGFA staff in the amount applied for, the amount awarded, amendments, date changes, and any changes to the application or award amounts.

The data shown reflect information that was received by the CGFA for a particular quarter, and may not reflect the actual dates of the requests and/or awarded date. All funds requested with no funds awarded means that the funds awarded will come in later.

Additional information about the federal programs listed in this report can be found in "Federal Funds to State Agencies", an annual report prepared for the Illinois General Assembly by the Commission on Government Forecasting and Accountability. CFDA: This column shows the identifying number assigned to the federal program by the U.S. Office of Management and Budget in the "Catalog of Federal Domestic Assistance".

State Match Appropriated: This column indicates whether the federal funds for this program/project have been appropriated by the General Assembly in the past or, if a new application, whether the agency intends to have the funds appropriated.

Subgrant: This column indicates whether the federal funds are or will be subgranted (passed through) from the recipient agency to any other state agencies.

Trust Fund: This column indicates the number of where the recipient agency federal funds are deposited in the following State Treasury Fund.
