This afternoon, it is my pleasure to welcome to the Illinois House of Representatives the Honorable Consul General of Japan. The Honorable Jun Yanagi. Over the course of his distinguished career, Consul General Yanagi has taught law, international relations, and economics. He has traveled the world as a diplomat, leading Japan's missions in Nigeria, Australia, Russia, Canada, Vietnam, and Vienna before coming to Illinois in 2023. I am particularly grateful for Majority Leader Robyn Gabel's work to bring Consul General Yanagi to join us today. Illinois' bonds with Japan drive our economy and enrich our culture in so many ways. So, I am extremely pleased to further those bonds today by welcoming the Honorable Consul General Yanagi to our House chamber. Members, please put your hands together

and give a warm welcome for the Honorable Consul General from Japan."

Consul General Yanagi: "Speaker Welch, Minority Leader McCombie, esteemed Members of the Illinois House of Representatives, let me express my deepest gratitude for the privilege of addressing you here in the capital of the great State of Illinois, crossroads of a nation, Land of Lincoln. Today, at this historical turning point as international order has been challenged, Japanese Prime Minister Fumio Kishida is making an official visit to the United States. Tomorrow, he will address a joint meeting of the U.S. Congress in Washington, D.C. At such a significant moment, I am honored to underscore the enduring significance of the alliance, mutual trust, and deep friendship between the United States and Japan. Serving 10 Midwestern states, I have had the privilege to meet many wonderful people across the region from diverse backgrounds. I have been consistently heartened by the strong bipartisan support for the U.S.-Japan alliance. Japan's robust relations with the United States as a close ally have been nurtured and endured over decades, testifying to their strengths. Today, complex geopolitical challenges and economic uncertainties: Russia's aggression in Ukraine, the situation in Israel and Gaza, and security concerns in East Asia. In a globally integrated world, these international turbulences affect economic and social life here in Illinois. In response to these geopolitical challenges, Japan has bolstered its national security architecture and has been fundamentally reinforcing its defense capabilities and committed to doubling its defense budget to two percent of GDP by 2027.

Japan has also intensified its diplomatic efforts in forging a broader network of partners around the world, including G7 presidency throughout the last year, Quad U.S.-Japan-India-Australia, trilateral partnership among U.S.-Japan-Republic of Korea, and Global South countries. In response to economic uncertainties, the United States and Japan are taking the lead in upholding rule-based economic order throughout the Indo-Pacific Economic Partnership, IPEF. The United States and Japan are also intensifying our cooperation in economic security, not to completely decouple us from China, but derisk, de-risk our vital economic interests. Today, against these backdrops, Japanese Prime Minister Fumio Kishida holds a summit meeting with President Biden and attends the State Dinner, demonstrating the strong friendship and trust between the two leaders. This visit demonstrates to the world that the United States and Japan stand united, stand united as global partners in upholding and bolstering the free and open international order, based on the rule of law, in a time when such an order is being challenged at an unprecedented level. The visit also reconfirms that the United States and Japan are now indispensable partners for one another in leading sustainable and inclusive global economic growth, maintaining competitiveness in advanced technologies and by overcoming the vulnerability of supply chains. For this, the two leaders will chart the course of cooperation in advanced technologies, such as outer space, AI, semiconductors, quantum, clean energy, 5G. In short, the U.S. and Japan have become truly, truly global partners, beyond regional sphere, indispensable to the peace, stability, and prosperity of the

international community as a whole, not only for us, but for our children and our children's children. Beneath this robust global partnership lies KIZUNA, the strong bond of trust and friendship that unites our two peoples. In Illinois, over 15 thousand Japanese nationals live in harmony with their local communities. Illinois and Japan have established nine sister-city relationships. Among them, Chicago and Osaka celebrated its anniversary last year. Turning to the business partnership, Japan has been the world number one investor to the United States for four consecutive years, creating one million U.S. jobs. In Illinois alone, 650 Japanese business facilities provide 44 thousand U.S. jobs. One of them is J-Power USA, an electric company which owns two large power stations, ensuring efficient, cost-effective generation and reliable power supply to all sectors across the state. Japanese companies that invest in the United States and Illinois have been making efforts to coexist and prosper with local communities as good corporate citizens. They are supported by the local governments and admired by residents and local workers. Today... sorry. All of these, all of these are the foundation of our strong global partnership. At home, been transforming socioeconomic structural Japan challenges, like climate change, energy, and demographic changes, into opportunities for economic growth. To advance cutting-edge fields, Japan has been intensifying publicprivate investment and attracting oversea investors. Japan

can see the beginning of the end of three decades of economic stagnation and deflation. Its economic indicators show this: the highest nominal GDP growth rate among major developed countries, record-high domestic investment, highest wage gains in 30 years, and record-high stock prices. Indeed, Japan is back on the U.S. radar. A lot of Japanese content have been widely accepted here in the United States, including anime, manga, sushi, sake, sport stars like Seiya Suzuki and Shota Imanaga of the Chicago Cubs. Japanese companies are also reliable business partners of your most trusted allies. Japan's strong economy makes it an attractive destination for U.S. investment. Japan's competitiveness in cutting-edge technology offers opportunities new for U.S.-Japan collaboration. In addition, the strong U.S. dollar against the Japanese yen makes Japan even more attractive than ever as a tourist destination. 2024 has been designated as U.S.-Japan tourism year. The 2024 Osaka-Kansai Expo is also coming soon. I encourage all of you to take these opportunities to visit Japan. In closing, I remain optimistic about the future of U.S.-Japan global partnership. It is because we share the same basic values of democracy, freedom, human rights, and rule of law. It is because our partnership has been built from the ground up, supported by multiple layers of human connections and a wide range of groups in the society of both nations. Any bilateral relationship ultimately hinge on human connections. The Japan-U.S. relationship is no exception. Thank you so much, once again, for giving me this opportunity to address this esteemed audience. Thank you so much indeed."

And so, I'm very excited to have them here with us today. So, welcome to the ED-RED team. And also, I'd like to acknowledge the team sitting with me here today, which is my family. My daughter, Sarah Muhl, who is off for today. It's SAT day at her high school. So, the sophomores got to take a field trip, and hers was here today. My parents, Abe and Kate Katz, are also with me in the chamber. Thank you to everybody who has welcomed them. Thank you, Leader."

West: "Thank you, Mr. Speaker. Point of personal privilege."

West: "I just want to introduce my Honorary Pages on today. I have two Pages with me. I have Isaiah Shelton with me, and I have Candance Neely. They are both the son and bonus son of my good friend and predecessor, who we all know, the honorable Dr. Litesa Wallace is on the Democratic side of the aisle. And for those of you who have got the chance to meet them, I asked you to provide words of wisdom. So, I asked them what has resonated so far. And Isaiah to my right said that don't

And then Candance told me that what resonated with him is having a clear conscience and someone to trust is important in every line of work and to stay open and true to yourself. These are 20-year-old gentlemen who have their whole life ahead of them. If you have words of wisdom, no matter... on both sides of the aisle, if you have words of wisdom, come see us 'cause we want to hear from you. Thank you so much, Mr. Speaker."

Speaker Evans: "Under the Order of Resolutions, we have House Resolution 453, Representative Ammons is recognized."

"Thank you, Mr. Speaker. I rise to present House Resolution 453. House Resolution 453 is the first of its kind in the United States, where we have paired research capability and genealogy with higher education and research for the descendants of those who are descendants of the enslaved. And I wanted to present the Resolution not by reading the entirety of the Resolution, but the words of those researchers and doctors who have helped us to get to this point. I want to start with Dr. David, who is the principal investigator for House Resolution 453. And pulling from her comments in committee, Dr. David said the following words, she said, 'Extended family members'... Mr. Speaker, if we can have a little quiet in the chamber. This is quite difficult to do. The importance of this Resolution certainly goes beyond me as an individual African descendant of those who were enslaved. It will live beyond me and all of us in this chamber. But the importance of the Resolution, about 10 years ago, I could not do this Resolution. I could not connect my family genealogy beyond my grandmother and just her mother. But because of

technology and the research of people like Dr. LaKisha David at the University of Illinois at Urbana-Champaign, we will be able to do just that. And I want to read her words about the importance of this Resolution. Dr. David presented committee, and she said, 'House Resolution 453 facilitates this reparative work by appointing my research team to provide these genetic genealogy services for residents of the State of Illinois. I will compare the DNA profiles of those who participate in this pilot program to reference individuals to their basic African relatedness, information that was separated during the transatlantic trafficking period. Many African Americans in the United States have been unable to find their ethnic homes because of the transatlantic slave period. But because of technology, we can answer that question today, and I'm a descendant of those who have asked for the question to be answered.' We also heard from the head of the Department of Anthropology at Urbana-Champaign, and I want to bring her words to the floor. She said, 'The Department of Anthropology fully supports Dr. LaKisha David's cutting-edge research and use of genetic genealogy in restoring family narratives following the transatlantic trafficking period. Dr. David's innovative approach combines both biological and social cultural anthropology, and she speaks directly to the psychological and social significance of her research.' The purpose of this pilot in this Resolution is to work with the department and university of our land-grant university to engage in scientific research for the benefit of society. Number two, through its public engagement and research, collaborate with other researchers to provide African

Americans in Illinois a connection to their ethnic home and all of their generations between the transatlantic period of 1619 up and to this period, and we can go back 11 generations to do that. And finally, the importance of this pilot came home to me. My family, and many of our members in this chamber, took a trip to Ghana in January of 2023 as an official delegation. Many of us have never stepped foot on the African continent until that point. That was a turning point for me as a descendant. I realized, by walking through the slave dungeons at that time, that reclaiming our history, healing our understanding, preserving our cultural heritage, documenting our contributions, and empowering our community are part and parcel to correcting the wrongs of the past. I want to take a moment, Mr. Speaker, and thank our caucus, the Legislators of the Black Caucus, who have stood in the gap for African Americans in this state and across this country. And this will live beyond all of our service. So, I want to take a moment and thank a few other doctors that we know. I want to thank Dr. Ron Daniels, who's been doing this work for over 40 years in Chicago and leading the nation in this work. I want to thank Kamm Howard, who's a member and former director of N'COBRA. I want to thank Siphiwe Baleka of Guinea-Bissau, but originally from Illinois, who established the Balanta B'urassa Society of Genealogy and Research from Yale University. I want to thank again Dr. LaKisha David and Dr. Jeff Trask, who have been working on this for a number of years and have coalesced around finding the genealogy of Illinois residents. And lastly, I wanted to thank Dr. Brenda Farnell of the anthropology department, the head of the

Department of Anthropology at the University of Illinois at Urbana-Champaign, who stood behind us from the very beginning as we began to research this pilot. This pilot would be available for up to 900 African Americans in Illinois, once it is launched, to enter into the pool to establish not only their genealogy, but also their ethnic home. I have learned that I am from Nigeria of the Esan people of the Igbo Kingdom. And the Igbo Kingdom is important to us because many of the artifacts that you see in our Field Museum in the Museum of Science and Industry come from the Nigerian kingdom from the Oba, the king of Nigeria. With that, I ask for the passage of House Bill... I mean, I'm sorry, House Resolution 453. Thank you very much, Mr. Speaker."

"Back in 2021, the Cary-Grove Trojans and the East St. Louis Flyers produced an instant classic in Illinois high school 6A football, where Cary-Grove walked away with a onepoint victory. In November of this past year, I had the privilege of sitting in the stadium at Illinois State University to watch a rematch of these two fine teams. And I think it might have topped the 2021 game. Cary-Grove overcame a 5-point 4th quarter deficit with a 19-play drive that covered 71 yards and took 10 minutes and 41 seconds off the clock. Bears fans, take note. Ending with a touchdown and 2point conversion by Logan Abrams with 1 minute and 19 seconds remaining, and the game was sealed with an intercepted pass with 52 seconds to go. In the end, it was Cary-Grove's triple option offense that made the difference. The Trojans racked up 199 yards on the ground on 54 rushing attempts, an average of 3.7 yards per carry, and were led by 87 yards and 2 touchdowns from Abrams, while Peyton Seaburg, the quarterback, threw one pass for a touchdown. Fifty-four running plays, one pass. Somewhere, Woody Hayes is smiling. Cary-Grove won the game 23 to 20 on those last-minute plays. I offer up House Resolution 644 today to congratulate the Cary-Grove Trojans on their second state title, 6A title in the past three years. This is a very, very good football team, and they beat a very, very good football team in East St. Louis. Sorry, Kevin. Today, we have with us in the Speaker's Gallery Brad Seaburg, the head coach of the Cary-Grove team; Dean Schlueter, the assistant coach; Ryan Ludwig, the

athletic director; and Brady Seaburg, who is a senior member of the team. The rest of the team today, many of them are taking the SAT and all that and couldn't attend. You might want to try it. The people up in the stands, we were very nervous with about a minute and 20 seconds to go in that game. So, I'd like to offer up House Resolution 644 to commemorate and congratulate the Cary-Grove Trojans for their 2023 6A state championship. Congratulations, guys."

A moment when young girls are finally seeing idols that look like them. Idols that people across the board, men and women, are being championed and respected for what they're doing. And I don't think you could pick a better representative for this moment than Kate Martin. It's not just that Kate's the first Iowa women's basketball player to have amassed over 900 points, over 500 rebounds, over 400 assists, over 120 steals, over 60 blocks, there's just so much more to Kate than that. I want to share the words of just a couple of her old high school teammates. 'She's never going to be outworked, and she always accepts her role. Even in high school basketball days, I don't remember how many points any of us scored, but I remember how good of a teammate she was and how hard she worked and how fun she was to be around.' Another teammate, 'She cares about everyone else and their success. There was never any animosity or jealousy. She wants what's best for her teammates, even over herself sometimes. From a team aspect, you need that type of person on the team who's able to bring everyone together, be friends with everyone, is able to communicate and give feedback.' Her old high school coach, Lori Blade, when she found out that Kate was named the seventh most impactful player by ESPN, her response was not surprised because of the work ethic she's always had. She's a grinder

and one that doesn't back down. But I think especially it came from her Iowa coach, Lisa Bluder, who nicknamed her 'the Glue' during a 2023 press conference. She got to the essence of Kate when asked about Kate having to leave the floor during a game against UConn after taking an elbow to the nose. 'Kate Martin, what a warrior. That poor kid has broken her nose I think every single year she's been at Iowa. She's a leader. She's the heart and soul of our team.' And, Kate, I just want to tell you that, for especially over the past few weeks and really for the past few years, you've been the heart and soul of the Edwardsville community. Your former coaches, teachers, and old friends have been traveling hours to watch you play. People who you've probably never met are actually gathering at local restaurants for watch parties. It tells you something when a local bar will switch the channel from a Blues game or a Cardinals game to put on a women's basketball game. It's all... it all is to cheer you on, and it all goes beyond basketball. I think Kate said it the best herself during a press conference after that heartbreaking loss at that final game of her career. 'Honestly, I just hope we've brought a lot of people joy and we've brought a lot of people together.' And I can tell you, Kate, you certainly have, and we really thank you for it. So, if we could give a round of applause to the wonderful Kate Martin of Edwardsville, I would appreciate it."

You know, Clayton is here today. And he's someone who radiates positivity and kindness. I also want to thank his wife, his children, and everyone who loves him for sharing him with us for so many years. Members, Lee was diagnosed with pancreatic cancer in 2019 and he recently learned that it's sadly returned. But if you know one thing for certain, you've got an entire chamber, Lee, that's full of prayers and love behind you each and every day. We love you, we care for you, and you will constantly be in our prayers. We are all better people for having known you being around this Capitol, and this entire state is better because of your work and service. You are a true gift, and we are so grateful for you. I'd like to ask the Members to give you another round of applause, please. Before... before the Honorable Leader McCombie speaks, I've also been asked to let everyone know there will be a reception for Lee down in the basement press office beginning at 1:30 today. I don't know if you can fit us all down there, but we'll try. All are welcome and encouraged to join us to celebrate our friend, Lee Milner.

The most recent study on the lifetime cost of autism was done 10 years ago. According to that study, a lifetime cost of autism averaged 1.4 million to 2.4 million. Now, this cost of lifetime care can be reduced by two-thirds with early diagnosis and intervention. That's lesson two to help educate, inform, and grow your understanding, and I want to end every lesson with 'I love somebody with autism.' Thank you for listening."
