PRESENTATION OF RESOLUTIONS

Senator Johnson offered the following Senate Resolution, which was referred to the Committee on Assignments:

SENATE RESOLUTION NO. 18

WHEREAS, The substance use and opioid use crises in Illinois are responsible for historically high rates of overdoses and overdose-related fatalities; and

WHEREAS, According to the State's own opioid data, use and misuse of opioids in Illinois also continues to have substantial associated public health consequences, including increased rates of infectious diseases such as hepatitis C and HIV, lost productivity in the workplace, crime, neonatal abstinence syndrome, and homelessness; and

WHEREAS, The purpose of many federal programs is to provide resources to states for increasing access to FDA-approved medications for the treatment of substance use and opioid use disorder and for supporting the continuum of prevention, harm reduction, treatment, and recovery support services for opioid use disorder and other substance use disorders; and

WHEREAS, A prescription digital therapeutic is approved, cleared, or classified by the Food and Drug Administration under section 510(k), 513(f), or 515 of the Federal Food, Drug, and Cosmetic Act, and requires a prescription under section 801.109 of title 21 of the Code of Federal Regulations (or any successor regulation); and

WHEREAS, Prescription digital therapeutics have the potential to significantly improve health care delivery to underserved populations because they transcend care access limitations due to geography, socioeconomic status, trust of traditional institutions, and more; and

WHEREAS, Clinical studies have shown significantly greater odds of stimulant and opioid abstinence during treatment if treatment as usual is combined with an FDA-authorized PDT that has both cognitive behavioral therapy and contingency management; and

WHEREAS, A 2018 study demonstrated that when a Community Reinforcement Approach and Contingency Management are administered together then a patient is 2.84 times more likely to remain abstinent at the end of the treatment than those in other programs; and

WHEREAS, The White House's Office of National Drug Control Policy recently released its 2022 National Drug Control Strategy document; specifically, the document points to prescription digital therapeutics and how these tools could help increase services for a wide array of patients; and

WHEREAS, Federally-funded programs help many states to fund access to FDA-authorized PDTs for patients and providers; therefore, be it

RESOLVED, BY THE SENATE OF THE ONE HUNDRED THIRD GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we urge the Department of Human Services and the Governor's Opioid Overdose Prevention and Recovery Steering Committee to closely consider funding FDA-authorized PDTs to help patients who are struggling with substance use and opioid use disorders; and be it further

RESOLVED, That a suitable copy of this resolution be delivered to the Secretary of the Illinois Department of Human Services.

Senator Johnson offered the following Senate Resolution, which was referred to the Committee on Assignments:

SENATE RESOLUTION NO. 19

WHEREAS, Pancreatic cancer is the third leading cause of cancer-related deaths in the U.S. and is projected to be the second leading cause of cancer-related deaths by 2030; and

WHEREAS, Pancreatic cancer is one of the deadliest cancers and has the lowest five-year survival rate at just 10%; and

WHEREAS, In 2023, an estimated 60,430 U.S. residents will be diagnosed with pancreatic cancer, and more than 48,220 will die from the disease; and

WHEREAS, Due to increased awareness, pancreatic cancer survival rates have been improving; however, the disease is still considered largely incurable; with all stages of pancreatic cancer combined, the one-year relative survival rate is 20% and the five-year rate is 9%; and

WHEREAS, The problem is that high-risk people are not being screened in the early and potentially curable stages of pancreatic cancer; and

WHEREAS, Risk factors can include chronic or hereditary pancreatitis, obesity, regular consumption of high dietary fats, alcohol abuse, smoking, family history, age, and long-standing diabetes; and

WHEREAS, Symptoms can include abdominal pain, mid-to-upper back pain, weight loss, jaundice that is yellowing of the skin and eyes, nausea, loss of appetite, changes in stool, and new-onset diabetes; and

WHEREAS, Early screening will save lives; therefore, be it

RESOLVED, BY THE SENATE OF THE ONE HUNDRED THIRD GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we declare the month of November 2023 as Pancreatic Cancer Awareness Month in the State of Illinois; and be it further

RESOLVED, That suitable copies of this resolution be presented to the Pancreatic Cancer Action Network (PanCAN), the American Cancer Society, and Dr. Paul Grippo of the University of Illinois at Chicago with our sincere appreciation for their efforts to address pancreatic cancer.

Senator Villa offered the following Senate Resolution, which was referred to the Committee on Assignments:

SENATE RESOLUTION NO. 22

WHEREAS, Social workers enter the profession because they have a strong desire to help empower individuals, families, communities, and our nation to overcome issues that prevent them from reaching their full potential; and

WHEREAS, Social workers have worked for more than a century to improve human well-being and enhance the basic needs of all people; and

WHEREAS, Social workers follow a code of ethics that calls on them to fight social injustice and to respect the dignity and worth of all people; and

WHEREAS, Social workers positively touch the lives of millions of Americans each day and in a variety of settings, including schools, hospitals, the military, child welfare agencies, small private practices, community centers, and in federal, state, and local government; and

WHEREAS, The 2023 Social Work Month theme is Social Work Breaks Barriers, embodying how social workers help empower individuals, families, communities, and our society to overcome hurdles that prevent them from achieving better well-being; and

WHEREAS, Social workers are the largest group of mental health care providers in the United States; they work daily to help thousands of Americans overcome mental illnesses such as depression and anxiety; and

WHEREAS, Social workers are on the front lines of the nation's opioid addiction crisis by helping people get the treatment they need and to prevail over substance use disorders; and

WHEREAS, Social workers help people cope with death and grief and help people and communities recover from natural disasters that are increasingly fueled by our warming climate, including hurricanes, drought, and flooding; and

WHEREAS, Social workers have helped this nation live up to its values by advocating for equal rights for all, including people of color, people who are Indigenous, people who are LBGQTIA2S+, or people who follow various faiths; and

WHEREAS, The social work profession is one of the fastest growing careers in the United States, with more than 60,000 more social workers expected to enter the profession over the next decade; currently, there are over 22,000 social workers in Illinois and about 708,000 social workers nationwide; and

WHEREAS, Social workers have continued to push for changes that have made our society a better place to live, including a livable wage, improved workplace safety, and social safety net programs that help ameliorate poverty, hunger, and homelessness; and

WHEREAS, Social workers endeavor to work throughout our society to meet people where they are and to help empower people and our society to reach the goals they wish to attain; therefore, be it

RESOLVED, BY THE SENATE OF THE ONE HUNDRED THIRD GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we declare the month of March 2023 as Social Work Month in the State of Illinois; and be it further

RESOLVED, That a suitable copy of this resolution be presented to the National Association of Social Workers-Illinois Chapter with our sincere appreciation for their efforts.

Senator Fine offered the following Senate Resolution, which was referred to the Committee on Assignments:

SENATE RESOLUTION NO. 23

WHEREAS, On November 29, 1947, the General Assembly of the United Nations voted to partition British Mandatory Palestine into a Jewish state and an Arab state; this was a compromise embraced by leadership of the nascent Jewish state; and

WHEREAS, On May 14, 1948, the people of Israel proclaimed the establishment of the independent State of Israel; 11 minutes later, President Truman, on behalf of the United States, became the first world leader to recognize Israel's provisional government as the legitimate authority in the area allotted to it; and

WHEREAS, The uninterrupted dream of the Jewish people to reestablish their independent state was directly linked to their historic sovereignty in the Land of Israel; this was first established 3,000 years ago with the city of Jerusalem as its capital then as it is now; and

WHEREAS, For over 2,000 years, Jews living in other parts of the world maintained a profound spiritual and emotional connection to the Land of Israel, and there has been a continuous Jewish presence in the land comprising the modern State of Israel; and

WHEREAS, The State of Israel provided a refuge to Jews who survived the destruction of much of the European Jewry during the Holocaust; and

WHEREAS, Israel has provided the opportunity for millions of Jews from all over the world, including immigrants fleeing antisemitism and oppression from such countries as Ethiopia, the former Soviet Union, Argentina, Syria, Morocco, Iraq, Iran, India, other parts of the Middle East, North Africa, South America, and Asia, to make new lives in their ancient homeland; and

WHEREAS, Since its establishment 75 years ago, the modern State of Israel has rebuilt the nation, forged a new and dynamic society, and created a thriving economic, political, cultural, and intellectual life despite the heavy burdens of war and terrorism; and

WHEREAS, The people of Israel, in the spirit of Israel's Declaration of Independence, have established a vibrant, pluralistic, democratic political system which includes freedom of speech, association, and religion, a vigorously free press, free, fair, and open elections, the rule of law, a fully independent judiciary, rights for the LGBTQ+ community, and other democratic principles and practices; and

WHEREAS, Israel has developed some of the world's leading universities and hospitals, some of which are partnering with Illinois-based institutions in Chicago and elsewhere; and

WHEREAS, Israel has developed an advanced, entrepreneurial economy, has one of the world's leading technological industries, and is at the forefront of research and development in the fields of renewable energy sources and medicine; and

WHEREAS, Israel regularly sends humanitarian aid, search and rescue teams, mobile hospitals, and other emergency supplies to help victims of disasters around the world, including setting up field hospitals and sending personnel and supplies to Ukraine, Haiti, Japan, Nepal, and Surfside, Florida; and

WHEREAS, Israel has courageously defended itself from repeated attacks since its independence while never losing sight of the determination to live in peace with all of its neighbors; and

WHEREAS, Thanks to the Abraham Accords, Israel has been able to expand its peaceful relations across the Middle East from not only Egypt and Jordan to now include the United Arab Emirates, Morocco, Bahrain, and Sudan; and

WHEREAS, Since the founding of the modern State of Israel, the United States, Illinois, and Israel have maintained a special relationship based on mutually shared democratic and moral values, common strategic interests, and bonds of friendship and mutual respect; and

WHEREAS, The United States and Illinois continue to regard Israel as a trusted ally and vital strategic partner in the Middle East; therefore, be it

RESOLVED, BY THE SENATE OF THE ONE HUNDRED THIRD GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we recognize and applaud the historic significance of the 75th anniversary of the establishment of the sovereign and independent State of Israel as a homeland for the Jewish people; and be it further

RESOLVED, That we reaffirm the bonds of friendship and cooperation which have existed between the United States, Illinois, and Israel for the past 75 years and commit to strengthening these bonds; and be it further

RESOLVED, That we commend the people of Israel for their remarkable achievements in building a new state and a pluralistic, democratic society in the face of terrorism as well as hostility, ostracism, and belligerence from many of their neighbors; and be it further

RESOLVED, That we reaffirm our support for Israel's right to defend itself against threats to its security and existence; and be it further

RESOLVED, That we reaffirm our enduring support for Israel as the country pursues peace with its neighbors; and be it further

RESOLVED, That we extend our best wishes to the State of Israel and its people for a peaceful and prosperous future.

Senator Stoller offered the following Senate Resolution, which was referred to the Committee on Assignments:

SENATE RESOLUTION NO. 24

WHEREAS, The Underground Railroad was a network of people offering shelter and aid to escaped enslaved people from the South; and

WHEREAS, Most of the enslaved people helped by the Underground Railroad escaped border states such as Kentucky, Virginia, and Maryland; and

WHEREAS, Hiding places included private homes, churches, and schoolhouses; and

WHEREAS, A former station on the Underground Railroad, the Lovejoy Homestead, is located at the eastern edge of Princeton and was the home of the Denham and Lovejoy families for nearly 100 years; and

WHEREAS, Reverend Lovejoy was its most famous resident and occupied the house from 1838 until his death in 1864; he was prominent in the abolition movement and the Underground Railroad, a founder of the Illinois and national Republican Party, and a congressional leader; and

WHEREAS, Reverend Lovejoy is perhaps best known for his role in the Underground Railroad; as an outspoken abolitionist, he openly proclaimed his willingness to assist fugitive slaves; his involvement made his house one of the most important stations on the Underground Railroad in Illinois; and

WHEREAS, The Owen Lovejoy Home now belongs to the City of Princeton and was opened as a museum in 1972; the United States Secretary of the Interior declared the property a National Historic Landmark in 1997; therefore, be it

RESOLVED, BY THE SENATE OF THE ONE HUNDRED THIRD GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we urge the Illinois Department of Transportation to place road signs in the vicinity of the Owen LoveJoy Homestead directing people to this National Historic Landmark; and be it further

RESOLVED, That a suitable copy of this resolution be delivered to the Illinois Department of Transportation.

Senator Tracy offered the following Senate Joint Resolution, which was referred to the Committee on Assignments:

SENATE JOINT RESOLUTION NO. 6

WHEREAS, 529 college savings plans are important tools for Illinois families who want to save for their children's college education; they offer a diverse range of investment options, tax-deferred growth, and withdrawals free of state and federal taxes when those withdrawals are used for qualified higher education expenses such as tuition, fees, books, certain room and board costs, computer equipment, and required supplies; and

WHEREAS, While the first college savings plans were developed by states in 1988 as innovative programs designed to help families and students save for higher education expenses, it was not until the enactment of Section 529 of the Internal Revenue Code by Congress in 1996 that college savings plans began to rapidly gain popularity across the country; and

WHEREAS, Today, all 50 states and the District of Columbia offer 529 college savings plans; 12.5 million 529 accounts have been opened, more than \$253 billion dollars have been saved for future higher education expenses, and more than one million students nationwide have withdrawn funds from 529 accounts to help pay higher education expenses; and

WHEREAS, The Illinois Treasurer currently offers and administers two 529 college savings plans, the Bright Start College Savings Plan and the Bright Directions College Savings Plan; and

WHEREAS, In 2018, Morningstar, which independently evaluates and rates college savings plans, selected the Bright Start 529 College Savings Plan as a Gold-Rated 529 and granted the Bright Directions Advisor-Guided 529 College Savings Plan a silver rating, which was the highest rating for all advisor-sold plans; and

WHEREAS, 529 college savings plans allow families to save for tuition at two-year and four-year institutions, including vocational, trade, community, state, or technical schools; and

WHEREAS, Illinois residents can claim a state tax deduction on contributions of up to \$10,000 a year (\$20,000 for married couples filing jointly) to any state plan; and

WHEREAS, In 2000, the average tuition rate at an Illinois public university was \$4,160, while the average rate at a private four-year institution was \$15,625; in 2018, those rates skyrocketed to \$15,182 for public universities and \$36,747 for private universities; and

WHEREAS, Federal financial aid awards have shifted away from student grants and moved to providing access to guaranteed student loans so that, today, nearly 63 percent of all federal financial aid is in the form of loans, substantially increasing the number of college graduates who will face the burden of repaying significant student loan debt upon entering the workforce; and

WHEREAS, As of 2018, student loan debt had reached \$1.5 trillion nationally, which rose from \$548 billion in 2007, and more than 1.6 million Illinois residents had student loans totaling more than \$52 billion; and

WHEREAS, When Illinoisans are burdened with student loan debt, they are not able to buy homes, cars, and other products that boost our economy; and

WHEREAS, College savings plans, such as Bright Start and Bright Directions, help families limit or eliminate future student loan debt by helping them save for future higher education expenses; and

WHEREAS, The contributions families make today pay off in the form of an increased earning potential for their children in the future, with a college graduate earning an average of \$1 million more than a high school graduate during his or her career, according to the United States Census Bureau; and

WHEREAS, May 29th is recognized nationally as 529 College Savings Day to help raise awareness across the country of the importance of saving for college with the help of 529 college savings plans; therefore, be it

RESOLVED, BY THE SENATE OF THE ONE HUNDRED THIRD GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, THE HOUSE OF REPRESENTATIVES CONCURRING HEREIN, that we declare May 29, 2023 as 529 College Savings Day in the State of Illinois; and be it further

RESOLVED, That we urge all Illinoisans to explore the benefits that 529 college savings plans offer families; and be it further
