

(in the same location) that conforms to the design previously approved by the Air Park – Dallas Zoning Committee in resolutions reflected in the minutes of the Zoning Committee dated April 13, 2007, and September 25, 2008, and in accordance with the terms of those resolutions.

All claims and causes of action that have been or could have been brought in this case by any party against any other opposing party are hereby DISMISSED with prejudice.

This shall constitute final judgment in this matter. All parties shall bear their own attorneys' fees and costs of court. The Court shall retain jurisdiction for the duration of this Order to enforce the terms of the Order.
