**NOTICE OF TERMINATION OF SETTLEMENT AGREEMENT  
AND JOINT REQUEST TO CLOSE CASE**

On October 21, 2010, upon the parties’ joint request, the Court administratively closed this case [doc. no. 175] while the parties implemented their Settlement Agreement [doc. no. 7-2]. Plaintiff and Defendants hereby jointly notify the Court that the Settlement Agreement terminated, by its terms, on January 15, 2014.

Section IV.E of the Agreement provides that “[t]he Agreement shall terminate five years from the Effective Date.” This section contemplates that the State will attain substantial compliance prior to termination. With the exception of the discharge and transition planning provisions in Section III.F.1, 3, 4, and 5d of the Settlement Agreement, the parties agree that the State has attained substantial compliance. The parties further agree that the discharge and transition planning provisions contained in Section III.F.1, 3, 4, and 5d of the Settlement Agreement in

this case are subsumed within Section III.D of the 2010 Settlement Agreement entered in the related case, Civil Action No. 1:10-CV-249 [*see* doc. no. 112].

The parties also agree that effective implementation of the discharge and transition planning terms are essential to compliance with the 2010 Settlement Agreement and will be subject to the Court's jurisdiction and enforcement, if necessary, in Civil Action No. 1:10-CV-249.

There is no further need for the Court to retain jurisdiction for purposes of enforcing the now-terminated Settlement Agreement in this case. Accordingly, the parties respectfully ask the Court to close this case permanently.
