## LOUISIANA BOARD OF MASSAGE THERAPY

IN THE MATTER OF

THE APPLICATION FOR ESTABLISHMENT LICENSE OF

SLIDELL SUNSHINE, INC.

## CONSENT AGREEMENT AND ORDER

WHEREAS, SLIDELL SUNSHINE, INC. ("SLIDELL SUNSHINE") submitted a Louisiana Application for Establishment License to the Louisiana Board of Massage Therapy ("LBMT") on or about October 26, 2023, and is subject to the jurisdiction and rules and regulations of the LBMT;

WHEREAS, JING WANG is listed as the owner of Slidell Massage on its LBMT license application;

WHEREAS, at the November 3, 2023, meeting of the LBMT, an application for licensure submitted by Yun Lin for Serenity Massage, located at the same address as Slidell Sunshine, was denied because it was identified on a number of illicit websites. The LBMT found advertisements for illicit services on "Call Escort Girls", "Scarlet Amour", "Rubs Guide", "Rub Maps", "Adult Look", "Sumo Search", "Adult Search", "Bed Page", "Skip the Games", "Google Ads" and "Eccie". The advertisements include scantily-clad Asian women described as "new girl", "bust size 36dd, sexy, cute, petite", "hot Asian baby", "Juicy Wet", "Young and beautiful Asian girls", "new sweet girl", "romantic" "hot sensual pretty Asian with like no other", "New Face, New Feeling, and Different Experience", "young & sexy", "If you like Asian girls giving you massage or anything else you want", "they're all young, beautiful, sexy girls", "GFE", "BBFS", "wet Asian pussy" "BBBJ", "DATY", "I like all positions with you", "SuckingLicking", "open minded",

"69", "kiss lick", "NuruMassage Body to Body", "a great time with a sexy hottie, I'm sure you will enjoy my flawless body", "if you come new Asian girl makes you Cum", "Shower together", "Unique girls for you to choose from", "all new, beautiful, sexy girls". Also included was a review on "ECCIE" regarding CFS, CBJ, k9, standing mish, acronyms referring to sexual conduct.

WHEREAS, on October 10, 2023, pursuant to inspection of Rose Massage, Jing Wang, as owner of Rose Massage, was issued a Cease-and-Desist Notice for operating an establishment without a massage therapy license and for personally providing massage therapy services without holding a license as a massage therapist in the State of Louisiana. Elizabeth Blackburn, listed as massage therapist for Serenity Massage and in the Application for Establishment License for Slidell Sunshine, was also issued a Cease-and-Desist for providing massage therapy services at an unlicensed establishment (Rose Massage).

WHEREAS, the previous owner of Serenity Massage, Yun Lin, has submitted a Louisiana Application for Establishment License for Rose Massage, the establishment for which Jing Yang was issued the Cease-and-Desist Notices. Jing Wang's application for Slidell Sunshine and Yun Lin's application for Rose Massage both contain the same establishment license phone number – 985-318-7052.

WHEREAS, by correspondence dated December 19, 2023, James R. Raines, LBMT Complaint Counsel, notified Jing Wang of the LBMT's intent to deny the Application for Establishment License for Slidell Sunshine.

WHEREAS, Jing Wang, as owner of Slidell Sunshine, has indicated her desire to resolve this matter through a Consent Agreement and Order provided for in LAC 46:XLIV §5901 and La. R.S. 49:955(D) of the Louisiana Administrative Procedure Act;

WHEREAS, Jing Wang has admitted to the following:

- 1. Jing Wang is and was at all times pertinent to the facts and matters alleged herein the owner of Slidell Sunshine.
- 2. Slidell Sunshine previously operated under the name "Serenity Massage," which was owned by another individual.
- 3. Jing Wang admits the telephone number with Serenity Massage was used in advertisements on the above-referenced websites. However, she asserts that all advertisements related to the telephone number associated with Serenity Massage have been removed from all illicit websites.
- 4. Jing Wang, as owner of Rose's Massage, was issued a Cease-and-Desist Notice for operating an establishment without a massage therapy license and for personally providing massage therapy services without holding a license as a massage therapist in the State of Louisiana.
- 5. Jing Wang admits that the above actions are in violation of the following rules and regulations of the LBMT: La. R.S. 37:3558; La. R.S. 37:3563; and LAC 46:XLIV §35301.

WHEREAS, Jing Wang and Slidell Sunshine recognize their right to have an administrative adjudication of the charges outlines in the Notice of Intent to Deny, at which time Jing Wang and Slidell Sunshine would be entitled to be represented by legal counsel, to call witnesses, and to present witnesses on their behalf in defense or in mitigation of the charges made, and to a decision thereon by the Board based upon written findings of fact and conclusions of law in accordance with the Louisiana Administrative Procedure Act. Jing Wang and Slidell Sunshine nonetheless waive their right to formal adjudication and, pursuant to La. R.S. 49:975(D), consent to the entry of the Consent Agreement and Order set forth hereinafter. Jing Wang and Slidell

Sunshine also acknowledge that they waive any rights to which they may be entitled pursuant to the Louisiana Administrative Procedure Act, La R.S. 49:951, et. seq., or which they otherwise may be afforded by any law, to contest their agreement to, or the force and effect of this Consent Agreement and Order, in any Court or other forum.

IT IS HEREBY ORDERED that in consideration of the foregoing and pursuant to the authority vested in the Board by La R.S. 49:975(D), the Board orders and Jing Wang and Slidell Sunshine accept the following administrative action, which is a final decision pursuant to La. R.S. 49:977:

- 1. The LBMT will grant an establishment license to Slidell Sunshine, which will be subject to a probation period of two (2) years (the "Probation Period").
- 2. Slidell Sunshine will be subjected to three (3) random inspections each year during the Probation Period.
- 3. Slidell Sunshine is prohibited from using the phone number 985-318-7052 in advertisements.
- 4. All promotional materials, building signage, websites, and all online advertising, including but not limited to Google advertising, must match the name, address, phone number, and website information on record with the LBMT.
- Slidell Sunshine is prohibited from using generic signage or verbiage on advertising such as "Massage."
- 6. Jing Wang cannot sell or transfer ownership of Slidell Sunshine during the Probation Period without approval of the LBMT.

- 7. During the Probation Period, Jing Wang and Slidell Sunshine will provide the LBMT with the days and hours of operation and will notify the LBMT of any changes to the days and hours of operation during the Probation Period.
- 8. Jing Wang and Slidell Sunshine shall submit the name (and preferred name, if applicable) and contact information of the licensed massage therapist(s) working at the establishment to the LBMT. The licensed massage therapist(s) will also be responsible for ensuring compliance with the Board's regulations and laws applicable to the practice of massage therapy in the State of Louisiana.
- 9. Jing Wang and Slidell Sunshine shall notify the LBMT in writing within seven (7) days of hiring a new massage therapist.
- 10. A licensed massage therapist must be present and available to provide services during all hours of operation.
- 11. If a licensed massage therapist is not available to work, Slidell Sunshine shall close until a licensed massage therapist is available to work.
- 12. Jing Wang shall provide her personal contact information, including name, address, phone number, and email address, to the LBMT within seven (7) days that all parties sign this Consent Agreement and Order. Jing Wang shall promptly notify the LBMT of any changes to her personal contact information.
- 13. Jing Wang and Slidell Sunshine shall provide the LBMT with a list of all non-licensed employees working at the establishment (and preferred name, if applicable). Jing Wang and Slidell Sunshine shall notify the LBMT of any changes of the non-licensed staff within seven (7) days of such changes.

- 14. Jing Wang and Slidell Sunshine shall submit all advertisements to the LBMT for review and approval prior to publishing.
- 15. Jing Wang shall provide the name, address, and nature of any and all other business in which she has any ownership interest.
- 16. Jing Wang will be under a probation period of two (2) years for practicing massage therapy without a license. If Jing Wang is found to be practicing massage therapy without a license, the establishment license for Slidell Sunshine will be immediately revoked.
- 17. Jing Wang and Slidell Sunshine specifically acknowledge that failure to comply with the terms of this Consent Agreement and Order may result in a denial, revocation, or suspension of any license, certificate, or registration issued by, or applied for, in accordance with LAC 46:XLIV §1701.
- 18. By agreeing to the terms of this Consent Agreement and Order, Jing Wang and Slidell Sunshine waive all rights to appeal this adjudication.

Effect of Non-Acceptance of Agreement. Jing Wang and Slidell Sunshine acknowledge that this Consent Agreement and Order is subject to the approval of the Board. They further acknowledge and agree that if the Board rejects this Consent Agreement and Order, it will be void, and a hearing on the application of Spring Body Health Conditioning and Notice of Intent to Deny issued by the Board relative to the allegations contained herein may proceed. If this Consent Agreement and Order is rejected by the Board, it will not constitute a waiver of Slidell Sunshine's right to a hearing on the matters alleged in the Notice of Intent to Deny and the admissions contained herein will have no effect. Jing Wang and Slidell Sunshine further agree that if the Board rejects this Consent Agreement and Order, the members of the Board may

decide the matter after a hearing, and their consideration of this Consent Agreement and Order

shall not alone be grounds for recusal of any member of the Board, including any claims that the

Board is biased against them, that it cannot fairly decide the case, or that it has received ex parte

communication.

Address of Board. All payments ordered and any reports required by this Consent

Agreement and Order shall be addressed to Louisiana Board of Massage Therapy, 9619 Interline

IT IS HEREBY FURTHER ORDERED that this Consent Agreement and Order shall

take effect immediately upon its adoption by the Board and is a public record of the Board. The

terms of this Consent Agreement and Order shall be published and reported in, including but not

limited to, the LBMT website.

THE ADMISSIONS AND FINDINGS CONTAINED HEREIN are intended solely for

the purpose of resolving the case at hand or in connection with other matters before the LBMT

involving Jing Wang and Slidell Sunshine.

THIS CONSENT AGREEMENT AND ORDER shall take effect immediately upon

adoption by the Board and is a matter of public record.

I, JAMES R. RAINES, serving as Prosecutor, do hereby acknowledge negotiation and

preparation of this Consent Agreement and Order in order to resolve, with prejudice, all

matters for which Jing Wang and Slidell Sunshine could be charged under this investigation,

and further certify that this Consent Agreement and Order is consistent with the evidence,

adequately addresses the complaint, and represents a true and correct statement of that which

could be proven at a hearing of this matter.

I expressly acknowledge that the disclosure of such information to the LBMT shall be without prejudice to the Prosecutor's authority to file a formal Administrative Complaint, or the LBMT's capacity to adjudicate such Administrative Complaint, should the LBMT decline to approve this Consent Agreement and Order. I further acknowledge my awareness that should the LBMT approve this Consent Agreement and Order that the Consent Agreement and Order will become a matter of public record.
