### FINDINGS OF FACT, CONCLUSIONS OF LAW AND ORDER

Pursuant to La. R.S. 37:3555(B) and applicable provisions of the Louisiana Administrative Procedure Act, an administrative hearing was held before the Louisiana Board of Massage Therapy (“Board”) on September 25, 2023, relative to the Notice of Intent to Deny Application for Establishment License for At Glamour Spa, Inc. owned by Yue Zhen Lan (“Applicant”).

James Raines, Complaint Counsel; and

Yue Zhen Lan, owner of At Glamour, Inc. (“Applicant”) assisted by Mandarin Chinese Language Interpreter, Liu Ting Chen.

### FINDINGS OF FACT

1. Records on file with the Louisiana Secretary of State on September 28, 2022, show Yue Zhen Lan as the registered agent and president of At Glamour Spa, Inc., (Board Exhibit B).
2. On April 17, 2023, Yue Zhen Lan submitted a Louisiana Application for Establishment License with Verifying Affidavit for At Glamour Spa, Inc. to be located at 4016 Highway 90 E, Suite 106 in Broussard with phone number (337)207-8130 to be opened for business on May 1, 2023 (“Application”), (Board Exhibit A).
3. The Board’s staff observed advertisements with the phone number and/or location on the Application on websites advertising sexually oriented services including SumoSearch, SkipTheGames.com, RubMaps, and BackPageGals.com. Advertisements on websites for sexually oriented services with the phone number on the Application included photographs of women in lingerie and customer reviews, (Board Exhibit C).
4. A Notice of Intent to Deny Louisiana Application for Establishment License with a hearing date of June 12, 2023, was sent to the Applicant via email and U.S. regular and Certified Mail No. 9589 0710 5280 6080 06 to the address of record (Board Exhibit D).
5. Applicant sent correspondence to the Board dated April 13, 2023, explaining her response to the question on the Application regarding previous massage establishment operated at the address stating “AT GLAMOUR SPA is a new massage establishment and she did not know any information about the previous establishment, (Board Exhibit C).

6. Applicant sent correspondence to the Board dated May 19, 2023, advising of her “decision to appear for a hearing regarding my massage establishment application” and requested a continuance to “September or October,” (Board Exhibit C).
7. On or about August 25, 2023, the Board’s Investigator, observed an “open” sign which was on and a flashing “massage” sign. The Board’s Investigator obtained a business card at the location for At Glamour Spa Inc. with the phone number and address on the Application, hours of operation and prices. A woman at the establishment, who presented a New York State Identification Card for He Yana, escorted the Board’s Investigator to the back and confirmed she was the massage therapist and was taking appointments. The Board’s Investigator did not see any licenses posted at the facility. While in the parking lot, the Board’s Investigator observed a man exit the business, (Board Exhibit C).
8. YUE ZHEN LAN testified under oath as follows:
  - a. She did not know about the advertisements. An advertising company contacted her and offered to put up advertisements for her establishment and she agreed.
  - b. She pays for the advertisements but was not aware of the kind of ads being posted. She rarely uses a computer and does not look at the advertisements.
  - c. Ling Wang, who lives in Texas, was the only massage therapist. Ling Wang is not practicing in Louisiana.
  - d. No one is doing massages at the establishment as of today.

**CONCLUSIONS OF LAW**

La. R.S. 37:3558(D) prohibits licensure of a sexually oriented businesses as a massage establishment.

**ORDER**


Considering the applicable law and evidence;

IT IS ORDERED, ADJUDGED AND DECREED that the Application for Establishment License of AT GLAMOUR SPA, INC. submitted by Yue Zhen Lang is hereby DENIED; and

IT IS FURTHER ORDED, ADJUDGED AND DECREED that Yue Zhen Lang and AT GLAMOUR SPA, INC., are ineligible for licensure by the Louisiana Board of Massage Therapy until Applicant appears before the board.
