## FINDINGS OF FACT, CONCLUSIONS OF LAW AND ORDER

### FINDINGS OF FACT

1. On or around the dates of May 13<sup>th</sup>, 2022 to June 10<sup>th</sup>, 2022, the Louisiana State Board of Massage Therapy ("BOARD") received applications to approve the above listed Establishment for B&B Spa Inc owned by Ming Ying Hu.
1. By letter(s) dated July 21st, 2022, sent Certified Mail, MingYin Hu was notified that the applications for each Establishment License would be reviewed by the Board at the August 19th, 2022 meeting which was cancelled and moved to September 9<sup>th</sup>, 2022, which additional certified letters were sent as well and an email notification. These notifications encouraged MingYing Hu "to attend to answer questions and/or provide additional information that may be needed."
2. No representative of MingYing Hu or B&B 66 Spa Inc. attended the September 9, 2022 Board meeting or requested a continuance of the application review to a date on which a representative could be present.
3. On MingYing Hu's application submitted to the board office, it was indicated that MingYing Hu was the owner of B&B 66 Spa Inc located 11944 Coursey Blvd, Suite 100, Baton Rouge, LA 70816. Included in the application packet was documentation from the Louisiana Secretary of State stating as such. MingYing Hu has been the owner at this location since October 29<sup>th</sup>, 2021. Publicly information shows that this location is and has been operating without an Establishment License and accepting appointments although not licensed by the BOARD.

4. There were multiple applications submitted but there were no records provided indicating MingYing Hu was the owner of any establishment located at, 5145 Main Street, Suite E Zachary, LA 70791

### **CONCLUSIONS OF LAW**

1. Pursuant to La. R.S. 37:3555(B)(1), the Louisiana State Board of Massage Therapy authorizes the BOARD to “accept or deny entrance of any applicant applying for licensure.”
2. B&B 66 Spa Inc. and MingYing Hu have advertised and/or engaged in the practice of massage therapy without a current license issued by the BOARD in violation of La. R.S. 37:3556(A).
3. La. R.S. 37:3558(3) requires “the entity which controls the physical location where the services are provided” to obtain a massage establishment license. B&B 66 Spa Inc and Ming Ying Hu failed to obtain a massage establishment license for the physical locations where services are being provided and failed to pay the establishment license fee for all “locations where one or more persons are regularly engaged in the practice of massage therapy,” in violation of La. R.S. 37:3558.

### **ORDER**

Considering the applicable laws and the evidence and testimony presented;

IT IS ORDERED, ADJUDGED AND DECREED that pursuant to La. R.S. 37:3555(B)(1) the Massage Establishment applications of B&B 66 Spa Inc and MingYing Hu are hereby denied;

IT IS ORDERED, ADJUDGED AND DECREED that B&B 66 Spa Inc and MingYing Hu shall be ineligible for licensure without appearing before the Louisiana State Board of Massage Therapy; and

IT IS ORDERED, ADJUDGED AND DECREED that B&B 66 Spa Inc locations and MingYing Hu Chi Chou shall immediately discontinue advertising and offering massage therapy services.
