**SUBJECT:** Program Year (PY) 2019 WIOA Revised Allocations

As a result of the fund restoration noted in USDOL's TEGL 16-18, Change 1 and the October distribution of Rapid Response funding, changes to the allocations for Regions 1 through 6 are being made for Adult, Dislocated Worker, Rapid Response, and Youth program funds. In addition, state Rapid Response funds will be distributed to address the need for ongoing dislocated worker services due to recent layoffs and anticipated closures.

WIOA PY19 allocation formulas were used to distribute the new program funds to the state's service delivery areas as seen below.
