2024 MCAC Juried Photography Show Rules & Release with Conditions of Entry

- All photos must be original work, taken by the entrants. No third party may own or control
 any materials the photo contains, and the photo must not infringe upon the trademark,
 copyright, moral rights, intellectual rights, or rights of privacy of any entity or person.
- Entries will not be accepted unless submitted via the official contest channel and submissions will not be accepted once the deadline lapses.
- All entries will be on display at The Common Ground for the entire month of July. Once the
 exhibit has concluded, Medina County Arts Council (MCAC) will coordinate with entries to
 arrange for pick up before August 31, 2024 and will become property of MCAC if not
 picked-up by August 31, 2024
- All entries will be judged blindly. All decisions are final.
- MCAC and/or Judges reserve the right to disqualify any entry that is deemed inappropriate
 or does not conform to stated contest rules.
- People's Choice winner: The public will have the opportunity to vote for their favorite display. People's Choice voting is open to the public and only one vote per person is allowed. If a duplication of voting occurs, the first vote will be counted and the others will be removed. People's Choice voting will take place online from July 5th through July 31st. The entry that receives the most public votes will be determined the winner. The People's Choice winner will be announced the first week of August.
- The winner will be contacted via the email address provided during entry. If no response is received after 30 business days, the winner will forfeit all rights to the prize.
- Participants retain the rights to their photograph. However, by entering the contest, participants grant the MCAC a royalty-free, world-wide, perpetual, non-exclusive license to publicly display, distribute, reproduce, and create derivative works of the entries, in whole or in part, in any media now existing or later developed. MCAC is not required to pay additional consideration or seek approval in connection with such uses. Any photograph reproduced will include a photographer's credit, as feasible.
- For photographs that include a recognizable person under 18 years of age, the photographer must provide written permission from a parent/guardian before the entry deadline.
- Objectionable or inappropriate content is ineligible for this contest and will be discarded.
- Application Images are limited to .jpeg files only and file name must include photographer's name and subject (e.g., JohnDoe_DrippingSprings.jpg). DO NOT embed any information in the image area itself, such as name, copyright, logo, etc., to keep judging anonymous
- Accepted pieces that will be on display are limited to matted prints at least 4" x 6" with 12" x 9" max with photographer's name and subject (e.g., JohnDoe_DrippingSprings.jpg) on the back of mat. (DO NOT embed any information in the image area itself, such as name, copyright, logo, etc., to keep judging anonymous) *** Mat boards must be either white or back & is required.
- By submitting an entry, each contestant agrees to the rules of the contest and confirms he
 or she is at least 18 years old at the time of their entry's submission <u>or</u> have
 parental/guardian permission if under 18 years of age.

The Indemnified Parties are not responsible for incomplete or misdirected entries, technical or network malfunctions or failures, or causes beyond their control.
