

# RESPONSES TO SURVEY OF MARKET PARTICIPANTS

Markets Group, Federal Reserve Bank of New York



## April/May 2019

The **Survey of Market Participants** is formulated by the Trading Desk at the Federal Reserve Bank of New York to enhance policymakers' understanding of market expectations on a variety of topics related to the economy, monetary policy and financial markets. The questions involve only topics that are widely discussed in the public domain and never presume any particular policy action. FOMC participants are not involved in the survey's design.

For most questions, median responses across participants, along with the 25th and 75th percentiles, are reported.<sup>1</sup> For questions that ask respondents to give a probability distribution, the average response across participants for each potential outcome is reported. Brief summaries of the comments received in free response form are also provided.

Responses were received from 26 market participants. Except where noted, all 26 participants responded to each question. In some cases, participants may not have provided complete responses (e.g. may not have provided forecasts extending to the same time horizon as requested in the survey). In these instances, the number of respondents who answered all parts of the question is indicated.

Current economic conditions:

**Several respondents indicated that they expected no material changes to this portion of the statement, while several others indicated that they expected the Committee to note continued strength in the labor market. Several respondents also indicated that they expected the Committee to describe growth of economic activity as “moderate”. Finally, several respondents indicated that they expected the Committee to downgrade its characterization of core inflation.**

**Most respondents indicated that they expected no material changes to this portion of the statement.**

**Many respondents indicated that they expected no material changes to this portion of the statement.**

**Several respondents indicated that they expected the Chair to continue to emphasize the value of patience in determining possible future adjustments to monetary policy, and several respondents indicated that they expected him to reiterate that policy will be data dependent. In addition, several respondents indicated that they expected the Chair to discuss recent softness in inflation data, while several indicated that they expected him to discuss risks to the global growth outlook.**

- 2)** How would you grade the Federal Reserve System's communication with the markets and with the public since the last policy survey? Please provide a rating between 1 and 5, with 1 indicating ineffectiveness and 5 indicating effectiveness.

In explaining their rating of the Federal Reserve System’s communication, some respondents indicated that they believed communication from Federal Reserve officials had been consistent. In addition, several respondents noted that they believed the Committee had clearly communicated that it would be patient in determining the appropriate course of monetary policy, while several respondents noted that they perceived communication regarding the Federal Reserve’s balance sheet policy to be clear.

**Several respondents indicated that they had reduced or removed their modal expectations for increases in the target range by the end of 2019, and several respondents cited Fed communication, including the events of the March FOMC meeting, in explaining changes to their expectations. In addition, several respondents indicated that they had revised lower the likelihood they assigned to increases in the target range while several indicated that they had revised higher the likelihood they assigned to decreases in the target range and/or for no change in the target range. Finally,**

**several respondents cited lower realized inflation and/or a perceived increased focus on inflation among Fed officials in explaining changes to their expectations.**

that they had lowered their recession probabilities. In explaining changes to their recession probabilities, several respondents cited improving U.S. and/or global economic data, and several noted improving Chinese economic data in particular.
