Wildhorse, Southeast District, Arizona DOF. Ten miles south of Sierra Vista, AZ. Grass and brush. Minimal fire behavior with creeping and smoldering. Numerous structures threatened.

Rico, Las Cruces Field Office, BLM. One mile north of Pinos Altos, NM. Light slash and timber. Minimal fire behavior with smoldering. Numerous structures threatened.

Goldwater, Phoenix District, BLM. Twenty miles southeast of Gila Bend, AZ. Grass and brush. Minimal fire behavior.

Post, Southeast District, Arizona DOF. Six miles southwest of Benson, AZ. Grass and brush. Minimal fire behavior. Reduction in acreage due to more accurate mapping.

McGregor, Las Cruces Field Office, BLM. Eight miles southeast of Timberon, NM. Grass and brush. No new information. Last report unless new information is received.

Comanche, Carson NF, USFS. Previously reported incident. Ten miles southwest of El Rito, NM. Timber and brush. Moderate fire behavior with torching, flanking and backing. Road closures in effect. Last narrative report unless significant activity occurs.

Predictive Services Discussion:

Widespread warm, dry and breezy weather will continue across the Southwest, southern Great Basin, West Slope, and southern California leading to moderate significant fire potential in the Southwest. Showers and thunderstorms with areas of heavy rain are likely from the Northern Rockies eastward across Minnesota and into parts of Wisconsin. Severe thunderstorms are possible in the Middle and Upper Mississippi Valley, while scattered to widespread showers and thunderstorms are expected over the Atlantic Coast States and along the Gulf Coast. Hot temperatures will continue in south and west Texas, with highs exceeding 10° F above normal. Windy conditions and isolated to scattered mixed wet and dry thunderstorms will develop over the Southern and Central Great Plains. Isolated thunderstorms are also likely over the mountains in northern California, the Cascades, and northern Great Basin. Scattered showers will continue across the southern half to two-thirds of Alaska.
