Sixty fireline management personnel from Australia and New Zealand are assigned to support large fires in the Northwest Area.

Active fire behavior with uphill runs, torching and short-range spotting. Structures, communication infrastructure threatened. Evacuations, area and road closures in effect. #### **Predictive Services Discussion:**

A shortwave trough will continue to move across the northern Rockies while weak high pressure briefly redevelops over the West Coast in advance of another West Coast trough, with little change in temperatures, on average. Less shower and thunderstorm activity is expected across the West as compared to recent days. The monsoon will be less active, and any thunderstorms will likely be focused over New Mexico. The main threat for mixed wet and dry thunderstorms will be in the Rockies from Montana to northern Colorado.

Very dry conditions will remain over the interior portions of the West, especially the Great Basin, though not quite as widespread as earlier in the week. The driest conditions will be focused over the interior of southern California through Nevada with RH as low as 5-20%. Less dry air is expected farther north into southeast Oregon and southwest Idaho as well as the Columbia Basin. Areas of breezy westerly winds will continue through the Cascade gaps and across portions of California and Nevada, though weaker than earlier in the week, while breezy westerly winds will expand farther south into southern California. Hot, dry, and breezy conditions will also continue for parts of the Southern Plains and Gulf Coast with chances for scattered afternoon thunderstorms along the northern Gulf Coast. Mild and dry conditions are expected for eastern Interior Alaska, while Tropical Storm Ernesto brings heavy rain and gusty winds to Puerto Rico into this afternoon before it moves north away from the island.
