Durkee, Vale District, BLM. Transfer of command from CIMT (NW Team 6) to CIMT (SA Team 3) will occur tomorrow. IMT is also managing the Cow Valley fire. Started on private land one mile west of Durkee, OR. Brush, grass and timber. Active fire behavior with wind-driven runs, flanking and short-range spotting. Numerous structures, energy and communication infrastructure threatened. Evacuations and road closures in effect.

Cow Valley, Vale District, BLM. Started on private land nine miles east of Ironside, OR. Brush and grass. Minimal fire behavior. Energy and communication infrastructure threatened. Sage-grouse habitat threatened.

Lone Rock, Prineville District, BLM. CIMT (NW Team 2). Started on county land 10 miles southeast of Condon, OR. Timber and grass. Moderate fire behavior with flanking, single tree torching and short-range spotting. Numerous structures threatened. Evacuations, area, road and trail closures in effect.

Swawilla I, Colville Agency, BIA. CIMT (NR Team 6). IMT is also managing the Bridge Creek fire. Ten miles southwest of Keller, WA. Grass, brush and timber. Active fire behavior with group torching and short-range spotting. Numerous residences threatened. Area, road and trail closures in effect.

Bridge Creek, Northeast Region, Washington DNR. Ten miles north of Keller, WA. Grass, brush and timber. Active fire behavior with short-range spotting and group torching. Residences threatened. Evacuations, area and road closures in effect.

Falls, Malheur NF, USFS. Transfer of command from CIMT (NW Team 8) to CIMT (AK Team 1) will occur today. IMT is also managing the Telephone fire. Twenty-six miles northwest of Burns, OR. Timber and grass. Active fire behavior with short crown runs, running and spotting. Numerous structures threatened. Evacuations, area, road and trail closures in effect.

Telephone, Malheur NF, USFS. Sixteen miles northeast of Burns, OR. Timber and grass. Extreme fire behavior with running, short-range spotting and single tree torching. Numerous structures threatened. Evacuations, area, road and trail closures in effect..

Battle Mountain Complex (5 fires), Pendleton Unit, Oregon DOF. IMT 1 (ODF Team 3) and IMT 1 (ODF Team 1). Includes the previously reported Boneyard fire. IMT is also managing the Courtrock fire. Eight miles north of Ukiah, OR. Timber, grass and brush. Active fire behavior with running, group torching and spotting. Numerous structures threatened. Evacuations, area, road and trail closures in effect.

Courtrock, Fossil Unit, Oregon DOF. Seven miles south of Monument, OR. Grass and brush. Active fire behavior with running, uphill runs and spotting. Numerous structures threatened. Evacuations and road closures in effect.

Badland Complex (3 fires), Vale District, BLM. CIMT (RM Team 2). Three miles northeast of Durkee, OR. Grass, brush and timber. Active fire behavior with wind-driven runs, torching and spotting. Structures and communication infrastructure threatened. Evacuations and road closures in effect.

Microwave Tower, The Dalles Unit, Oregon DOF. CIMT (GB Team 6). IMT is also managing the Whisky Creek fire. Five miles southwest of Mosier, OR. Timber and grass. Moderate fire behavior with backing, creeping and smoldering. Numerous structures threatened. Evacuations, area, road and trail closures in effect.

Whisky Creek, Mt. Hood NF, USFS. Six miles southeast of Cascade Locks, OR. Timber and brush. Active fire behavior with flanking, backing and short-range spotting. Area, road and trail closures in effect.

Cougar Creek, Southeast Region, Washington DNR. CIMT (NW Team 13). Twenty-three miles southwest of Asotin, WA. Timber, grass and brush. Active fire behavior with uphill runs, flanking and spotting. Numerous structures threatened. Evacuations, area, road and trail closures in effect.

Pioneer, Southeast Region, Washington DNR. CIMT (NW Team 3). IMT is also managing the Easy fire. Started on private land 10 miles southeast of Stehekin, WA. Timber, brush and grass. Active fire behavior with backing, flanking and single tree torching. Numerous structures threatened. Evacuations, area, road and trail closures in effect.

Easy, Okanogan-Wenatchee NF, USFS. Seventeen miles west of Mazama, WA. Timber. Active fire behavior with creeping, smoldering and single tree torching. Structures threatened. Area, road and trail closures in effect.

Diamond Complex (7 fires), Umpqua NF, USFS. CIMT (NW Team 7). Eighteen miles southwest of Chemult, OR. Timber. Active fire behavior with flanking, isolated torching and short-range spotting. Numerous structures threatened. Evacuations, area, road and trail closures in effect.

Lane 1, East Lane Unit, Oregon DOF. CIMT (NC State Team 1). IMT is also managing the Clark 900, Adam Mountain, Jack Saddle, Mineral, Quartz and Puddin fires. Fifteen miles southeast of Springfield, OR. Timber. Active fire behavior with flanking, backing and torching. Structures threatened. Area and road closures in effect.

Clark 900, Northwest District, BLM. Nineteen miles southwest of Oakridge, OR. Timber. Active fire behavior with flanking, backing and torching.

Adam Mountain, Umpqua NF, USFS. Six miles southeast of Dorena, OR. Timber and closed timber litter. Active fire behavior with flanking, backing and torching.

Jack Saddle, Umpqua NF, USFS. Ten miles southeast of Dorena, OR. Timber and closed timber litter. Active fire behavior with flanking, backing and torching.

Mineral, Umpqua NF, USFS. Seven miles southeast of Dorena, OR. Timber and closed timber litter. Active fire behavior with flanking, backing and torching. Structures threatened.

Quartz, Umpqua NF, USFS. Ten miles southeast of Dorena, OR. Timber and closed timber litter. Active fire behavior with flanking, backing and torching.

* **Puddin**, Umpqua NF, USFS. Thirteen miles southeast of Dorena, OR. Timber, closed timber litter and light slash. Active fire behavior with flanking, backing and torching. Structures threatened.

Pyramid, Willamette NF, USFS. CIMT (CA Team 5). Seventeen miles northeast of Cascadia, OR. Timber and medium slash. Active fire behavior with backing, creeping and short-range spotting. Area, road and trail closures in effect.

Homestead Complex (4 Fires), Umpqua NF, USFS. CIMT (GB Team 5). Thirty miles northeast of Glide, OR. Timber and brush. Moderate fire behavior with backing, smoldering and isolated torching. Area, road and trail closures in effect.

Ore, Willamette NF, USFS. CIMT (NW Team 10). Seven miles northeast of Blue River, OR. Timber. Active fire behavior with creeping, torching and group torching. Structures threatened. Area, road and trail closures in effect.

Chalk, Willamette NF, USFS. CIMT (RM Team 1). IMT is also managing the Moss Mountain, Coffeepot and 208 fires. Nine miles northeast of Oakridge, OR. Timber. Active fire behavior with uphill runs, group torching and spotting. Area, road and trail closures in effect.

Moss Mountain, Willamette NF, USFS. Fourteen miles southeast of Oakridge, OR. Timber. Active fire behavior with uphill runs, group torching and spotting. Area, road and trail closures in effect. Transportation infrastructure threatened.

Coffeepot, Willamette NF, USFS. Ten miles southeast of Oakridge, OR. Timber. Active fire behavior with uphill runs, group torching and spotting. Transportation infrastructure threatened. Area, road and trail closures in effect.

* **208**, Willamette NF, USFS. Twenty miles southeast of Oakridge, OR. Timber. Moderate fire behavior with creeping and smoldering. Area and trail closures in effect.

Red, Deschutes NF, USFS. CIMT (EA Team 1). IMT is also managing the Wickiup fire. Eighteen miles west of Crescent, OR. Timber and closed timber litter. Moderate fire behavior with running, flanking and backing. Numerous structures threatened. Evacuations, area, road and trail closures in effect.

Wickiup, Deschutes NF, USFS. Eight miles west of La Pine, OR. Timber. Minimal fire behavior with smoldering. Area, road and trail closures in effect.

Crazy Creek, Ochoco NF, USFS. CIMT (SW Team 5). Sixteen miles northeast of Paulina, OR. Timber and grass. Active fire behavior with short-range spotting and group torching. Residences threatened. Area, road and trail closures in effect.

Retreat, Southeast Region, Washington DNR. CIMT (NR Team 1). Started on private land 14 miles southeast of Naches, WA. Timber, brush and closed timber litter. Extreme fire behavior with wind-driven runs, spotting and crowning. Numerous structures and energy infrastructure threatened. Road closures in effect.

* **Middle Fork**, Crater Lake NP, NPS. Fourteen miles northeast of Union Creek, OR. Timber and brush. Moderate fire behavior with isolated torching, creeping and backing. Trail closures in effect.

Big Horn, Washington State Fire Marshall's Office. Seven miles southeast of Bickleton, WA. Grass and brush. Active fire behavior with wind-driven runs, running and backing. Numerous structures threatened. Evacuations, area and road closures in effect.

Camp Creek, Prineville District, BLM. Ten miles southwest of Paulina, OR. Grass, timber and brush. Active fire behavior with creeping, uphill runs and group torching.

Ritter, Burns District, BLM. Thirteen miles northeast of Crane, OR. Timber, brush and grass. Active fire behavior with spotting, wind-driven runs and smoldering. Residences threatened.

Black Canyon, Southeast Region, Washington DNR. Ten miles northwest of Naches, WA. Timber, brush and grass. Minimal fire behavior with backing and smoldering. Numerous structures threatened. Evacuations in effect.

Cedar Creek, Vale District, BLM. Twenty-three miles southwest of Juntura, OR. Brush and grass. Moderate fire behavior with creeping and smoldering. Sage-grouse habitat threatened.

Hole-In-The-Ground, Vale District, BLM. Twenty-four miles west of Jordan Valley, OR. Brush and grass. Extreme fire behavior with uphill runs, running and wind-driven runs. Structures threatened.

Knot, Klamath Unit, Oregon DOF. Four miles southwest of Sprague River, OR. Grass and brush. Minimal fire behavior with creeping, backing and smoldering. Last report unless significant activity occurs.

* **Gooseneck**, Southeast Region, Washington DNR. Ten miles southwest of Clarkston, WA. Brush and grass. Active fire behavior with running and flanking. Structures threatened.

* **Cliff Mountain**, Wallowa-Whitman NF, USFS. Twenty-five miles east of Joseph, OR. Brush and grass. Extreme fire behavior with uphill runs, flanking and backing. Energy infrastructure threatened.

* **Deer Creek**, Vale District, BLM. Eighteen miles southwest of Adrian, OR. Brush and grass. Minimal fire behavior. Sage-grouse habitat threatened.

Extreme fire behavior with wind-driven runs, group torching and long-range spotting. Numerous structures and communication infrastructure threatened. Area, road and trail closures in effect.

Gold Complex, Plumas NF, USFS. CIMT (CA Team 10). Four miles northwest of Portola, CA. Timber, brush and closed timber litter. Active fire behavior with backing, isolated torching and short-range spotting. Numerous residences threatened. Evacuations, area, road and trail closures in effect.

Bench Lake, Sawtooth NF, USFS. Transfer of command from CIMT (GB Team 4) back to the local unit will occur on 7/28. Eight miles south of Stanley, ID. Light slash and timber. Minimal fire behavior with smoldering and creeping. Numerous structures threatened. Evacuations, area, road and trail closures in effect.

Speirs, Ashley NF, USFS. CIMT (GB Team 3). Thirty miles north of Vernal, UT. Timber, medium slash and grass. Minimal fire behavior with flanking, backing and creeping. Residences threatened. Road and trail closures in effect.

Quail Springs, Arizona Strip District, BLM. Twelve miles south of St. George, UT. Grass and brush. Minimal fire behavior with smoldering. Last report unless significant activity occurs.

Predictive Services Discussion:

Westerly winds gusting from 25 to 45 mph will redevelop in eastern Idaho, western Wyoming and parts of Montana Friday, with higher gusts possible near thunderstorms. Gusty southwesterly winds will impact Southern California into parts of the southern Great Basin. Minimum relative humidity across much of the Intermountain West, including inland California, is forecast to drop to between 5 and 20%, lowest from northern California into Nevada, southern Oregon and far southwest Idaho. Lighter winds and cooler temperatures are forecast across the Northwest behind the cold front, but this may result in increasing smoke and visibility issues near and downwind of ongoing wildfires during the morning and overnight hours. Isolated to scattered mixed wet and dry thunderstorms are expected across south-central Montana into Wyoming, eastern Utah and Idaho, the West Slope, and northern portions of the Southwest. Scattered mainly wet thunderstorms will develop farther south and east into southeast Arizona, New Mexico, and Colorado. Moderate to high-risk significant fire potential is forecast from northeastern California through portions of the Great Basin and northern Rockies Friday.

Rain will become more widespread across Alaska, though the eastern Interior will see one last warm day with isolated afternoon or evening thunderstorms. Another round of flooding rainfall is expected from eastern Texas to the coastal Carolinas. Enhanced trade winds will maintain dry and breezy conditions in the lee of Hawaii's higher terrain. The Great Lakes and Northeast will see dry and seasonable conditions.
