Swawilla I, Colville Agency, BIA. CIMT (NR Team 6). IMT is also managing the Bridge Creek fire. Ten miles southwest of Keller, WA. Grass, brush and timber. Active fire behavior with group torching and short-range spotting. Numerous residences threatened. Area, road and trail closures in effect.

Bridge Creek, Northeast Region, Washington DNR. Ten miles north of Keller, WA. Grass, brush and timber. Moderate fire behavior with creeping and smoldering. Residences threatened. Area and road closures in effect.

Durkee, Vale District, BLM. CIMT (SA Team 3). IMT is also managing the Cow Valley fire. Started on private land one mile west of Durkee, OR. Brush, grass and timber. Ritter, Burns District, BLM. Thirteen miles northeast of Crane, OR. Timber, brush and grass. Active fire behavior with flanking, backing and creeping. Residences threatened.

Retreat, Southeast Region, Washington DNR. CIMT (NR Team 1). Started on private land 14 miles southeast of Naches, WA. Timber, brush and closed timber litter. Active fire behavior with uphill runs and single tree torching. Numerous structures, communication and energy infrastructure threatened. Area and road closures in effect.

Battle Mountain Complex (2 fires), Pendleton Unit, Oregon DOF. IMT 1 (ODF Team 3) and IMT 1 (ODF Team 1). IMT is also managing the Courtrock fire. Eight miles north of Ukiah, OR. Timber, grass and brush. Active fire behavior with running, group torching and spotting. Numerous structures threatened. Evacuations, area, road and trail closures in effect.

Courtrock, Fossil Unit, ODF. Seven miles south of Monument, OR. Grass and brush. Active fire behavior with uphill runs, torching and spotting. Numerous structures threatened. Evacuations, area and road closures in effect.

Badland Complex (3 fires), Vale District, BLM. CIMT (RM Team 2). Three miles northeast of Durkee, OR. Grass, brush and timber. Moderate fire behavior with wind-driven runs, torching and spotting. Structures, energy, communication infrastructure and Sage-grouse habitat threatened. Evacuations, area, road and trail closures in effect.

Lone Rock, Prineville District, BLM. CIMT (NW Team 2). Started on county land 10 miles southeast of Condon, OR. Timber and grass. Moderate fire behavior with backing, isolated torching and short-range spotting. Numerous structures threatened. Evacuations, area, road and trail closures in effect.

Pioneer, Southeast Region, Washington DNR. CIMT (NW Team 3). IMT is also managing the Easy fire. Started on private land 10 miles southeast of Stehekin, WA. Timber, brush and grass. Active fire behavior with backing, flanking and single tree torching. Numerous structures threatened. Evacuations, area, road and trail closures in effect.

208, Willamette NF, USFS. Twenty miles southeast of Oakridge, OR. Timber. Minimal fire behavior with creeping and smoldering. Area and trail closures in effect.

Crazy Creek, Ochoco NF, USFS. CIMT (SW Team 5). Sixteen miles northeast of Paulina, OR. Timber and grass. Active fire behavior with flanking, torching and short-range spotting. Residences threatened. Area, road and trail closures in effect.

Homestead Complex (5 Fires), Umpqua NF, USFS. CIMT (GB Team 5). Thirty miles northeast of Glide, OR. Timber and brush. Moderate fire behavior with backing, flanking and isolated torching. Area, road and trail closures in effect.

Lane 1, East Lane Unit, ODF. CIMT (NC State Team 1). IMT is also managing the Clark 900, Adam Mountain, Mineral and Puddin fires. Fifteen miles southeast of Springfield, OR. Timber. Active fire behavior with flanking, backing and torching. Structures threatened. Area and road closures in effect.

Clark 900, Northwest District, BLM. Includes the acreage of the previously reported Jack Saddle and Quartz fires. Nineteen miles southwest of Oakridge, OR. Timber. Active fire behavior with flanking, backing and torching. Area and road closures in effect.

Adam Mountain, Umpqua NF, USFS. Six miles southeast of Dorena, OR. Timber and closed timber litter. Active fire behavior with flanking, backing and torching. Structures, communication and energy infrastructure threatened. Evacuations in effect.

Mineral, Umpqua NF, USFS. Seven miles southeast of Dorena, OR. Timber and closed timber litter. Active fire behavior with flanking, backing and torching. Structures, energy and communication infrastructure threatened. Evacuations in effect.

Puddin, Umpqua NF, USFS. Thirteen miles southeast of Dorena, OR. Timber, closed timber litter and light slash. Active fire behavior with torching, flanking and backing. Structures, energy and communication infrastructure threatened.

Red, Deschutes NF, USFS. CIMT (EA Team 1). IMT is also managing the Wickiup fire. Eighteen miles west of Crescent, OR. Timber and closed timber litter. Moderate fire behavior with creeping, isolated torching and torching. Numerous structures threatened. Evacuations, area, road and trail closures in effect.

Ore, Willamette NF, USFS. CIMT (NW Team 10). Seven miles northeast of Blue River, OR. Timber. Active fire behavior with creeping, torching and group torching. Structures threatened. Area, road and trail closures in effect.

Hole-In-The-Ground, Vale District, BLM. Twenty-four miles west of Jordan Valley, OR. Brush and grass. Active fire behavior. Structures threatened.

Camp Creek, Prineville District, BLM. Ten miles southwest of Paulina, OR. Grass, timber and brush. Moderate fire behavior with backing and single tree torching.

Big Horn, Washington State Fire Marshall's Office. Seven miles southeast of Bickleton, WA. Grass and brush. Minimal fire behavior with backing and creeping. Numerous structures threatened. Evacuations, area and road closures in effect.

Grasshopper, Vale District, BLM. Six miles northeast of Juntura, OR. Grass and brush. Moderate fire behavior. Structures and energy infrastructure threatened.

Black Canyon, Southeast Region, Washington DNR. Ten miles northwest of Naches, WA. Timber, brush and grass. Minimal fire behavior with smoldering. Numerous structures threatened. Area, road and trail closures in effect. Reduction in acreage due to more accurate mapping.

Predictive Services Discussion:

Hot, dry and breezy conditions will continue from eastern portions of southern California into northwest Arizona, central and southern Utah, the West Slope and far southern Wyoming today. Despite slightly lower winds as compared to Saturday, a second day of intense drying should lead to an overall increase in risks. Wind gusts of 25-40 mph will be common, and temperatures will be slightly above normal, with minimum relative humidity likely to drop to as low as 3-8% in the afternoon. Early morning moisture recovery will also be abysmal, except in sheltered valleys. Moderate to high-risk significant fire potential will continue, with emerging holdovers and growth to existing incidents likely. Scattered mixed wet and dry thunderstorms, along with a few dry thunderstorms, are expected over western Montana into much of Wyoming into far eastern Idaho. Temperatures over the northern Intermountain West will remain a bit below normal, but dry air will prevail. Dense wildfire smoke will maintain areas of low visibility and poor air quality across some of the northern Intermountain West, as well.

Monsoonal thunderstorms will generally be limited to southeast Arizona and portions of southern New Mexico. Most of the central and southern High Plains will see a drier and hotter day as high pressure aloft begins to strengthen over the region. Look for strong to severe thunderstorms in the northern and central Plains, with wet weather continuing over the Southeast. Aside from Florida, the rest of the East Coast into the eastern Great Lakes and Northeast will see dry and seasonably warm conditions. However, low pressure off the coast will bring showers and increasing winds to eastern New England late.
