Swawilla I, Colville Agency, BIA. CIMT (NR Team 6). IMT is also managing the Bridge Creek fire. Ten miles southwest of Keller, WA. Grass, brush and timber. Active fire behavior with isolated torching and short-range spotting. Numerous residences threatened. Evacuations, area, road and trail closures in effect.

Bridge Creek, Northeast Region, Washington DNR. Ten miles north of Keller, WA. Grass, brush and timber. Moderate fire behavior with creeping and smoldering. Residences threatened. Area and road closures in effect.

Falls, Malheur NF, USFS. CIMT (AK Team 1). IMT is also managing the Telephone and Ritter fires. Twenty-six miles northwest of Burns, OR. Timber and grass. Active fire behavior with short crown runs, running and spotting. Numerous structures threatened. Evacuations, area, road and trail closures in effect.

Telephone, Malheur NF, USFS. Sixteen miles northeast of Burns, OR. Timber and grass. Active fire behavior with short crown runs, running and spotting. Numerous structures threatened. Evacuations, area, road and trail closures in effect.

Ritter, Burns District, BLM. Thirteen miles northeast of Crane, OR. Timber, brush and grass. Active fire behavior with flanking, backing and creeping. Residences threatened.

Retreat, Southeast Region, Washington DNR. CIMT (NR Team 1). Started on private land 14 miles southeast of Naches, WA. Timber and brush. Active fire behavior with uphill runs, single tree torching and short-range spotting. Numerous structures, communication and energy infrastructure threatened. Area, road and trail closures in effect.

Pyramid, Willamette NF, USFS. CIMT (CA Team 5). Seventeen miles northeast of Cascadia, OR. Timber. Moderate fire behavior with backing, creeping and short-range spotting. Area, road and trail closures in effect. Precipitation occurred over the fire area yesterday.

Battle Mountain Complex (2 fires), Pendleton Unit, Oregon DOF. IMT 1 (ODF Team 3) and IMT 1 (ODF Team 1). IMT is also managing the Courtrock fire. Eight miles north of Ukiah, OR. Timber, grass and brush. Active fire behavior with running, group torching and spotting. Numerous structures threatened. Evacuations, area, road and trail closures in effect.

Courtrock, Fossil Unit, ODF. Seven miles south of Monument, OR. Timber, grass and brush. Active fire behavior with flanking, isolated torching and backing. Numerous structures threatened. Evacuations, area and road closures in effect.

Badland Complex (2 fires), Vale District, BLM. CIMT (RM Team 2). Three miles northeast of Durkee, OR. Brush and timber. Moderate fire behavior with creeping, isolated torching and smoldering. Structures, energy, communication infrastructure and sage-grouse habitat threatened. Evacuations, area, road and trail closures in effect.

Durkee, Vale District, BLM. CIMT (SA Team 3). IMT is also managing the Cow Valley fire. Started on private land one mile west of Durkee, OR. Grass and timber. Active fire behavior with flanking, backing and smoldering. Numerous structures, energy and communication infrastructure threatened. Evacuations, area and road closures in effect.

Cow Valley, Vale District, BLM. Started on private land nine miles east of Ironside, OR. Brush and grass. Minimal fire behavior.

Pioneer, Southeast Region, Washington DNR. CIMT (NW Team 3). CIMT (CA Team 15) mobilizing. IMT is also managing the Easy fire. Started on private land 10 miles southeast of Stehekin, WA. Timber and grass. Active fire behavior with creeping, flanking and single tree torching. Numerous structures threatened. Evacuations, area, road and trail closures in effect. Precipitation occurred over the fire area yesterday.

Easy, Okanogan-Wenatchee NF, USFS. Seventeen miles west of Mazama, WA. Timber and brush. Active fire behavior with creeping, backing and single tree torching. Structures threatened. Trail and area closures in effect. Precipitation occurred over the fire area yesterday.

Diamond Complex (8 fires), Umpqua NF, USFS. CIMT (NW Team 7). IMT is also managing the Middle Fork fire. Eighteen miles southwest of Chemult, OR. Timber and brush. Moderate fire behavior with flanking, backing and isolated torching. Numerous structures threatened. Evacuations, area, road and trail closures in effect.

Middle Fork, Crater Lake NP, NPS. Fourteen miles northeast of Union Creek, OR. Timber and brush. Moderate fire behavior with flanking, backing and isolated torching. Trail closures in effect.

Lone Rock, Prineville District, BLM. Transfer of command from CIMT (NW Team 2) to CIMT (SW Team 2) will occur tomorrow. Started on county land 10 miles southeast of Condon, OR. Timber and grass. Minimal fire behavior with backing, isolated torching and smoldering. Numerous structures threatened. Evacuations have been lifted. Area, road and trail closures in effect.

Crazy Creek, Ochoco NF, USFS. CIMT (SW Team 5). Sixteen miles northeast of Paulina, OR. Timber, brush and grass. Active fire behavior with running, torching and spotting. Residences threatened. Evacuations, area, road and trail closures in effect.

Microwave Tower, The Dalles Unit, Oregon DOF. Five miles southwest of Mosier, OR. Timber and grass. Moderate fire behavior with backing, creeping and smoldering. Numerous structures threatened. Evacuations, area, road and trail closures in effect.

Whisky Creek, Mt. Hood NF, USFS. Six miles southeast of Cascade Locks, OR. Timber and light slash. Moderate fire behavior with flanking, backing and creeping. Area, road and trail closures in effect.

Chalk, Willamette NF, USFS. CIMT (RM Team 1). IMT is also managing the Moss Mountain, Coffeepot and 208 fires. Nine miles northeast of Oakridge, OR. Timber. Active fire behavior with uphill runs, group torching and spotting. Area, road and trail closures in effect.

Moss Mountain, Willamette NF, USFS. Fourteen miles southeast of Oakridge, OR. Timber. Moderate fire behavior with flanking, single tree torching and spotting. Area, road and trail closures in effect.

Coffeepot, Willamette NF, USFS. Ten miles southeast of Oakridge, OR. Timber. Active fire behavior with uphill runs, group torching and spotting. Area, road and trail closures in effect.

208, Willamette NF, USFS. Twenty miles southeast of Oakridge, OR. Timber. Minimal fire behavior with creeping and smoldering. Area and trail closures in effect.

Cougar Creek, Southeast Region, Washington DNR. CIMT (NW Team 13). CIMT (NW Team 12) mobilizing. Twenty-three miles southwest of Asotin, WA. Timber, grass and brush. Active fire behavior with uphill runs, flanking and spotting. Numerous structures threatened. Evacuations, area, road and trail closures in effect.

Homestead Complex (5 Fires), Umpqua NF, USFS. CIMT (GB Team 5). Thirty miles northeast of Glide, OR. Timber and brush. Moderate fire behavior with backing, flanking and creeping. Area, road and trail closures in effect.

Ore, Willamette NF, USFS. CIMT (NW Team 10). Seven miles northeast of Blue River, OR. Timber. Active fire behavior with flanking, backing and creeping. Structures threatened. Area, road and trail closures in effect. Precipitation occurred over the fire area yesterday.

Lane 1, East Lane Unit, ODF. CIMT (NC State Team 1). IMT is also managing the Adam Mountain fire. Fifteen miles southeast of Springfield, OR. Timber. Active fire behavior with uphill runs, flanking and backing. Structures threatened. Area and road closures in effect.

Adam Mountain, Umpqua NF, USFS. Six miles southeast of Dorena, OR. Timber. Active fire behavior with uphill runs, flanking and backing. Structures, communication and energy infrastructure threatened. Area, road and trail closures in effect.

Red, Deschutes NF, USFS. CIMT (EA Team 1). IMT is also managing the Wickiup fire. Eighteen miles west of Crescent, OR. Timber. Moderate fire behavior with smoldering, torching and spotting. Numerous structures threatened. Area, road and trail closures in effect.

Wickiup, Deschutes NF, USFS. Eight miles west of La Pine, OR. Timber. Minimal fire behavior with smoldering. Area, road and trail closures in effect.

Big Horn, Washington State Fire Marshall's Office. Seven miles southeast of Bickleton, WA. Grass and brush. Minimal fire behavior with smoldering. Numerous structures threatened.

Grasshopper, Vale District, BLM. Six miles northeast of Juntura, OR. Grass and brush. Moderate fire behavior.

Hole-In-The-Ground, Vale District, BLM. Twenty-four miles west of Jordan Valley, OR. Brush and grass. Minimal fire behavior with creeping.

Winding Waters Complex, Wallowa Unit, ODF. IMT 1 (ODF Team 2). Twenty-three miles east of Union, OR. Timber and brush. Active fire behavior with backing, flanking and creeping. Area, road and trail closures in effect.

Camp Creek, Prineville District, BLM. Ten miles southwest of Paulina, OR. Grass, timber and brush. Moderate fire behavior with isolated torching.

Cliff Mountain, Wallowa-Whitman NF, USFS. Twenty-five miles east of Joseph, OR. Brush and grass. No new information. Last report unless new information is received.

Limepoint, Payette NF, USFS. CIMT (SA Team 1). Includes the acreage from the previously reported Oxbow fire. Three miles southwest of Cuprum, ID. Grass and brush. Active fire behavior with running, torching and spotting. Structures, energy and communication infrastructure threatened. Evacuations in effect.

Boulder, Boise NF, USFS. CIMT (GB Team 7). IMT is also managing the Wolf Creek fire. Nine miles southwest of Cascade, ID. Timber and brush. Active fire behavior with short-range spotting, flanking and backing. Communication infrastructure and structures threatened.

Wolf Creek, Payette NF, USFS. Eleven miles northwest of Cascade, ID. Timber and brush. Active fire behavior with group torching, spotting and flanking. Structures threatened.

Predictive Services Discussion:

Much cooler and more humid weather will overspread the Northwest, northern Great Basin, and western parts of the northern Rockies behind a passing cold front. Showers and a few thunderstorms will produce areas of beneficial rain, especially in western Montana and northern Idaho. A few dry lightning strikes are possible, generally towards the southern edge of precipitation. Areas ahead of the front, from southeastern Montana through the Rockies, southern Great Basin, and Desert Southwest will continue to see very dry conditions, with widespread single-digit minimum relative humidity values likely once again. Dead fuel moisture will continue to trend well below normal, with the risk for lengthy burn periods expanding across the region. West-southwesterly winds gusting from 30-50 mph will be common across parts of the Great Basin into far southern Montana, Wyoming and parts of the West Slope. Gusts locally in these areas may exceed 60 mph with thunderstorm outflows and areas of downslope flow. Monsoonal activity will stay put over southeast Arizona, New Mexico, and far southern Colorado.

Meanwhile, highs above 100 degrees over much of Kansas, Oklahoma, and northwestern Texas will combine with breezy southerly winds and relative humidity as low as 20-25% to promote a continued drying trend and possible increase in initial attack. There are no fire environment concerns in the eastern half of the country, where high humidity and areas of rainfall will continue.
