Re: **Producer Controlled Insurer Information Report for year ending December 31, 2023**

Dear Company President:

Pursuant to Chapter 239 of the laws of 1993, codified at N.J.S.A. 17:22D-1 through 17:22D-6 all authorized property and casualty and title insurers either domiciled in this State or domiciled in another State that is not NAIC accredited shall file the referenced report. This report shall be filed on an annual basis, on or before April 1<sup>st</sup>, for the calendar year immediately preceding. The review of our records indicates that the companies licensed in this State are as the following type of insurers:

- a New Jersey Incorporated (i.e., "domestic") property and casualty or title insurer.
- a New Jersey licensed, but foreign incorporated (i.e., incorporated under the laws of a state other than New Jersey), property and casualty or title insurer whose domestic insurance department is not accredited by the National Association of Insurance Commissioners (NAIC) and is therefore required to file this report with the State of New Jersey Department of Banking and Insurance.
