Reference: Forrest Fenn Treasure

Subject: Response to Freedom of Information Act (FOIA) Request NPS-2020-01088

This letter is in response to your Freedom of Information Act (FOIA) request dated July 20, 2020, in which you requested “internal reports, memoranda, investigation files, and correspondence regarding Fenn’s treasure.” Your request has been processed in accordance with the FOIA (5 U.S.C. § 552).

Upon further review, your request is granted in part and denied in part. We are providing two files, totaling 41 pages of responsive material. Portions of approximately 33 pages, however, are being withheld under Exemption Exemptions 6 of the FOIA, and portions of approximately 22 pages are being withheld under Exemption 7(C) of the FOIA.

Exemption 6 allows us to withhold information that if released would constitute a clearly unwarranted invasion of personal privacy. Exemption 7(C) allows us to withhold information from law enforcement files that could reasonably be expected to constitute an unwarranted invasion of personal privacy.

The information being withheld consists of personally identifiable information (PII), including names, addresses, driver’s license numbers and personal email addresses for individuals other than yourself. We have determined that the individuals to whom this information pertains have a substantial privacy interest in withholding it. You have not provided information that explains a relevant public interest under the FOIA in the disclosure of this personal information. Additionally, we have determined that the disclosure of this information would shed little or no light on the performance of the agency’s statutory duties. Because the harm to personal privacy is greater than whatever public interest might be served by disclosure, we have determined that the release of the information that is being withheld would constitute a clearly unwarranted invasion of the privacy of these individuals and we are therefore withholding it under Exemptions 6 and 7(C).

The incident reports you have requested are contained within the Incident Management and Reporting System (IMARS), which is a Privacy Act System of Records (DOI-10). Therefore, although some or all of the information being withheld may be known to you through other means, we are obligated under the

Privacy Act and FOIA to withhold that information. Additionally, records relating to the death of Mr. Murphy at Yellowstone National Park has been previously been made available on our FOIA frequently requested documents page <https://www.nps.gov/aboutus/foia/foia-frd.htm>.

Dear Mr. Fenn,

My name is (b) (6), and I am from the Black Hills of South Dakota. First let me say that I am not a treasure hunter, although I have read with great interest your clues and followed the story of the treasure closely. I am more of a seeker of knowledge, listener, writer, and an admirer of the outdoors. The story of your treasure sparked in me an excitement about your

intent: to get people into the great outdoors, to encourage discovery and adventure – not necessarily for the treasure - but for the special places in our great country that so many people never even knew existed.

I have a proposition for you – and I hope you'll take me quite seriously. Your idea has inspired a number of people to venture out, seeking your treasure. What if I could perpetuate this idea many, many years into the future?

My idea is simple – split the treasure into several parts, and secret these parts in different locations across the country, each with its own set of clues. I have the capability to complete this task – I won't include my resume in this email, but know that I have been involved with exploring some of the longest and most complex caves on this planet, climbing world class peaks (I recently completed the ascent of Grand Teton this last August), and travelling our great country to show my children these special places that we as Americans need to learn more about in order to help protect them. If I were to relocate your treasure to some of these places, perhaps it would encourage even more interest in these locations and ignite a new wave of interest across our great country. Perhaps we could even stipulate that anyone finding the treasure caches should continue the tradition by splitting the treasure yet again and finding new locations for adventure.

I realize that it all sounds too good to be true – and why would you have any reason to trust me? I have a roof over my head, a wife and two boys whom I love, and a well-paying job. I have need of nothing else in life other than teaching my boys the value of respecting the land, exploration and discovery, and helping them grow. Would I like a portion of your treasure?

Of course. Who wouldn't? Do I need it? No. Besides, it belongs to you.

Consider my offer, and if you'd like to know more, I would be happy to talk in person, on the phone, or over email. Lastly, I have studied the clues you've provided, and I believe that the treasure is North of Ennis Lake (Brown[Trout]'s Home) on the Madison River in Montana, very close to Warm Springs Landing and Bear Trap Canyon.

If I am right, and with your permission, I would like to proceed with my idea, and together we could develop the locations and clues for the other caches.

Thanks for suffering through my lengthy message, and I hope you take my offer seriously.

Dear Mr. Fenn,

I am leading investigations on the search for Mr. Murphy here in Yellowstone National Park. At this time we have over 5 dog teams, 8 mounted horses, 24 ground pounders and over 18 people organizing the search. Many people are vested in finding Mr. Murphy alive. We are mostly in need of understanding WHERE Mr. Murphy may have been trekking while looking for buried treasure that seems to have been prompted by a poem written by you.

He left the trailhead yesterday (08/07/17) morning around 0815 am on the Rescue Creek Trailhead with the destination of Turkey Penn Peak. He told his wife that he wanted to look on the north side of the trail and in the email to you sent on June 03, I see that he states "Since I now know that 2 trips in 1 afternoon is not a reference to a campsite, I am planning to circle back to my blaze." He also wrote an email to you referencing the trip that he and his wife took in late May to the 1A2 campsite. If you were Mr. Murphy and were looking for buried treasure related to the poem that you wrote, where would you be walking/wandering/looking? If you need a copy of a map, I would be happy to provide one. Any assistance you can provide at this point would be more than helpful. Thank you.

Fatality near North Entrance

Search for Missing Person ends

MAMMOTH HOT SPRINGS, WY – Today, park search crews located the body of Jeff Murphy who was missing near the park's North Entrance. Mr. Murphy's death appears to have resulted from a fall on Turkey Pen Peak.

Mr. Murphy, 53, from Batavia, Illinois went for a day hike on the Rescue Creek Trail on June 7. The park initiated the search on June 8 when Mr. Murphy's wife reported that he failed to check in.

“All of us at Yellowstone extend our sympathy to the Murphy family for their tragic loss,” said Superintendent Dan Wenk.

At its peak, the search involved eight hiking teams, five dog teams, four horse teams, and a helicopter.

The Rescue Creek Trail, which had been closed due to this search, is open. However, visitors should anticipate temporary closures in the area until the investigation is complete.
