### **Regional Highlights:**

(New) DC: July 8, event to commemorate the 153rd anniversary of the Battle of Fort Stevens (managed by Rock Creek Park). Special programs will highlight the fort's role in the successful defense of Washington, D.C. The event concludes at the Battleground National Cemetery honoring Union soldiers who fought in the battle.

(New) DC: July 12, public scoping meeting for the site of the proposed National Desert Storm and Desert Shield Memorial. Two sites are under consideration: the area near Memorial Circle at George Washington Memorial Parkway on Columbia Island, and the Constitution Avenue Terminus Area near 23rd Street NW. The public comment period for the Environmental Assessment (EA) is open through July 24.

(New) DC: July 17, 30-day public scoping period begins for the Theodore Roosevelt Island Cultural Landscape Report (CLR), Environmental Assessment (EA) and Assessment of Effect. This combined planning effort is a first for the NPS National Capital Region. Over the past two years the park has received interest from Congress and stakeholders about the condition of the island and what steps can be taken to ensure long term stewardship.

(New) MT: On July 15, Facebook CEO Mark Zuckerberg will visit Glacier National Park. He will tour the park in a historic red bus with Superintendent Mow and USGS scientist Dan Fagre (Director of the Climate Change in Mountain Ecosystems Project). He will also visit with Gracie the Bark Ranger and official park partners. Zuckerberg will do a Facebook post immediately following his visit to his 92 million followers.

(New) AZ: Early in July 2017, the NPS plans to initiate a 30-day public scoping period under the National Environmental Policy Act (NEPA) for replacement of Grand Canyon National Park's trans-canyon pipeline. The trans-canyon pipeline serves the park's south rim supplying all water to facilities serving over 5 million visitors and 2,500 residents annually. The pipeline has exceeded its serviceable life and breaks frequently. The cost to replace the pipeline is currently estimated at \$131.8 million and construction is expected to begin in 2019. During the 30-day initial public scoping the NPS plans to hold public meetings at the park's south rim and in Flagstaff, AZ and will consult with the park's 11 associated tribes.

(New) CA: On or about July 9, Golden Gate National Recreation Area is scheduled to host the Hon. Rick Colless, Member of the Legislative Council in New South Wales, Australia who serves as the Parliamentary Secretary for Natural Resources. He is visiting as part of a Commonwealth Parliamentary Association study tour to the U.S. and Canada for him, and he has expressed specific interest in northern California and Yellowstone. They are interested in visits to national forests and parks and meetings with industry stakeholders to discuss forest and park management, natural resource management, conservation, and commercial logging policies and practices. (New) WA: On July 11, CNBC is scheduled to feature Washington state as part of a national announcement related to states "best for business" (the selection of Washington state as the top state nationwide is tightly embargoed by CNBC). CNBC and anchor Scott Cohn will broadcast live from locations in Mount Rainier National Park throughout the day. Governor Inslee is expected to attend and be interviewed on air.

(New) AK: Katmai National Park's popular "bear cam" has begun live on-line broadcasts from Brooks Falls. Brown bears gather there in significant number each July to catch migrating sockeye salmon. The cameras are operated in partnership with Explore.org, which is associated with the Annenberg Foundation, and run live into the fall. The on-line feed attracts thousands of viewers. NPS rangers periodically provide on-line and on-camera interpretive presentations and answer viewers questions. <u>http://explore.org/live-cams/player/brown-bear-salmon-cam-brooks-falls</u>

(Old) WA: On August 18, Olympic National Park will host a special event at Hurricane Ridge celebrating the renaming of the Olympic Wilderness to the Daniel J. Evans Wilderness by a 2016 act of Congress. Evans, a former Washington state governor and U.S. Senator, was the lead sponsor of the Washington Park Wilderness Act of 1988. Evans will speak at the event and various Congress members and/or staff are expected to among the estimated 150 participants.

(Old) DC: June through September, preparations are underway for a major rehabilitation project at Arlington House, The Robert E. Lee Memorial. There will be periodic, partial closures of the house and site to accommodate the work. The site is expected to close completely in September for the major construction, expected to last 18 months.

(Old) DC: June 23-July 24, The NPS is conducting an Environmental Assessment (EA) and is seeking public comments regarding the site of the proposed National Desert Storm and Desert Shield Memorial. Two sites are under consideration: the area near Memorial Circle at George Washington Memorial Parkway on Columbia Island, and the Constitution Avenue Terminus Area near 23rd Street NW. The EA public scoping period is June 23-July 24, 2017, with an initial scoping meeting on July 12.

(Old) DC: Late June/early July, as part of the Anacostia Park Wetlands Management Plan, the D.C. Department of Energy and Environment (DOEE), under an agreement with NPS, will round up and euthanize geese to regulate the resident population. The plan aims to restore the wetlands that surround the Anacostia River and eventually aid in restoring the river's health. This is the second year the park has done a goose roundup in partnership with DOEE and Animal and Plant Health Inspection Service (APHIS). The meat will be donated to the DC Central Kitchen.

(Old) Early July, The National Mall and Memorial Parks (NAMA) will drain the pond in Constitution Gardens for cleaning and maintenance. It is expected to be empty for approximately a week. (This is not related to the recent draining of the Lincoln Memorial Reflecting Pool because of elevated parasite levels.)

(Update) WA: On July 10, Olympic National Park will begin a \$27.5 million road project at Lake Crescent to resurface 11.6 miles of U.S. Highway 101. The project will mitigate rockfall hazards, and repair walls, guardrails, and culverts. Construction that will cause visitor delays will occur after Labor Day.

(Old) SC: During the week of July 24, the Reconstruction Era National Monument will hold three public listening sessions in Beaufort, Port Royal, and St. Helena Island, South Carolina, as part of the development of a foundation document for this new park. Targeted stakeholder meetings will also be held in the respective communities during the day to identify the biggest challenges and opportunities facing the National Park Service in setting up these new areas and also provide input into the development of the foundation document and interpretive themes.

(Old) DC: Mid-late July, work to clean, wax, and re-gild the U.S. Marine Corps War Memorial, commonly referred to as the Iwo Jima Memorial, will begin. Visitor access will be affected. The project also includes engraving "Iraq" and "Afghanistan" on the memorial to honor those who served. The park will notify stakeholders of the project's potential impacts. The project was made possible by a donation from philanthropist David Rubenstein.

(Old) AK: Beginning July 23, PBS and BBC will broadcast live from Katmai National Park and other locations in Alaska. The programming is set for July 23, 26 and 30. The project has been under consideration for more than a year, and park staff are issuing required special use permits. The Katmai segments are likely to focus on the congregations of brown bears along salmon streams, particularly at Brooks Camp.







Thanks for the quick response.

We try to develop themes for the areas and people he meets with. So far, we haven't really done anything around natural resources and people who work to manage public lands. Thought that meeting with your superintendent, park rangers and others (maybe someone from the Glacier Institute or other nonprofit working in the Park) about the work the Park Service does would be a great way to accomplish this.

Also, earlier in the trip he'll be visiting a North Dakota community involved in oil production and thought that a visit to Glacier, where the effects of global warming have been widely documented, would be a good balance.

Was thinking that maybe a drive (in a Jammer) up the Going to the Sun with the folks mentioned above would be a good way to knock off a meeting and Park tour in one shot. # Intermountain Region Weekly Report July 10, 2017

**Glacier National Park, MT** – On the weekend of July 4th, Glacier National Park experienced levels of extreme visitation. Traffic backed up for two miles onto US HWY 2, despite "flushing" 250 vehicles twice during peak hours through the entrance station. Based on a call from the park concession, the park temporarily closed the Many Glacier Valley for the first time due to gridlock conditions and hundreds of illegally parked cars. The Bowman Lake area has consistently filled and traffic restrictions occur on a daily basis. Based on unofficial metrics, the park estimates June visitation to be in excess of 25% over last year, setting the pace for another year of record visitation.

**Glacier National Park, MT** – On July 15, Facebook CEO Mark Zuckerberg will visit Glacier National Park. He will tour the park in a historic red bus with Superintendent Mow and USGS scientist Dan Fagre (Director of the Climate Change in Mountain Ecosystems Project). He will also visit with Gracie the Bark Ranger and official park partners. Zuckerberg will do a Facebook post immediately following his visit to his 92 million followers.

**Glen Canyon National Recreation Area, AZ** – In response to a GLCA news release announcing the June 28 closure of a small area on land in Kane Creek Canyon of Padre Bay at Lake Powell (deemed unsafe for recreational activities due to potential exposure to human feces), media coverage was provided by two TV stations in Salt Lake City (Fox 13 and Good4Utah), the St. George News, the Deseret News, and the Lake Powell Chronicle. On July 3 KSL Radio in Salt Lake City asked for an interview. The Powell Watch program was emphasized, "If you see something, say something."

**Grand Canyon National Park (AZ)** – Grand Canyon National Park managers meet Tuesday July 11 with Hualapai tribal officials regarding recent placement by the tribe of No Trespassing signs next to Colorado River. For more than a decade, the tribe and the NPS have met regularly to discuss areas of mutual interest. The signs were placed below the high water mark on NPS land which the tribe has claimed is within the reservation. Concession operators, who guide park visitors on the Colorado River, are concerned about loss of beach access along this 100-mile stretch of the river.

**Grand Canyon National Park, AZ** – Congressional staff members are expected to visit the park during the rest of July and during the August Recess. On Tuesday, July 11, 2017, staff from the office of Sen. John McCain and from the office of Sen. Jeff Flake will be in the park to visit with Superintendent Chris Lehnertz on a variety of topics including visitation, Colorado River fisheries and rafting, North Rim bison management, and the Transcanyon water pipeline.

**Grand Canyon National Park, AZ** – The NPS initiated a 30-day public scoping period under the National Environmental Policy Act (NEPA) for replacement of Grand Canyon National Park's trans-canyon pipeline on July 5, 2017. During public scoping period the NPS plans to hold public meetings at the park's south rim (July 17) and in Flagstaff, AZ (July 18) as well as a web based meeting (July 25) for those who cannot attend an in person meeting. The trans-canyon pipeline serves the park's south rim supplying all water to facilities serving over 5 million visitors and 2,500 residents annually. The pipeline has exceeded its serviceable life and breaks frequently. The cost to replace the pipeline is currently estimated at \$131.8 million and construction is expected to begin in 2019.

**Grand Canyon National Park, AZ** – The NPS plans to award up to three contracts to provide logistical support services for NPS administrative work along the Colorado River corridor within Grand Canyon National Park by September 1, 2017. Contractor support under the contracts will include providing boats, equipment and boat operators to support biological, archaeological, maintenance and restoration, and other administrative NPS work along the river. The NPS solicitation for award, which was issued on July 5, is tentatively schedule to close August 7. Commercial river trips conducted for park visitors by concessioners and NPS search and rescue operations are ongoing and will be unaffected by this action.

**Grand Teton National Park, WY** – On June 29 the Gros Ventre Road was open to alternating one-lane traffic in the erosion-affected area by a lighted traffic control system. The road was closed June 6 to all traffic due to significant erosion along the Gros Ventre River and damage to the Gros Ventre Road near the southern boundary of the park. The alternating one-lane of traffic and some riverbank stabilization is the first of three phases in the park's response to the situation. The second phase of the plan is to provide additional stabilization and create a two-lane bypass. The third phase includes re-establishing the river bank and permanent realignment of the road. As of June 19, the river bank had eroded a total of 40 horizontal feet and a 30-foot section of the eastbound lane had eroded. The road is the primary transportation corridor for the community of Kelly, Wyoming, a major park campground, numerous homeowners, US Forest Service campgrounds and recreation areas, active agricultural lands, and more.

**Grand Teton National Park, WY** – On July 11 the park will host a public open house to share information about the construction of a roundabout at the Gros Ventre Junction along US Highway 26/89/191 in the southern area of the park. The project addresses existing safety risks for pathways users, highway users and wildlife. US Highway 26/89/191 is a high-speed, two-lane rural road with an unsignalled intersection. This type of road has the greatest safety risk of any type of road in the country. A roundabout will meet all safety improvement objectives, and provide the best balance of improved safety, protection of wildlife and visual quality and cost. Construction will begin Spring 2018 and will have temporary impacts to vehicle and bicycle traffic, including delays and bypass lanes. The park is working in partnership with Western Federal Lands Highway on the project. In FY17 approximately \$4.2 million is programed from the Federal Lands Transportation Program. Public concerns about traffic impacts are anticipated.


**Regional Highlights:** 

(New) AK: The National Park Foundation's board of directors will be in Alaska July 12-15, with meetings at Denali National Park and other events in Fairbanks. Plans include an introduction to the park's operations and orientation to the park frontcountry and interior along the park road. Acting Director Mike Reynolds plans to attend.

(New) AK: The Army Corps of Engineers is accepting comments through August 14 on the Alaska Stand Alone Pipeline project Draft Supplemental Environmental Impact Statement (SEIS) during a public review period. The National Park Service is a cooperating agency on the SEIS as an agency with jurisdiction and as an agency with special expertise. The 800mile proposed pipeline would run within one mile of Gates of the Arctic NPP and Denali NPP, and one alternative to the proposed route runs through approximately seven miles of the front country of Denali NPP.

(New) HI: On July 17-18, 2017, Representative Jun Tsushima and Representative Kiyohiko Toyama, members from the Japanese House of Representatives, will visit the USS Arizona Memorial and tour the museum exhibits at the WWII Valor in the Pacific Visitor Center. They will be accompanied by Mr. Masumi Oka, Deputy Director General, Defense Policy Bureau, Ministry of Defense, and Mr. Yasushi Misawa, Consul General of Japan in Honolulu.

(New) AK: (b) (5)



(Old) DC: July 12, public scoping meeting for the site of the proposed National Desert Storm and Desert Shield Memorial. Two sites are under consideration: the area near Memorial Circle at George Washington Memorial Parkway on Columbia Island, and the Constitution Avenue Terminus Area near 23rd Street NW. The public comment period for the Environmental Assessment (EA) is open through July 24.

(Old) DC: July 17, 30-day public scoping period begins for the Theodore Roosevelt Island Cultural Landscape Report (CLR), Environmental Assessment (EA) and Assessment of Effect. This combined planning effort is a first for the NPS National Capital Region. Over the past two years the park has received interest from Congress and stakeholders about the condition of the island and what steps can be taken to ensure long term stewardship. (Old) MT: On July 15, Facebook CEO Mark Zuckerberg will visit Glacier National Park. He will tour the park in a historic red bus with Superintendent Mow and USGS scientist Dan Fagre (Director of the Climate Change in Mountain Ecosystems Project). He will also visit with Gracie the Bark Ranger and official park partners. Zuckerberg will do a Facebook post immediately following his visit to his 92 million followers.

(Old) AZ: Early in July 2017, the NPS plans to initiate a 30-day public scoping period under the National Environmental Policy Act (NEPA) for replacement of Grand Canyon National Park's trans-canyon pipeline. The trans-canyon pipeline serves the park's south rim supplying all water to facilities serving over 5 million visitors and 2,500 residents annually. The pipeline has exceeded its serviceable life and breaks frequently. The cost to replace the pipeline is currently estimated at \$131.8 million and construction is expected to begin in 2019. During the 30-day initial public scoping the NPS plans to hold public meetings at the park's south rim and in Flagstaff, AZ and will consult with the park's 11 associated tribes. (NOTE: will send Paul the park's comms package on this).

(Old) WA: On July 11, CNBC is scheduled to feature Washington state as part of a national announcement related to states "best for business" (the selection of Washington state as the top state nationwide is tightly embargoed by CNBC). CNBC and anchor Scott Cohn will broadcast live from locations in Mount Rainier National Park throughout the day. Governor Inslee is expected to attend and be interviewed on air.

(Old) WA: On August 18, Olympic National Park will host a special event at Hurricane Ridge celebrating the renaming of the Olympic Wilderness to the Daniel J. Evans Wilderness by a 2016 act of Congress. Evans, a former Washington state governor and U.S. Senator, was the lead sponsor of the Washington Park Wilderness Act of 1988. Evans will speak at the event and various Congress members and/or staff are expected to among the estimated 150 participants.

(Old) DC: June through September, preparations are underway for a major rehabilitation project at Arlington House, The Robert E. Lee Memorial. There will be periodic, partial closures of the house and site to accommodate the work. The site is expected to close completely in September for the major construction, expected to last 18 months.

(Old) WA: On July 10, Olympic National Park will begin a \$27.5 million road project at Lake Crescent to resurface 11.6 miles of U.S. Highway 101. The project will mitigate rockfall hazards, and repair walls, guardrails, and culverts. Construction that will cause visitor delays will occur after Labor Day.


(Old) SC: During the week of July 24, the Reconstruction Era National Monument will hold three public listening sessions in Beaufort, Port Royal, and St. Helena Island, South Carolina, as part of the development of a foundation document for this new park. Targeted stakeholder meetings will also be held in the respective communities during the day to identify the biggest challenges and opportunities facing the National Park Service in setting up these new areas and also provide input into the development of the foundation document and interpretive themes.

(Old) DC: Mid-late July, work to clean, wax, and re-gild the U.S. Marine Corps War Memorial, commonly referred to as the Iwo Jima Memorial, will begin. Visitor access will be affected. The project also includes engraving "Iraq" and "Afghanistan" on the memorial to honor those who served. The park will notify stakeholders of the project's potential impacts. The project was made possible by a donation from philanthropist David Rubenstein.

(Old) AK: Beginning July 23, PBS and BBC will broadcast live from Katmai National Park and other locations in Alaska. The programming is set for July 23, 26 and 30. The project has been under consideration for more than a year, and park staff are issuing required special use permits. The Katmai segments are likely to focus on the congregations of brown bears along salmon streams, particularly at Brooks Camp.

Midway through a "personal challenge" to travel to 30 states he'd never visited, the 33-year- old aims "to talk to more people about how they're living, working and thinking about the future," he wrote in January on his Facebook page.

Among those people was Kyle McKasson, manager of the Wilton Candy Kitchen, a century-old shop on the town square in Wilton, Iowa.

He was at work one Monday afternoon in June when two men and a woman dressed in jeans and button-down shirts entered the store, which is a regular stop on Iowa's presidential campaign circuit.

The three said they were from California on a business trip on their way to Chicago and asked Mr. McKasson for a tour of the store and its museum of the history of Wilton, population 2,800. They didn't tell their names, he said, and he thought it impolite to ask.

Four days later, the same three people returned to the candy store, and one of his new customers revealed their true mission: "Mark Zuckerberg will be here in five minutes."

A startled Mr. McKasson, 54, asked: "What do I need to do?" he recalled, and was told: "Nothing."

As Mr. Zuckerberg was leaving, he made one request, Mr. Moore said. "He said, 'If there are any news reporters that call you, just make sure you tell them I'm not running for president.""
