Procurement Process



Complex, made simple?



- In some ways, Information Technology (IT) procurement is not dissimilar from a construction project:
 - Extensive pre-planning period
 - Several levels of regulatory oversight
 - Multiple interrelated skilled workers executing various components
 - Fundamentally comes down to three things:
 - SCOPE
 - BUDGET
 - SCHEDULE



Scope, Budget, Schedule



- Command what is in your control, Manage what is not.
- Scope:
 - Distinguish mandatory functionality from desirable functionality
 - “It’d be nice” is quickest way for budget and schedule to get off track
- Budget:
 - Know your budget, recognize that costs increase
 - Know which market you are in: Custom or Commercial
- Schedule:
 - Comprehensive planning (taking place now) is key to commanding schedule
 - Stabilizing the current framework is key to avoiding undesirable exigencies



Information Technology Procurements in Oregon



- DAS Statewide Policy 107-004-130 requires agencies to obtain State CIO approval in advance of purchase/execution of IT systems:
 - IT investments exceeding a cost of \$150,000, unless the investment is agency-staffed development, or
 - IT investments exceeding a cost of \$1 million for agency-staffed application development projects, or
 - IT investments involving Information Classification Level 3 (restricted) or high data), or
 - IT Investments that meet one of the risk thresholds triggering EIS oversight under the Cloud Computing Policy, or
 - Any IT investments where EIS determines that oversight, review or approvals is in the best interest of state government.



Oregon Stage Gate Process for Information Technology Projects



- The Stage Gate process provides an opportunity for incremental review and approval of significant IT projects. EIS endorsement is required at the end of each project life cycle change.



Stage 1: Origination and Initiation



- State Gate 1 endorsement: Agency identifies project management and business analysis resources, and prepares high-level project justifications and project initiation documents.
 - CCB completed many of these documents in early 2020.
 - Received Stage Gate 1 Approval
 - These documents will need to be updated.



Stage Gate 2: Resource and Solution Planning and Analysis



- Stage Gate 2 endorsement: Agency identifies a project's resource and solution analysis planning. Stage 2 ends when OSCIO provides Stage Gate 2 endorsement memorandum.
 - Endorsement may contain conditions that must be satisfied before the next endorsement.
- This Stage is expected to be completed before the agency begins a formal Request for Proposal (RFP) process to procure the project's Solution Contractor.
- CCB had begun work on this Stage in early 2020.



Stage 3: Implementation Planning



- Stage Gate 3 endorsement: Agency identifies a project's detailed implementation planning. Upon approval, OSCIO will provide a Stage Gate 3 endorsement memorandum. At the time of Stage Gate 3 endorsement the scope, schedule, and budget baselines are set for the project. During implantation planning:
 - The project develops details about the implementation approach for execution
 - An RFP is released for vendor services
 - The project's planning documents are revised to establish scope, schedule, and budget baselines.
 - The detailed project management plan is updated as appropriate vendor services are procured and, as needed throughout the remainder of the project lifecycle.
- Stage Gate 3 endorsement may be needed to support the release of funding for the project execution.



Stage 4: Execution



- Stage Gate 4 endorsement: Agency identifies a project's execution, where the organization implements the plans that were developed in the previous stages and delivers the functionality described in the project document and Vendor Statement of Work, and prepares project tracking and close-out artifacts.
- The agency must report to the OSCIO:
 - Monthly status reports
 - Any significant changes to scope, schedule, or budget
 - Internal quality assurance
- At project close, the OSCIO will provide a memorandum and require transition documentation, operations/maintenance planning, lessons-learned, and close-out documentation.



Procurement Process



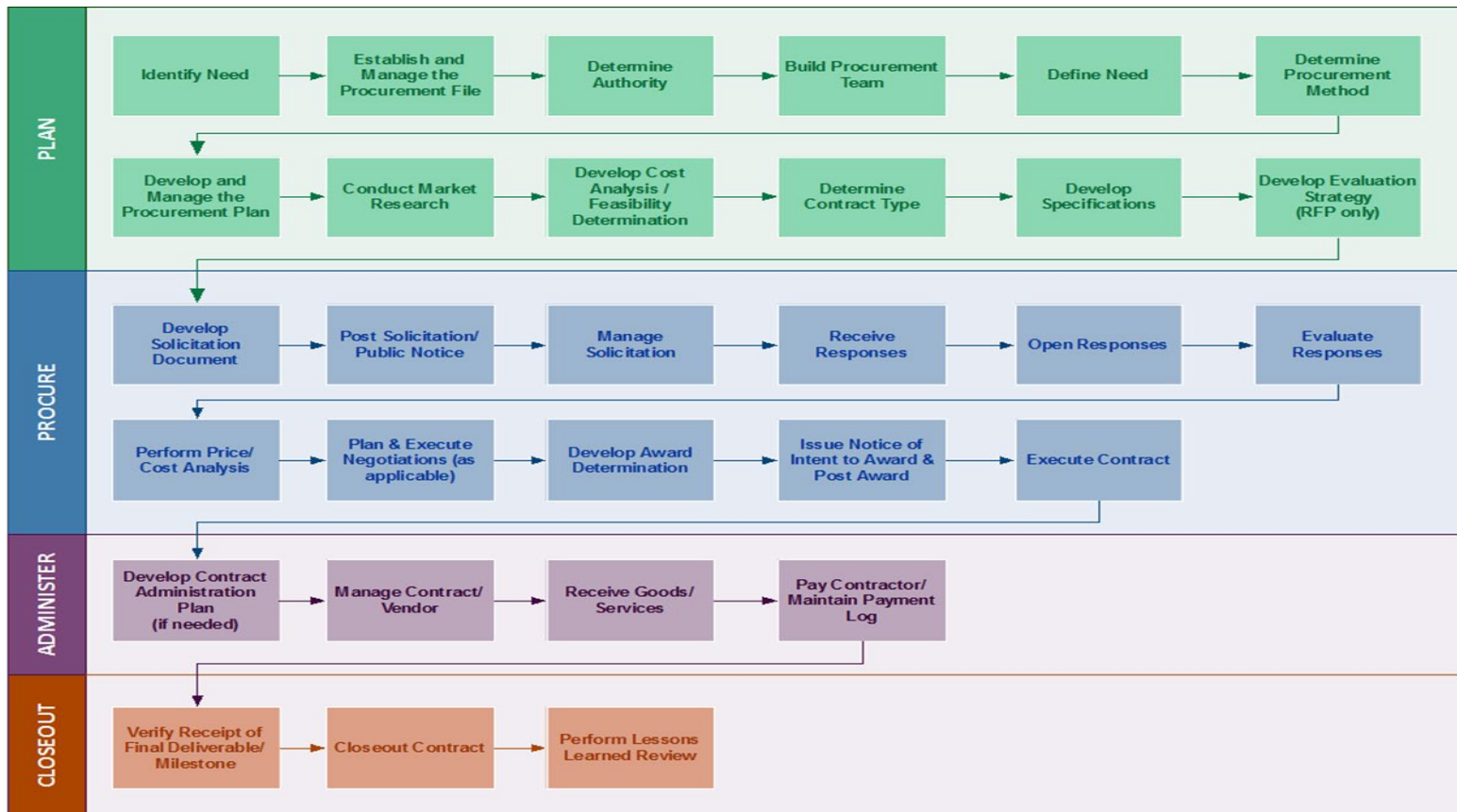
- Oregon Laws and Rules regulating procurement:
 - ORS Chapter 279
 - OAR Chapter 125
- Once DAS EIS gives approval for Procurement, CCB will then work with DAS Procurement to find a vendor.
- DAS Procurement will run the procurement.



DAS Procurement Process



- The DAS procurement process involves a lot of steps:





Key Procurement Tasks



1. Develop Solicitation Document
 - Statement of Work
 - Requirements
 - We have started work – have a first draft
 - Reviewed some recent agencies requirements (OLCC, Medical Board)
 - This is the most time consuming part of the solicitation
 - This is also the most important part of the solicitation because it will be how vendors are evaluated.
 - Develop Evaluation Strategy to be used
 - Working with DAS to develop the document could take several months



Key Procurement Tasks



2. Receive Responses to RFP's
 - Once the RFP is released there can be a few procurement activities
 - Pre-proposal conference
 - Questions/Clarifications on the RFP
 - The RFP should be open at least one month (could be longer) to give vendors time to respond to the RFP.



Key Procurement Tasks



3. Evaluate Responses

- Need a dedicated team and time to evaluate responses
 - There could be teams that evaluate specific portions of the responses rather than the entire RFP.
- How long this step takes is dependent upon how many responses are received:
 - Two recent agency Licensing System RFP's:
 - OLCC received 17 original responses
 - Medical Board received 8 responses
- Once the responses are received, demonstrations of the top systems are scheduled and evaluated.
- Evaluation could take several months.
- One of the last steps in Evaluation is to review cost proposals (done as a separate step in the RFP evaluation process).



Key Procurement Tasks



4. Award contract

- A protest period is part of the process
- Contract negotiation
- Signing contract

NOTE: DAS Procurement is understaffed currently and if this persists it will affect our procurement timeline.



And That's Just The Beginning



- Once we get through four stages of DAS-authorized planning and preparation...
- ...and once we move through the multi-layer DAS-governed procurement process...
- ...then we actually have implement the system, and more importantly move to the new system:
 - Axiom: “It is pretty easy to develop a new system/process, it is really challenging to move from an old system/process to a new one.



Super Tentative Road Map



- Mid-to-late 2022: Complete Stage Gate 3.
- Late 2022: Request funding authorization through legislature.
- Early 2023: Begin procurement process
- Late 2023: Award Contract
- Late 2023, Early 2024: Begin Implementation
- End of 2024: Complete implementation, ongoing operation and maintenance

Ongoing Activities

We have again started to validate system requirements and (also) business rules for the licensing system upgrade. We have a great deal more work to do before we're ready to choose a new system. We also began or continued three statewide initiatives. These initiatives will improve data availability, security framework and employee security preparedness across all agencies, boards, and commissions. Primarily work continued on the new notification software.

Subject: Outreach and Education Program update

Attached to this memo is a summary of outreach events for the year 2021. Below are some Education Section highlights from 2021:

- **Translated brochures into Spanish.** The education section's most important brochures have been translated into Spanish. PDF versions are available on the website, and printed versions are on their way to CCB offices. As soon as printed versions arrive, they will be made available for ordering on the CCB's forms page.
- **Collaborated with DCBS/DOJ to Publish Disaster Scams brochure.** CCB is involved in an ongoing collaboration with DCBS and DOJ to create outreach aimed specifically at victims of disaster scams. The brochure has been finalized and published in English and Spanish. When disasters occur, the publication will be promoted on the radio and in printed media and through online sources. There will also be an accompanying website.
- **Held over 30 live webinars, taught approximately 2,000 contractors, facilitated 6,000 continuing education credit hours.*** This is double the number of contractors taught in webinars in 2020, and over three times the number of contractors taught in live classes in 2019. Our webinars have changed a lot in the last year. We've added speakers like Work Share Oregon and 811 to our lineup of trainers, and because we've started advertising the speaker schedule, contractors are able to choose the classes most relevant to them. We've also changed the way we advertise for webinars, so contractors are signing up for webinars steadily without prompts from advertisements in the Toolbox.
- **Added outreach features to the website.** In an effort to get the word out about CCB's outreach, we've added an outreach services page to our website: <https://www.oregon.gov/ccb/Pages/CCBOutreachServices.aspx>
- **Created forms for easy access to CCB publications.** Anyone who wants one can order the trifold business card holder (in English or Spanish) and the Guide to Selecting a Contractor. Order forms are available on our website. These publications are popular among contractors, real estate professionals and homeowners. We've also made our Guide to Becoming a Licensed Contractor available. These can be ordered singly; they're aimed at anyone hoping to become a licensed contractor.
- **Streamlined mailing processes to make sending publications in the mail faster and easier.** Now that we're sending publications through the mail, we wanted to make the mailing process faster, easier and less costly. We've changed the formatting of our most popular publication – the Guide to Becoming a Licensed

Contractor – so that it can be sent in the mail without an envelope (simply put on a label and send it out!) or it can easily fitted in a 6x9 envelope, if needed.

- **Made upgrades to the CCB's website to make it easier to access the website's most important features.** Recently, we made some important changes to the CCB's website to make it easier to find pages like the sign up for the the 3-hour webinar, the "report unlicensed contractors" page and licensing forms. This is on the part of our website called the "carousel," which is placed prominently at the top of our website. Phone staff has reported this makes it easier to help callers, and it has increased the number of contractors who can find the 3-hour webinar sign up on their own.
- **Homeowner survey success.** The homeowner survey showed that homeowner awareness of the CCB is up to 54%, which is the highest it's ever been, and 10 points higher than the previous survey conducted in 2019. Homeowner contact with CCB has also increased, and the number of homeowners who used licensed contractors for home construction and home improvement has also increased. The number of homeowners who say their contractor showed them their CCB license at the time of hire also remains high - this could be related to CCB efforts to encourage contractors to educate homeowners about the value of hiring a licensed contractor.

*As of the date of this memo, we have held 29 webinars and taught 1855 contractors. The numbers above take into consideration classes that are scheduled but have not yet occurred.
