Past-Due Payment Relief: Homeowners must have household income at or below 150% of the area median income (AMI) for household size or 100% of the median income for the United States, whichever is greater. The greater of the two is outlined in the chart below on the "Past-Due" row. Homeowners must also be "housing cost burdened" by paying more than 43% of their household income toward housing costs

Ongoing Payment Relief: Homeowners must have household income at or below 100% of the AMI for household size or 100% of the median income for the United States, whichever is greater. The greater of the two is outlined in the chart below on the "Ongoing" row.
