

How Did the Fund Perform Last Year?

MSCI Transformational Changes ETF (the "Fund") seeks investment results, before fees and expenses, that track the performance of the MSCI Global Transformational Changes Index (the "Index"). The Fund invests in financial instruments that the Advisor believes, in combination, should track the performance of the Index. Strong technology sector performance was offset by a sizeable healthcare allocation, which contributed to underperformance relative to the S&P 500[®] . For the year ended May 31, 2024, the Fund had a total return of 19.87%. For the same period, the Index had a total return of 20.30% and a volatility of 12.65%. Primary factors affecting Fund performance include the total return of the securities held by the Fund, expenses, transaction costs, the volatility of the Fund's index, and other miscellaneous factors.
