How Did the Fund Perform Last Year?

Ultra Bitcoin ETF (the "Fund") seeks daily investment results, before fees and expenses, that correspond to two times (2x) the daily performance of the Bloomberg Bitcoin Index (the "Index"). The Fund invests in financial instruments that the Advisor believes, in combination, should produce daily returns consistent with the Fund's investment objective. Bitcoin returns were muted during this brief two-month period after a strong rally in cryptocurrencies. For the period April 1, 2024, through May 31, 2024, the Fund had a total return of -12.64%. For the same period, the Index had a total return of -2.75% and a volatility of 473.97%. Primary factors affecting Fund performance include the total return of the derivatives held by the Fund, including the performance of the reference assets to which any derivatives are linked, financing rates paid or earned, the types of derivative contracts used (and their correlation to the Fund's Index), expenses, transaction costs, the volatility of a Fund's index (and its impact on compounding), and other miscellaneous factors.
