

How Did the Fund Perform Last Year?

K-1 Free Crude Oil Strategy ETF (the "Fund") seeks investment results, before fees and expenses, that track the performance of the Bloomberg Commodity Balanced WTI Crude Oil IndexSM (the "Index"). The Fund invests in financial instruments that the Advisor believes, in combination, should track the performance of the Index. Volatile, but ultimately higher, oil prices drove performance. For the year ended May 31, 2024, the Fund had a total return of 25.68%. For the same period, the Index had a total return of 27.76% and a volatility of 24.11%. Primary factors affecting Fund performance include the total return of the derivatives held by the Fund, including the performance of the reference assets to which any derivatives are linked held by the Fund, expenses, transaction costs, the volatility of the Fund's index, and other miscellaneous factors.
