

How Did the Fund Perform Last Year?

S&P MidCap 400[®] Dividend Aristocrats ETF (the "Fund") seeks investment results, before fees and expenses, that track the performance of the S&P MidCap 400[®] Dividend Aristocrats Index (the "Index"). The Fund invests in financial instruments that the Advisor believes, in combination, should track the performance of the Index. Solid performance of MidCap stocks drove total return, though an underweight to the technology sector drove underperformance relative to the S&P 400. For the year ended May 31, 2024, the Fund had a total return of 15.93%. For the same period, the Index had a total return of 16.41% and a volatility of 14.89%. Primary factors affecting Fund performance include the total return of the securities held by the Fund, expenses, transaction costs, the volatility of the Fund's index, and other miscellaneous factors.
