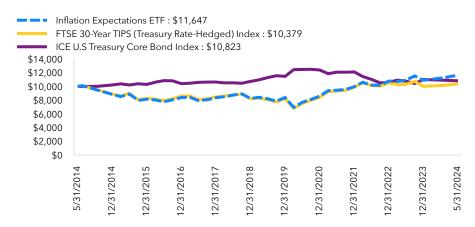

### How Did the Fund Perform Last Year?

Inflation Expectations ETF (the "Fund") seeks investment results, before fees and expenses, that track the performance of the FTSE 30-Year TIPS (Treasury Rate-Hedged) Index (the "Index"). The Fund invests in financial instruments that the Advisor believes, in combination, should track the performance of the Index. Performance was driven by a modest uptick in breakeven inflation which offset a higher risk-free rate. For the year ended May 31, 2024, the Fund had a total return of 7.56%. For the same period, the Index had a total return of 1.00% and a volatility of 7.33%. Primary factors affecting Fund performance include the total return of the securities and derivatives held by the Fund, including the performance of the reference assets to which any derivatives are linked, financing rates paid or earned, expenses, transaction costs, the volatility of the Fund's index, and other miscellaneous factors.
