How Did the Fund Perform Last Year?

S&P 500[®] Ex-Energy ETF (the "Fund") seeks investment results, before fees and expenses, that track the performance of the S&P 500[®] Ex-Energy Index (the "Index"). The Fund invests in financial instruments that the Advisor believes, in combination, should track the performance of the Index. Performance was driven by strong performance of the S&P 500[®] and roughly in-line performance of the energy sector. For the year ended May 31, 2024, the Fund had a total return of 28.16%. For the same period, the Index had a total return of 28.31% and a volatility of 11.73%. Primary factors affecting Fund performance include the total return of the securities held by the Fund, expenses, transaction costs, the volatility of the Fund's index, and other miscellaneous factors.
