

#### How Did the Fund Perform Last Year?

S&P 500<sup>®</sup> Ex-Health Care ETF (the "Fund") seeks investment results, before fees and expenses, that track the performance of the S&P 500<sup>®</sup> Ex-Health Care Index (the "Index"). The Fund invests in financial instruments that the Advisor believes, in combination, should track the performance of the Index. Performance was driven by strong performance of the S&P 500<sup>®</sup> and underperformance of the Health Care sector. For the year ended May 31, 2024, the Fund had a total return of 30.19%. For the same period, the Index had a total return of 30.35% and a volatility of 12.22%. Primary factors affecting Fund performance include the total return of the securities held by the Fund, expenses, transaction costs, the volatility of the Fund's index, and other miscellaneous factors.
