
## About the fund

# Index description

The S&P Merger Arbitrage Index follows a true merger arbitrage approach. The index takes long positions in target securities. The index also takes short positions in shares of the acquirer when the deal involves an exchange of the acquirer's stock. The short positions are intended to reduce the effect that declines in the value of the acquirer's stock could have on the spread. The index is composed of up to 40 publicly announced deals within developed market countries through a combination of long and, in certain cases, short security positions. When deals enter the index, the weight in long positions of targets is initiated at three percent (3%) and the initial weight in short positions of acquirers ranges between 0% and 3%, depending on terms of the deal. This limits the sum of initial net exposures to between 0% and 100%, with both the long and short positions having a maximum initial exposure each of 120%. The index also includes a Treasury bill component, which constitutes the remainder of the index when net exposure from included deals is less than 100%. Certain deals are screened out based on liquidity, size, and remaining spread between the deal price and the stock price of the company being acquired. Additions and deletions occur on a rolling basis.

The index is denominated in local currencies.
