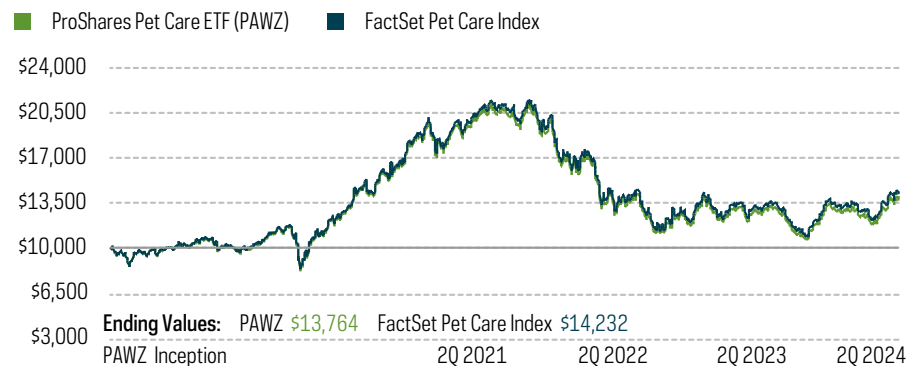
- PAWZ is the first ETF that allows investors to capitalize on people's passion for their pets.
