Pursuant to Ordering Paragraph (OP) 2 of Commission Decision (D.) 12-04-024, Section II.A of Commission Resolution ESRB-8, D.19-05-042, and D.20-05-051, San Diego Gas & Electric Company (SDG&E) submits this report regarding the initiation of Public Safety Power Shutoff (PSPS) protocols that occurred in SDG&E's service area on January 14–16, 2021. While these protocols were initiated, SDG&E did not de-energize customers for safety in this time period. As noted in the PSPS reporting requirements, this report has been verified by an SDG&E officer in accordance with Rule 1.11 of the Commission's Rules of Practice and Procedure.

In accordance with D.19-05-042, this report has been distributed to the service lists for the following Commission rulemaking (R.) proceedings: R.18-10-007 and R.18-12-005.

This report covers the Public Safety Power Shutoff (PSPS) protocols implemented in SDG&E's service territory from January 14 through January 16, 2021. As discussed below, while SDG&E initiated its PSPS protocols, including customer notifications, SDG&E did not de-energize customers for public safety in this time period. SDG&E submits this report to the Director of Safety and Enforcement Division (SED) and the service lists for Rulemaking (R.) 18-12-005 and R.18-10-007. This report includes the information required by Decision (D.) 12-04-024, Section II.A of CPUC Resolution ESRB-8, D.19-05-042, and D.20-05-051.

The analysis and data provided in this report are based on the most current information available at the time and are subject to modification resulting from additional analyses and assessments completed following submission of the report.

- 1. An explanation of SDG&E's decision to de-energize, including an explanation of alternatives considered; mitigation measures used to decrease the risk of utility-caused wildfires in de-energized areas; a thorough and detailed description of the quantitative and qualitative factors SDG&E considered in calling, sustaining or curtailing the PSPS event, including information regarding why PSPS was a last resort option; and the specific conditions SDG&E determined must be present for the de-energization event to be concluded.**

Response:

Explanation of the Decision to De-Energize

The decision to initiate PSPS protocols was made at SDG&E's Emergency Operations Center (EOC), which was staffed in a remote environment by a cross-functional team of electric operations, safety, meteorology, engineering, customer service, external affairs, communications, and other personnel, as well as a designated Utility Incident Commander (UIC) for the event. SDG&E implemented PSPS protocols to provide coordinated response; ensure there was informed decision-making; coordinate as-needed logistic support; and manage notifications to all affected stakeholders, including customers, state agencies, local jurisdictions, tribal governments, elected representatives, and public safety partners.

SDG&E's EOC was activated in a monitoring mode on January 13 at 1530 in response to weather forecasts indicating Santa Ana conditions, including strong winds and low humidity, were possible in portions of SDG&E's service area. Based on advanced forecasts, SDG&E anticipated the most severe winds and critical fire weather in areas of Orange County.

SDG&E weighs many inputs when making the decision to de-energize portions of its system, and leverages refined situational awareness data and input from its subject matter experts when considering the need for PSPS, though experience with the program has indicated it is not appropriate to use a prescriptive technique to determine when to use PSPS, as wildfire conditions are dynamic and not every situation is the same. When making the decision to de-energize, SDG&E considers the following factors:

- Weather conditions: SDG&E's Fire Potential Index (FPI) ratings, Red Flag Warnings (RFW) issued by the National Weather Service (NWS), and the Santa Ana Wildfire Threat Index (SAWTI);

- Vegetation conditions and SDG&E’s Vegetation Risk Index;
- Field observations and flying/falling debris;
- Information from first responders;
- Meteorological data, including 10-years of historical information from weather stations and 99th and 95th percentile winds;
- Expected duration of conditions;
- Location of any existing fires;
- Wildfire activity in other parts of the state affecting resource availability;
- Information on temporary construction.

SDG&E has not developed a specific PSPS algorithm that lists, quantifies, and calculates the weight of each factor that is incorporated into a PSPS. SDG&E has developed and published information regarding the factors and weights that go into the determination of the fire environment severity which is included in the FPI and SAWTI sections of SDG&E’s 2020 Wildfire Mitigation Plan (WMP).¹

In addition to local weather conditions, SDG&E closely monitored and considered wildfire activity throughout the region and the availability of fire suppression resources to the area. After monitoring and considering weather conditions, de-energizations for public safety were not implemented during this event. The central considerations in determining if PSPS were warranted are detailed below.

Weather Forecasts and Conditions

Summary: The NWS issued a RFW for Inland Orange County (Zone 554) effective January 14 at 1600 until January 16 at 1600 for widespread gusty winds accompanied by hot and dry conditions.

Weather Forecasts: SDG&E weather models showed the potential for a weak to locally moderate Santa Ana wind event, with gusty winds localized to mountain ridges in the backcountry areas. Wind-prone locations were projected to see isolated wind gusts over 45 mph. The NWS was forecasting peak wind gusts of 45–50 mph, with relative humidity values dropping to 8–12%.

Weather Conditions: Sixteen high temperature records were broken in the Southwestern California area during this event, and humidity levels dropped into the teens and single digits. The maximum wind gust recorded on SDG&E weather stations was 82 mph at Sill Hill, with six stations reaching or exceeding 60 mph, nine reaching or exceeding 56 mph, and 21 stations reaching or exceeding 45 mph. 19 SDG&E weather stations met or exceeded their 99th percentile wind gust, and 73 met or exceeded their 95th percentile wind gust.

Local Fire Conditions and Fire Potential: Areas forecast to be the windiest still had patchy snow cover from the last storm, as well as damp and muddy soil conditions. This

created less of a fire concern, as it would take longer for the light flashy fuels to dry out than in the areas forecast to receive much lighter winds. With hot and dry weather conditions in place, the service territory was under a low-end Elevated FPI of 12.

Local, State, and federal suppression resource levels were monitored and appeared to be adequately staffed throughout the weather event.

Alternatives Considered

In the days leading up to potential PSPS events, including the events described in this report, SDG&E meteorologists closely monitor weather forecasts to identify the specific areas most likely to experience weather conditions that warrant PPS. Operational groups use these targeted forecasts to strategically stage field crews and observers in areas anticipated to experience the most severe weather.

Once fire weather conditions materialize, stations in SDG&E's weather network provide reading of conditions including wind speeds, temperatures, and relative humidity every 30 seconds. This data is monitored in real time by staff at SDG&E's EOC and used to determine if PPS should be implemented. This close monitoring and frequent updating of location-specific data enables SDG&E to implement PPS only as a last resort when conditions warrant de-energization.

After monitoring and considering weather conditions, de-energizations for public safety were not implemented during this event.

Mitigation Measures to Decrease Utility-Caused Fire Risk in De-Energized Areas

Not applicable as no areas were de-energized during this event.

Conditions to Conclude the PPS Event

Similar to the decision to initiate PPS protocols, the decision to conclude a PPS event is based on a number of factors.

During this event, SDG&E Meteorologists utilized real time weather station data and forecast models to determine critical fire weather conditions had peaked and were trending weaker, without any indication of potential resurgence of conditions that could necessitate PPS.

Based on favorable weather conditions and expiration of the Red Flag Warning, SDG&E's UIC approved conclusion of the PPS event and demobilization of SDG&E's EOC.

- 2. All factors considered by SDG&E in its decision to de-energize, including wind speed, temperature, humidity, and vegetation moisture in the vicinity of the de-energized circuits.**

Response:

The decision to implement PSPS is not based on a single factor; numerous criteria are considered when making this decision.

During the January 14–16 event, key bases for determining if PSPS were necessary included, but were not limited to:

- The FPI was rated Elevated for all inland districts and Orange County on January 14 and for all districts in SDG&E’s service area January 15–16;
- Weather forecasts indicated the potential for Santa Ana winds with isolated gusts over 45 mph, along with abnormally hot temperatures and very dry conditions;
- The SAWTI was rated Moderate for January 14–16, indicating that upon ignition, fires will grow rapidly and will be difficult to control;
- Official NWS forecasts mentioned the potential for wind gusts of 45–50 mph, with stronger localized gusts in the most wind-prone locations;
- A Red Flag Warning was issued for portions of Orange County from January 14 at 1600 through January 16 at 1600;
- Wind climatology of each circuit or circuit segment to include the 95th and 99th percentile winds from nearly 10 years of collecting weather data every 10 minutes from every station.

Not applicable; no customers were impacted by de-energizations during this event.

Response:

SDG&E did not utilize sectionalization to mitigate customer impacts during this event, as no de-energizations for public safety were initiated.

SDG&E used sectionalizing devices to send warning messages and notifications of potential PSPS impacts to specific, more precise customer groups.

Response:

Starting on January 13, SDG&E notified customers in areas that would potentially be impacted by PSPS on January 14. Notifications were made via outbound dialer, email, text message, and personal phone calls. Helpful information was also shared on SDG&E's websites (SDGE.com and SDGEnews.com), SDG&E Alerts app, SDG&E's social media channels (Twitter, Facebook, Instagram, Nextdoor) and with local, state, and national news media outlets.

On January 13, SDG&E provided verbal notice of the potential PSPS event to the Office of the Governor of California and staff for Senator Toni Atkins. No additional communications to elected officials were made during this event, as conditions warranting implementation of PSPS did not materialize and no customers were de-energized.

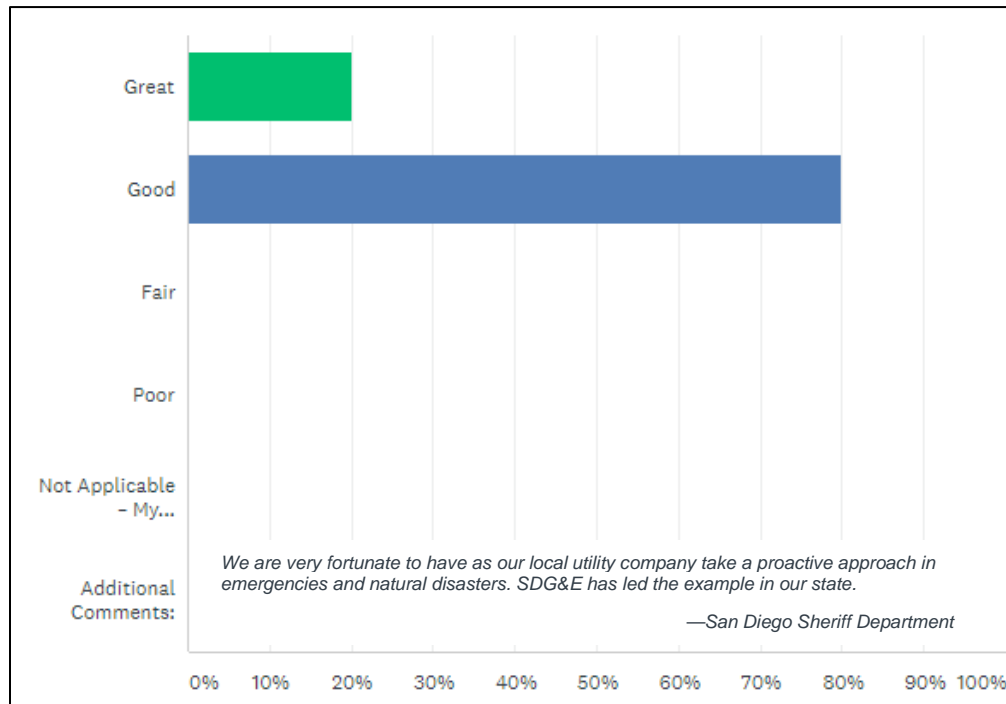
SDG&E worked extensively with state and regional partners throughout this event, including extensive and multiple daily briefings with representatives from CalOES, CPUC, CalOES Tribal Affairs, County OES and 2-1-1. Additionally, SDG&E partnered with San Diego County OES, AFN Working Group, 2-1-1 San Diego, 2-1-1 Orange County, and community-based organizations (CBOs) to amplify key messaging through their databases and social media channels, and to translate PSPS notification into other languages.

The following is a description of specific engagement during the January 14–16 event:

Throughout the event, SDG&E remained engaged with its local and state public safety partners by providing advanced notification to all appropriate partners and monitoring its communication channels throughout the duration of the event.

Immediately following the PSPS event, SDG&E distributed a one question online survey to public safety partners requesting they rate SDG&E’s level of engagement with their organization before and during the January 14–16 event. 

Based on updated forecasts, fire weather conditions are now expected to potentially continue through the late evening on Saturday, January 16. The RFW issued by the NWS for Orange County will go into effect at 1600 today, and will remain in place through 1600 Friday, January 15. An additional RFW may be issued for Saturday afternoon and evening that could include portions of San Diego County.
