Attached is a spreadsheet showing total trades done for each account in December 2004. Basically, it shows that on 12/13/04 all of the accounts purchased baskets totaling \$2,143,751,216 and on 12/16/04 total sales totaled \$2,171,068,276. This resulted in a total profit of approximately \$27,317,059. For one customer, a negative number appears in the profit column. I believe this is a mistake with the conversion of data they gave us. On Thursday as I was walking out, they gave us a disk of text files (.txt) that contained the 15 months of customer statements. The data does not appear as a customer statement and I \Box m going to ask the firm to provide it in a usable format. I \Box we had to try to import the data into Access with only limited success.
