Mr. McGinnis updates the Court on the status of the case and the issues in the Stipulation.

Ms. Parks comments on the issues in the Stipulation and stated that ADWR does not oppose the utilization of the Reference ET-Crop Coefficient Method and the Penman-Montieth Equation to quantify reference crop evapotranspiration.

Mr. McGinnis further comments on the remaining issues of crop mix and irrigation efficiency.

Mr. Brown concurs with Mr. McGinnis and adds further comments regarding agreement on crop mix and efficiencies.

Mr. Burnside, Mr. Sparks, Mr. Billingsley, Ms. Brennan, Mr. Cahoy, Mr. Leininger, Mr. Hood, Mr. Murphy, Ms. Kintz, Ms. Montgomery, and Mr. Weiner have no further comments.

Mr. McGinnis proposes to extend the discovery and dispositive motion deadlines.

Mr. Brown addresses the points of diversion issue and agrees to the extension of the discovery and dispositive motion deadlines.
