AND SETTING A STATUS CONFERENCE

4 IT IS ORDERED vacating the Status Conference set for December 11, 2019.


5 IT IS FURTHER ORDERED that the parties shall either:

7 (1) File a Stipulation, Withdrawal of Objections, and Request for Approval of  
8 Proposed Water Right Abstracts (Stipulation) by January 28, 2020; or  
9 (2) File a joint Status Report.

10 IT IS FURTHER ORDERED that if a Stipulation is filed, Arizona Department of Water  
11 Resources will file a Report by February 18, 2020 if the proposed abstracts contains information  
12 about the source of water for the proposed water right that is not consistent with its records.

13 IT IS FURTHER ORDERED that if a Stipulation is not filed by January 28, 2020, the  
14 parties shall participate in a Status Conference. The Status Conference shall be held on **February**  
15 **4, 2020** at 1:30 p.m. in the Superior Court of Arizona, 201 West Jefferson Street, Courtroom 301,  
16 Phoenix, Arizona 85003-2202.
